AN ACT

Amending the act of June 1, 1956 (1955 P.L.1959, No.657), entitled, as amended, "An act fixing the salaries and 2 3 compensation of the Chief Justice and judges of the Supreme Court, the President Judge and judges of the Superior Court, 5 the judges of the courts of common pleas, the judges of the orphans' courts, the judges of the County Court of 7 Philadelphia and the judges of the County Court and Juvenile Court of Allegheny County, certain associate judges not 8 learned in the law, certain state officers, and the salary 9 10 and expenses of the members of the General Assembly, and repealing certain inconsistent acts," further providing for 11 the annual salary of the President Judge of the Philadelphia 12 Traffic Court AND DISTRICT JUSTICES; AND MAKING A REPEAL. 13 14 The General Assembly of the Commonwealth of Pennsylvania 15 hereby enacts as follows: 16 Section 1. Section 4.2 of the act of June 1, 1956 (1955 P.L.1959, No.657), referred to as the Public Official Compensation Law, amended October 25, 1979 (P.L.235, No.75), is 18 19 amended to read: 20 Section 4.2. (a) The annual salary of the President Judge 21 of the Philadelphia Traffic Court shall be [twenty-six thousand

dollars (\$26,000)] forty-two thousand five hundred dollars

- 1 (\$42,500). The annual salary of associate judges of the
- 2 Philadelphia Traffic Court shall be [twenty-five thousand
- 3 dollars (\$25,000)] thirty-seven thousand five hundred dollars
- $4 \quad (\$37,500).$
- 5 (b) As of July 1, 1984, the annual salary of the President
- 6 Judge of the Philadelphia Traffic Court shall be forty-five
- 7 thousand dollars (\$45,000) and the annual salary of the
- 8 <u>associate judges of the Philadelphia Traffic Court shall be</u>
- 9 forty thousand dollars (\$40,000).
- 10 (C) AS OF THE EFFECTIVE DATE OF THIS SUBSECTION, THE ANNUAL <-
- 11 SALARY OF DISTRICT JUSTICES SHALL BE THIRTY-TWO THOUSAND FIVE
- 12 <u>HUNDRED DOLLARS (\$32,500)</u>.
- 13 SECTION 2. SECTION 206(A) OF THE ACT OF JULY 15, 1976
- 14 (P.L.1014, NO.204), KNOWN AS THE MAGISTERIAL DISTRICT REFORM
- 15 ACT, IS REPEALED.
- 16 Section 2 3. This act shall take effect July 1, 1983.
