AN ACT

1 Amending Title 75 (Vehicles) of the Pennsylvania Consolidated  
2 Statutes, providing for issuance of detachable anatomical  
3 donor symbols on drivers' licenses; AND FURTHER PROVIDING FOR <—  
4 SPECIAL PERMITS.

5 The General Assembly of the Commonwealth of Pennsylvania  
6 hereby enacts as follows:

10 § 1510. Issuance and content of driver's license.

11 (a) General rule.--The department shall, upon payment of the  
12 required fee, issue to every qualified applicant a driver's  
13 license indicating the type or general class of vehicles the  
14 licensee is authorized to drive, which license shall contain the  
15 social security number of the licensee, the actual name, date of  
16 birth, residence address, a color photograph of the licensee, a  
17 ~~detachable symbol signifying the organ or organs to be donated~~ <—

1 ~~as determined by the Department of Health and which designates a~~  
2 ~~person to be an anatomical donor when applicable, DETACHABLE~~ ←  
3 SYMBOL PROVIDED BY THE DEPARTMENT OF HEALTH DESIGNATING A PERSON  
4 TO BE AN ANATOMICAL DONOR AND SIGNIFYING THE ORGAN OR ORGANS TO  
5 BE DONATED WHEN APPLICABLE, such other information as may be  
6 required by the department, and either a facsimile of the  
7 signature of the licensee or a space upon which the licensee  
8 shall write his usual signature with pen and ink. Personal  
9 medical data and other information for use in an emergency may  
10 be included as a part of the license. Information other than  
11 that required to identify the licensee, the distinguishing  
12 number and the class of license issued may be included in  
13 microdata form. No driver's license shall be valid until it has  
14 been signed by the licensee.

16 § 4961. AUTHORITY TO ISSUE PERMITS. ←

17 (A) GENERAL RULE.--THE DEPARTMENT AND LOCAL AUTHORITIES WITH  
18 RESPECT TO HIGHWAYS UNDER THEIR RESPECTIVE JURISDICTIONS MAY,  
19 UPON APPLICATION IN WRITING SHOWING GOOD CAUSE, ISSUE SPECIAL  
20 PERMITS IN WRITING AUTHORIZING THE APPLICANT TO OPERATE OR MOVE  
21 ON SPECIFIED HIGHWAYS ANY OF THE FOLLOWING:

22 (1) A VEHICLE WHICH WHEN UNLOADED EXCEEDS THE MAXIMUM  
23 SIZE SPECIFIED IN SUBCHAPTER B (RELATING TO WIDTH, HEIGHT AND  
24 LENGTH) OR THE MAXIMUM WEIGHTS SPECIFIED IN SUBCHAPTER C  
25 (RELATING TO MAXIMUM WEIGHTS OF VEHICLES).

26 (2) A COMBINATION CARRYING A NONDIVISIBLE LOAD AND  
27 EXCEEDING THE MAXIMUM SIZE SPECIFIED IN SUBCHAPTER B OR THE  
28 MAXIMUM WEIGHTS SPECIFIED IN SUBCHAPTER C.

29 (3) A VEHICLE CONTAINING A NONDIVISIBLE LOAD WHICH  
30 EXCEEDS THE MAXIMUM WIDTH SPECIFIED IN SECTION 4921(A)

1 (RELATING TO WIDTH OF VEHICLES) OR THE MAXIMUM HEIGHT  
2 SPECIFIED IN SECTION 4922 (RELATING TO HEIGHT OF VEHICLES).

3 (4) A MOBILE HOME.

4 (5) A MODULAR HOUSING UNIT WHICH EXCEEDS THE MAXIMUM  
5 SIZE PRESCRIBED IN THIS TITLE.

6 (6) A MODULAR HOUSING UNIT UNDERCARRIAGE WHICH EXCEEDS  
7 THE MAXIMUM SIZE PRESCRIBED IN THIS TITLE.
