AS AMENDED ON THIRD CONSIDERATION, IN SENATE, JUNE 26, 1985

AN ACT

1 Amending the act of April 9, 1929 (P.L.177, No.175), entitled
2 "An act providing for and reorganizing the conduct of the
3 executive and administrative work of the Commonwealth by the
4 Executive Department thereof and the administrative
5 departments, boards, commissions, and officers thereof,
6 including the boards of trustees of State Normal Schools, or
7 Teachers Colleges; abolishing, creating, reorganizing or
8 authorizing the reorganization of certain administrative
9 departments, boards, and commissions; defining the powers and
10 duties of the Governor and other executive and administrative
11 officers, and of the several administrative departments,
12 boards, commissions, and officers; fixing the salaries of the
13 Governor, Lieutenant Governor, and certain other executive
14 and administrative officers; providing for the appointment of
15 certain administrative officers, and of all deputies and
16 other assistants and employes in certain departments, boards,
17 and commissions; and prescribing the manner in which the
18 number and compensation of the deputies and all other
19 assistants and employes of certain departments, boards and
20 commissions shall be determined," further providing for
21 appointments to the Energy Development Authority; AND <—
22 PROVIDING FOR THE TRANSFER OF CONNELLSVILLE STATE GENERAL
23 HOSPITAL.

24 The General Assembly of the Commonwealth of Pennsylvania
25 hereby enacts as follows:

26 SECTION 1. AS MUCH OF SECTION 202 AS RELATES TO THE BOARD OF <—
27 TRUSTEES OF CONNELLSVILLE STATE GENERAL HOSPITAL IN THE

1 DEPARTMENT OF PUBLIC WELFARE OF THE ACT OF APRIL 9, 1929
2 (P.L.177, NO.175), KNOWN AS THE ADMINISTRATIVE CODE OF 1929, IS
3 REPEALED.

4 SECTION 2. SECTION 401 OF THE ACT, AMENDED FEBRUARY 17, 1984
5 (P.L.75, NO.14), IS AMENDED TO READ:

6 SECTION 401. BOARDS OF TRUSTEES OF STATE INSTITUTIONS.--THE
7 BOARDS OF TRUSTEES OF EACH OF THE STATE INSTITUTIONS HEREINAFTER
8 MENTIONED SHALL CONSIST OF NINE MEMBERS, AND THE HEAD OF THE
9 DEPARTMENT HAVING SUPERVISION OVER THE INSTITUTION EX OFFICIO.

10 THE TERMS OF EACH MEMBER OF EACH SUCH BOARD SHALL BE SIX
11 YEARS, AND UNTIL HIS SUCCESSOR IS APPOINTED AND QUALIFIED.

12 THE TERMS OF THE FIRST THREE MEMBERS OF ALL BOARDS, THE
13 MEMBERS OF WHICH NOW SERVE FOR TERMS OF FOUR YEARS, APPOINTED BY
14 THE GOVERNOR ON OR AFTER THE THIRD TUESDAY OF JANUARY, 1959,
15 SHALL EXPIRE ON THE THIRD TUESDAY OF JANUARY, 1961. THE TERMS OF
16 THE NEXT THREE MEMBERS APPOINTED SHALL EXPIRE ON THE THIRD
17 TUESDAY OF JANUARY, 1963. THE TERMS OF THE NEXT THREE MEMBERS
18 APPOINTED SHALL EXPIRE ON THE THIRD TUESDAY OF JANUARY, 1965.
19 THEIR SUCCESSORS AND ALL MEMBERS OF ALL BOARDS, APPOINTED TO
20 SUCCEED MEMBERS WHO HAVE SERVED SIX YEAR TERMS, SHALL BE
21 APPOINTED FOR TERMS OF SIX YEARS FROM THE DATE OF THE EXPIRATION
22 OF THE PRECEDING TERM. VACANCIES HAPPENING BEFORE THE EXPIRATION
23 OF A TERM SHALL BE FILLED FOR THE UNEXPIRED TERM.

24 FIVE MEMBERS OF ANY SUCH BOARD SHALL CONSTITUTE A QUORUM.

25 EACH SUCH BOARD SHALL ANNUALLY ELECT A PRESIDENT AND VICE-
26 PRESIDENT FROM AMONG ITS MEMBERS, AND A SECRETARY AND TREASURER
27 WHO NEED NOT BE MEMBERS OF THE BOARD. THE SECRETARY AND
28 TREASURER MAY BE THE SAME PERSON.

21 Section 4 3. Section 2803-C(b) of the act, ~~of April 9, 1929~~ <—
22 ~~(P.L.177, No.175), known as The Administrative Code of 1929,~~
23 added December 14, 1982 (P.L.1213, No.280), is amended to read:

24 Section 2803-C. Energy Development Authority.--* * *

25 (b) The authority shall be governed and all of its corporate
26 powers exercised by a board of directors which shall be composed
27 of the following individuals:

28 (1) Nine members to be appointed by the Governor, one of
29 whom shall be designated as chairman. At least two members shall
30 be members of the general public. The members initially

1 appointed shall serve for terms of two, three and four years,
2 respectively, the particular term of each to be designated by
3 the Governor at the time of appointment. The terms of all of
4 their successors shall be four years each, except that any
5 person appointed to fill a vacancy shall serve only for the
6 unexpired term. Every member's term shall extend until his
7 successor is appointed and qualified. Any appointment of a
8 member of the authority shall be subject to the advice and
9 consent of a majority of all of the members of the Senate. Any
10 appointed member of the authority shall be eligible for
11 reappointment.

12 (2) The Secretary of Environmental Resources or his
13 designee.

14 (3) The Secretary of Banking or his designee.

15 (4) The Secretary of Commerce or his designee.

16 (5) The Secretary of Agriculture or his designee.

17 (6) Two members of the Senate, one from the majority party
18 and one from the minority party, to be appointed by the
19 President pro tempore to serve at his pleasure, or the designees
20 appointed by such members.

21 (7) Two members of the House of Representatives, one from
22 the majority party and one from the minority party, to be
23 appointed by the Speaker of the House to serve at his pleasure,
24 or the designees appointed by such members.

25 (8) The Consumer Advocate or his designee.

26 (9) The Chairman of the Public Utility Commission or his
27 designee.

28 * * *

29 ~~Section 2. This act shall take effect in 60 days.~~

30 SECTION 4. CONVEYANCE OF REAL PROPERTY.

1 THE DEPARTMENT OF GENERAL SERVICES, THE BOARD OF TRUSTEES OF
2 CONNELLSVILLE STATE GENERAL HOSPITAL AND THE GENERAL STATE
3 AUTHORITY, WITH THE APPROVAL OF THE GOVERNOR AND THE DEPARTMENT
4 OF PUBLIC WELFARE, ARE HEREBY AUTHORIZED AND DIRECTED ON BEHALF
5 OF THE COMMONWEALTH OF PENNSYLVANIA TO GRANT AND CONVEY TO
6 CONNELLSVILLE HOSPITAL, A NONPROFIT, NONSTOCK CORPORATION
7 ORGANIZED AND OPERATING IN THIS COMMONWEALTH, THE FOLLOWING
8 TRACTS OF LAND, TOGETHER WITH ANY AND ALL BUILDINGS AND
9 IMPROVEMENTS NOW OR HEREAFTER ERECTED ON OR AT THE PROPERTY
10 DESCRIBED IN THIS ACT, INCLUDING, WITHOUT LIMITATION, THE
11 FIXTURES, ATTACHMENTS, APPLIANCES, EQUIPMENT MACHINERY AND OTHER
12 ARTICLES OWNED BY THE COMMONWEALTH ATTACHED TO SUCH BUILDINGS
13 AND IMPROVEMENTS, SITUATE IN THE CITY OF CONNELLSVILLE, FAYETTE
14 COUNTY, PENNSYLVANIA, BOUNDED AND DESCRIBED AS FOLLOWS:

15 SECTION 5. ADDITIONAL ITEMS OF CONVEYANCE.

16 THE DEED OF CONVEYANCE SHALL CONVEY ANY AND ALL TENEMENTS,
17 HEREDITAMENTS, AND APPURTENANCES BELONGING TO THE PROPERTY,
18 BUILDINGS AND IMPROVEMENTS DESCRIBED IN THIS ACT OR IN ANY WAY
19 PERTAINING THERETO, AND ALL STREETS, ALLEYS, PASSAGES, WAYS,
20 WATER COURSES, WATER RIGHTS, AND ALL LEASEHOLD ESTATES,
21 EASEMENTS, AND COVENANTS NOW EXISTING OR HEREAFTER CREATED FOR
22 THE BENEFIT OF THE OWNER OR TENANT OF THE PROPERTY DESCRIBED IN
23 THIS ACT AND ALL RIGHTS TO ENFORCE THE MAINTENANCE OF SUCH
24 PROPERTY, AND ALL OTHER RIGHTS, LIBERTIES, AND PRIVILEGES OF
25 WHATSOEVER KIND OR CHARACTER, AND ALL THE ESTATE, RIGHT, TITLE,
26 INTEREST, PROPERTY, POSSESSION, CLAIM AND DEMAND WHATSOEVER, AT
27 LAW OR IN EQUITY, OF THE COMMONWEALTH IN AND TO THE PROPERTY,
28 BUILDINGS AND IMPROVEMENTS DESCRIBED IN THIS ACT.

29 SECTION 6. LEGAL SURVEY.

30 CONNELLSVILLE HOSPITAL SHALL, AT ITS OWN COST AND EXPENSE,

1 PERFORM A LEGAL SURVEY OF ALL THE PROPERTIES AUTHORIZED TO BE
2 CONVEYED BY THIS ACT. THE LEGAL DESCRIPTION RESULTING FROM THE
3 LEGAL SURVEY SHALL BE PLACED IN THE DEED OR DEEDS OF CONVEYANCE
4 AUTHORIZED BY THIS ACT.

5 SECTION 7. RENTAL CHARGES.

6 THE GENERAL ASSEMBLY HAS APPROPRIATED FUNDS FOR PAYMENT OF
7 RENTAL CHARGES ON BEHALF OF CONNELLSVILLE STATE GENERAL HOSPITAL
8 TO THE GENERAL STATE AUTHORITY TO RELEASE SUCH PROPERTY FROM
9 ALL LIENS AND ENCUMBRANCES IN FAVOR OF THE GENERAL STATE
10 AUTHORITY IN ORDER TO COMPLETE THE TRANSFER OF CONNELLSVILLE
11 STATE GENERAL HOSPITAL TO PRIVATE OWNERSHIP.

12 SECTION 8. TRANSFER OF PERSONAL PROPERTY.

13 THE DEPARTMENT OF GENERAL SERVICES, THE BOARD OF TRUSTEES OF
14 CONNELLSVILLE STATE GENERAL HOSPITAL AND THE GENERAL STATE
15 AUTHORITY, WITH THE APPROVAL OF THE GOVERNOR AND THE DEPARTMENT
16 OF PUBLIC WELFARE, ARE HEREBY AUTHORIZED AND DIRECTED ON BEHALF
17 OF THE COMMONWEALTH OF PENNSYLVANIA TO GRANT AND CONVEY TO
18 CONNELLSVILLE HOSPITAL, A NONPROFIT, NONSTOCK CORPORATION
19 ORGANIZED AND OPERATING IN THIS COMMONWEALTH, ALL RIGHT, TITLE
20 AND INTEREST OF THE COMMONWEALTH IN AND TO ALL TANGIBLE AND
21 INTANGIBLE PERSONAL PROPERTY OF ANY NATURE WHATSOEVER OWNED BY
22 THE COMMONWEALTH, INCLUDING, BUT NOT LIMITED TO, FURNISHINGS,
23 EQUIPMENT, INVENTORIES, BUSINESS RECORDS AND PATIENT RECORDS,
24 ATTACHED TO, OR LOCATED IN, ON OR AT THE PROPERTY, BUILDINGS AND
25 IMPROVEMENTS DESCRIBED IN SECTION 4, WHETHER OR NOT THE PERSONAL
26 PROPERTY IS OR SHALL BE AFFIXED TO ANY SUCH PROPERTY, BUILDINGS
27 OR IMPROVEMENTS.

28 SECTION 9. EXEMPTION FROM TAXES, FEES AND COSTS.

29 THE CONVEYANCES AUTHORIZED UNDER THIS ACT SHALL BE EXEMPT
30 FROM TAXES, IMPOSTS OR OTHER FEES AND COSTS TO THE EXTENT THAT

1 SUCH TAXES, IMPOSTS, FEES AND COSTS ARE IMPOSED BY ANY TAXING
2 AUTHORITY.

3 SECTION 10. RESTRICTIONS OF RECORD.

4 THE CONVEYANCES DESCRIBED IN THIS ACT SHALL BE MADE UNDER AND
5 SUBJECT TO ALL EASEMENTS, SERVITUDES AND RIGHTS OF OTHERS,
6 INCLUDING, BUT NOT CONFINED TO, STREETS, ROADWAYS AND RIGHTS OF
7 ANY TELEPHONE, TELEGRAPH, WATER, ELECTRIC, SEWER, GAS OR
8 PIPELINE COMPANIES AS WELL AS UNDER AND SUBJECT TO INTEREST,
9 ESTATES OR TENANCIES VESTED IN THIRD PERSONS, WHETHER OR NOT
10 APPEARING OF RECORD, FOR ANY PORTION OF THE LAND OR IMPROVEMENTS
11 ERECTED THEREON.

12 SECTION 11. APPROVAL AND EXECUTION OF DEEDS.

13 THE DEEDS OF CONVEYANCE OF THE PROPERTY DESCRIBED IN THIS ACT
14 SHALL BE APPROVED AS PROVIDED BY LAW AND SHALL BE EXECUTED BY
15 THE PRESIDENT AND ASSISTANT SECRETARY OF THE GENERAL STATE
16 AUTHORITY AND BY THE SECRETARY OF GENERAL SERVICES IN THE NAME
17 OF THE COMMONWEALTH OF PENNSYLVANIA, AND SHALL BE EXECUTED BY A
18 DULY AUTHORIZED AGENT OF THE BOARD OF TRUSTEES OF CONNELLSVILLE
19 STATE GENERAL HOSPITAL, WHO IS HEREBY AUTHORIZED AND DIRECTED TO
20 JOIN IN SUCH DEEDS FOR THE PURPOSE OF TRANSFERRING SUCH
21 REMAINING INTEREST IN THE PROPERTIES DESCRIBED IN THIS ACT AND
22 SHALL BE VESTED AS OF THE TIME OF EXECUTION OF SUCH DEEDS IN THE
23 REMAINING MEMBERS OF THE BOARD OF TRUSTEES OF CONNELLSVILLE
24 STATE GENERAL HOSPITAL.

25 SECTION 12. COSTS AND FEES.

26 COSTS AND FEES INCIDENTAL TO CONVEYANCES AUTHORIZED IN THIS
27 ACT SHALL BE BORNE BY THE GRANTEE.

28 SECTION 13. TRANSFER OF CONTROL.

29 AS OF THE DATE OF THE CONVEYANCES OF PROPERTY AUTHORIZED BY
30 THIS ACT, MANAGEMENT AND LEGAL CONTROL OF THE AFFAIRS OF

1 CONNELLSVILLE STATE GENERAL HOSPITAL, INCLUDING, WITHOUT
2 LIMITATION, SERVICES, ADMINISTRATION, PERSONNEL AND OTHER
3 FUNCTIONS, SHALL BE TRANSFERRED AND VESTED IN CONNELLSVILLE
4 HOSPITAL, A NONPROFIT, NONSTOCK CORPORATION, WHICH MAY EXERCISE
5 BY LAW WITH RESPECT TO CONNELLSVILLE STATE GENERAL HOSPITAL ALL
6 OF THE POWERS, RIGHTS AND FRANCHISES VESTED BY LAW IN NONPROFIT,
7 NONSTOCK CORPORATIONS UNDER THE LAWS OF THIS COMMONWEALTH.

8 SECTION 14. GIFTS OR DONATIONS.

9 ANY GIFT, GRANT OR DONATION OF ANY KIND WHATSOEVER, OR ANY
10 BEQUEST, DEVISE, GIFT OR GRANT CONTAINED IN ANY WILL OR OTHER
11 INSTRUMENT, IN TRUST OR OTHERWISE, MADE TO OR FOR THE BENEFIT OF
12 CONNELLSVILLE STATE GENERAL HOSPITAL BEFORE OR AFTER THE
13 CONVEYANCES AUTHORIZED BY THIS ACT SHALL INURE TO THE BENEFIT OF
14 CONNELLSVILLE HOSPITAL AND MAY BE USED BY CONNELLSVILLE HOSPITAL
15 FOR ANY PURPOSES THAT SHALL BE CONSISTENT WITH ANY CONDITIONS,
16 RESTRICTIONS OR LIMITATIONS IMPOSED BY THE MAKER OF SUCH GIFT,
17 GRANT, DONATION, BEQUEST OR DEVISE.

18 SECTION 15. REVERSION TO COMMONWEALTH.

19 THE DEEDS OF CONVEYANCE AUTHORIZED BY THIS ACT SHALL CONTAIN
20 CLAUSES THAT THE CONVEYANCE OF PROPERTIES SHALL BE EXPRESSLY
21 CONDITIONED UPON COMPLIANCE BY CONNELLSVILLE HOSPITAL WITH TERMS
22 AND CONDITIONS AS FOLLOWS, AND THAT IF, AT ANY TIME,
23 CONNELLSVILLE HOSPITAL, OR ITS SUCCESSOR FAILS TO COMPLY WITH
24 ANY OF THE CONDITIONS SPECIFIED IN THIS SECTION, THE TITLE TO
25 SUCH PROPERTY SHALL IMMEDIATELY REVERT TO AND REVEST IN THE
26 COMMONWEALTH OF PENNSYLVANIA:

27 (1) CONNELLSVILLE HOSPITAL SHALL PROVIDE UNCOMPENSATED
28 CARE, INCLUDING INDIGENT CARE, IN REASONABLE AMOUNTS TO
29 PERSONS UNABLE TO PAY THE COST THEREOF, AND TO THE EXTENT
30 FINANCIALLY FEASIBLE FOR CONNELLSVILLE HOSPITAL.

1 (2) IN THE EVENT THAT UNFORESEEN EVENTS REQUIRE THAT THE
2 HOSPITAL PRESENTLY OPERATED AS CONNELLSVILLE STATE GENERAL
3 HOSPITAL BE CLOSED BY CONNELLSVILLE HOSPITAL, CONNELLSVILLE
4 HOSPITAL SHALL PROVIDE NOT LESS THAN 90 DAYS' NOTICE PRIOR TO
5 THE PROPOSED DATE OF CLOSING OF THE HOSPITAL TO THE
6 DEPARTMENT OF PUBLIC WELFARE AND SHALL MAKE GOOD FAITH
7 EFFORTS TO OBTAIN A SUCCESSOR OPERATOR FOR THE HOSPITAL.

8 (3) IN THE EVENT OF A SALE OR OTHER DISPOSITION OF ALL
9 OR SUBSTANTIALLY ALL THE PROPERTIES DESCRIBED IN THIS ACT AT
10 ANY TIME WITHIN THREE (3) YEARS OF THE DATE OF THE
11 CONVEYANCES AUTHORIZED BY THIS ACT FOR AN AMOUNT EQUALING OR
12 EXCEEDING FAIR MARKET VALUE AS DETERMINED BY ONE OR MORE
13 PERSONS EXPERT IN ASSESSING THE VALUE OF HEALTH CARE
14 INSTITUTIONS, SUCH PERSON OR PERSONS TO BE MUTUALLY AGREED TO
15 BY THE DEPARTMENT OF PUBLIC WELFARE AND CONNELLSVILLE
16 HOSPITAL, THE PROCEEDS OF SUCH DISPOSITION AFTER PROVIDING
17 FOR ALL DEBTS, LIABILITIES, AND OBLIGATIONS OF CONNELLSVILLE
18 HOSPITAL SHALL BE PAID IN PROPORTIONAL AMOUNTS TO THE
19 COMMONWEALTH AND TO CONNELLSVILLE HOSPITAL UNTIL THE TOTAL
20 AMOUNT OF SUCH PROCEEDS PAID TO THE COMMONWEALTH EQUALS
21 \$4,600,000 AND ONLY TO THE EXTENT THAT SUCH PROCEEDS ARE NOT
22 REINVESTED IN OR EXPENDED FOR FACILITIES OR PROGRAMS
23 PROVIDING SERVICES TO RESIDENTS OF CONNELLSVILLE AND
24 SURROUNDING COMMUNITIES SERVED BY CONNELLSVILLE STATE GENERAL
25 HOSPITAL. THE PROPORTION OF SUCH PROCEEDS TO BE PAID TO THE
26 COMMONWEALTH AND CONNELLSVILLE HOSPITAL RESPECTIVELY SHALL BE
27 DETERMINED AS OF THE DATE OF SALE BY THE TOTAL AMOUNT OF
28 CAPITAL PREVIOUSLY CONTRIBUTED TO CONNELLSVILLE HOSPITAL BY
29 THE COMMONWEALTH AND BY CONNELLSVILLE HOSPITAL RESPECTIVELY.
30 THE TOTAL AMOUNT OF CAPITAL SHALL BE DETERMINED BY ADDING

1 TOGETHER \$4,600,000 AND ALL CAPITAL EXPENDED BY OR ON BEHALF
2 OF CONNELLSVILLE HOSPITAL BY CONNELLSVILLE HOSPITAL OR
3 ENTITIES RELATED BY COMMON OWNERSHIP OR CONTROL TO
4 CONNELLSVILLE HOSPITAL, INCLUDING WITHOUT LIMITATION,
5 EXPENDITURES FOR PROPERTY, BUILDINGS, IMPROVEMENTS,
6 EQUIPMENT, AND CONTRIBUTIONS OF PROPERTY, BUILDINGS,
7 IMPROVEMENTS OR EQUIPMENT. THE RELATIVE PERCENTAGE OF SUCH
8 PROCEEDS TO BE PAID TO THE COMMONWEALTH SHALL EQUAL
9 \$4,600,000 DIVIDED BY SUCH TOTAL CAPITAL. THE RELATIVE
10 PERCENTAGE OF SUCH PROCEEDS TO BE PAID TO CONNELLSVILLE
11 HOSPITAL SHALL EQUAL THE TOTAL CAPITAL CONTRIBUTED BY
12 CONNELLSVILLE HOSPITAL DIVIDED BY SUCH TOTAL CAPITAL. ALL NET
13 PROCEEDS SHALL BE PAID EXCLUSIVELY TO CONNELLSVILLE HOSPITAL
14 AFTER THE TOTAL AMOUNT OF PROCEEDS PAID TO THE COMMONWEALTH
15 EQUALS \$4,600,000. ALL PROCEEDS PAID TO THE COMMONWEALTH
16 SHALL BE USED EXCLUSIVELY FOR CHARITABLE PURPOSES RELATED TO
17 THE PROVISION AND PROMOTION OF HEALTH SERVICES WITHIN THIS
18 COMMONWEALTH. ALL PROCEEDS PAID TO CONNELLSVILLE HOSPITAL
19 SHALL BE SET ASIDE AND HELD BY ONE OR MORE CHARITABLE
20 ORGANIZATIONS DESIGNATED BY CONNELLSVILLE HOSPITAL AND
21 DESCRIBED IN SECTION 501(C)(3) OF THE INTERNAL REVENUE CODE
22 OF 1954, AS AMENDED, AND SHALL BE USED EXCLUSIVELY FOR
23 CHARITABLE PURPOSES RELATED TO THE PROVISION AND PROMOTION OF
24 HEALTH SERVICES WITHIN THIS COMMONWEALTH.

25 (4) IN THE EVENT OF A SALE OR OTHER DISPOSITION OF ALL
26 OR SUBSTANTIALLY ALL OF THE PROPERTIES DESCRIBED IN THIS ACT
27 AT ANY TIME THREE (3) YEARS OR MORE AFTER THE DATE OF THE
28 CONVEYANCES AUTHORIZED BY THIS ACT FOR AN AMOUNT EQUALLING OR
29 EXCEEDING FAIR MARKET VALUE AS DETERMINED BY ONE OR MORE
30 PERSONS EXPERT IN ASSESSING THE VALUE OF HEALTH CARE

1 INSTITUTIONS, SUCH PERSON OR PERSONS TO BE MUTUALLY AGREED TO
2 BY THE DEPARTMENT OF PUBLIC WELFARE AND CONNELLSVILLE
3 HOSPITAL, THE PROCEEDS OF SUCH DISPOSITION AFTER PROVIDING
4 FOR ALL DEBTS, LIABILITIES AND OBLIGATIONS OF CONNELLSVILLE
5 HOSPITAL SHALL BE PAID TO CONNELLSVILLE HOSPITAL. NOT LESS
6 THAN ONE-HALF OF ALL SUCH PROCEEDS SHALL BE SET ASIDE AND
7 HELD BY ONE OR MORE CHARITABLE ORGANIZATIONS DESIGNATED BY
8 CONNELLSVILLE HOSPITAL AND DESCRIBED IN SECTION 501(C)(3) OF
9 THE INTERNAL REVENUE CODE OF 1954, AS AMENDED, AND SHALL BE
10 USED EXCLUSIVELY FOR CHARITABLE PURPOSES RELATED TO THE
11 PROVISION AND PROMOTION OF HEALTH SERVICES WITHIN
12 CONNELLSVILLE AND SURROUNDING COMMUNITIES SERVED BY
13 CONNELLSVILLE HOSPITAL. THE REMAINING ONE-HALF OF ALL SUCH
14 PROCEEDS PAID TO CONNELLSVILLE HOSPITAL SHALL BE SET ASIDE
15 AND HELD BY ONE OR MORE CHARITABLE ORGANIZATIONS DESIGNATED
16 BY CONNELLSVILLE HOSPITAL AND DESCRIBED IN SECTION 501(C)(3)
17 OF THE INTERNAL REVENUE CODE OF 1954, AS AMENDED, AND SHALL
18 BE USED EXCLUSIVELY FOR CHARITABLE PURPOSES RELATED TO THE
19 PROVISION AND PROMOTION OF HEALTH SERVICES WITHIN THIS
20 COMMONWEALTH.

21 (5) IN THE EVENT OF DISPOSITION BY CONNELLSVILLE
22 HOSPITAL OF ALL OR SUBSTANTIALLY ALL THE PROPERTIES DESCRIBED
23 IN THIS ACT FOR LESS THAN FAIR MARKET VALUE AS DETERMINED BY
24 ONE OR MORE PERSONS EXPERT AT ASSESSING THE VALUE OF HEALTH
25 CARE INSTITUTIONS, SUCH PERSON OR PERSONS TO BE MUTUALLY
26 AGREED TO BY THE DEPARTMENT OF PUBLIC WELFARE AND
27 CONNELLSVILLE HOSPITAL, CONNELLSVILLE HOSPITAL SHALL REQUIRE
28 ANY SUCCESSOR, GRANTEE, PURCHASER OR OPERATOR OF SUCH
29 PROPERTY TO COMPLY WITH THOSE REQUIREMENTS CONTAINED IN THIS
30 SECTION AND SUCH SUCCESSORS SHALL OBTAIN THE AGREEMENT OF ANY

1 SUBSEQUENT SUCCESSOR TO CONFORM TO THE CONDITIONS IMPOSED IN
2 THIS SECTION AS A CONDITION OF TRANSFER OF THE PROPERTY
3 DESCRIBED IN THIS ACT.

4 SECTION 16. TRANSFER OF AGREEMENTS AND LEASES.

5 ALL AGREEMENTS TO THE EXTENT ASSIGNABLE AND LEASES OF EVERY
6 NATURE OF THE COMMONWEALTH OF PENNSYLVANIA WHICH ARE USED,
7 EMPLOYED OR DISPENSED IN CONNECTION WITH THE DUTIES, POWERS OR
8 FUNCTIONS OF THIS COMMONWEALTH RELATING TO CONNELLSVILLE STATE
9 GENERAL HOSPITAL ARE HEREBY TRANSFERRED TO CONNELLSVILLE
10 HOSPITAL AS OF THE DATE OF THE CONVEYANCE OF THE PROPERTIES
11 DESCRIBED IN THIS ACT. ALL MONEYS RECEIVED BY CONNELLSVILLE
12 HOSPITAL FOR SERVICES RENDERED BY THIS COMMONWEALTH AT
13 CONNELLSVILLE STATE GENERAL HOSPITAL PRIOR TO THE DATE OF THE
14 CONVEYANCE OR CONVEYANCES BY THIS ACT SHALL BE REMITTED TO THE
15 COMMONWEALTH AND ALL ACCOUNTS PAYABLE AND LIABILITIES ARISING
16 FROM OPERATIONS PRIOR TO THE DATE OF CONVEYANCE OF THE
17 PROPERTIES DESCRIBED IN THIS ACT SHALL BE PAID BY THE
18 COMMONWEALTH. NOTHING CONTAINED IN THIS SECTION SHALL IMPOSE
19 UPON CONNELLSVILLE HOSPITAL ANY OBLIGATION, CLAIM, DEMAND OR
20 CAUSE OF ACTION AGAINST THE COMMONWEALTH ARISING OUT OF OR IN
21 CONNECTION WITH THE OPERATION OF CONNELLSVILLE STATE GENERAL
22 HOSPITAL BY THE COMMONWEALTH. THE COMMONWEALTH SHALL INDEMNIFY
23 AND HOLD HARMLESS CONNELLSVILLE HOSPITAL FOR ALL CLAIMS,
24 OBLIGATIONS AND LIABILITIES WHATSOEVER ARISING OUT OF THE
25 OPERATION OF CONNELLSVILLE STATE GENERAL HOSPITAL BY THE
26 COMMONWEALTH AT ANY TIME PRIOR TO THE CONVEYANCE OF THE
27 PROPERTIES DESCRIBED IN THIS ACT.

28 SECTION 17. EFFECTIVE DATE.

29 (A) SPECIFIC.--SECTIONS 1 AND 2 RELATING TO SECTIONS 202 AND
30 401 OF THE ACT SHALL TAKE EFFECT UPON THE CONVEYANCE OF THE

1 PROPERTY AUTHORIZED IN THIS ACT.

2 (B) GENERAL.--THE REMAINDER OF THIS ACT SHALL TAKE EFFECT

3 JULY 1, 1985, OR IMMEDIATELY, WHICHEVER IS LATER.
