AN ACT

- 1 Providing for reimbursement by insurance companies, professional
- health service plan corporations, fraternal benefit societies
- 3 and voluntary nonprofit health service plans for service
- 4 performed by a registered nurse; and providing further duties
- of the Insurance Department.
- 6 The General Assembly of the Commonwealth of Pennsylvania
- 7 hereby enacts as follows:
- 8 Section 1. Short title.
- 9 This act shall be known and may be cited as the Insurance
- 10 Payment to Registered Nurse Law.
- 11 Section 2. Definitions.
- 12 The following words and phrases when used in this act shall
- 13 have the meanings given to them in this section unless the
- 14 context clearly indicates otherwise:
- 15 "Department." The Insurance Department of the Commonwealth.

- 1 Section 3. Policies and contracts covered.
- 2 (a) Coverage enumerated.--This act shall apply to every
- 3 group policy, contract or certificate issued thereunder, of
- 4 health, sickness or accident insurance delivered or issued for
- 5 delivery within the Commonwealth including, but not limited to,
- 6 policies, contracts or certificates issued by:
- 7 (1) Any stock insurance company as described in section
- 8 202(c)(4) and (11) and any mutual insurance company as
- 9 described in section 202(d)(1) of the act of May 17, 1921
- 10 (P.L.682, No.284), known as The Insurance Company Law of
- 11 1921.
- 12 (2) Any hospital plan corporation as defined in 40
- Pa.C.S. Ch. 61 (relating to hospital plan corporations).
- 14 (3) Any professional health services plan corporation as
- defined 40 Pa.C.S. Ch. 63 (relating to professional health
- services plan corporations).
- 17 (4) Any fraternal benefit society as defined in 40
- Pa.C.S. Ch. 65 (relating to fraternal benefits societies).
- 19 (5) Any voluntary nonprofit health service plan as
- 20 defined in the act of December 29, 1972 (P.L.1701, No.364),
- 21 known as the Health Maintenance Organization Act.
- 22 (6) Any person who sells or issues contracts or
- 23 certificates of insurance which meet the requirements of this
- 24 act.
- 25 (b) Application of act.--This act shall apply to policies,
- 26 contracts or certificates issued, renewed, modified, altered,
- 27 amended or reissued on and after the effective date of this act.
- 28 Section 4. Scope of coverage.
- 29 (a) General rule. -- When a service is performed by a
- 30 certified registered nurse anesthetist, certified registered

- 1 nurse practitioner, certified enterostomal therapy nurse,
- 2 certified community health nurse, certified psychiatric mental
- 3 health nurse, or certified clinical nurse specialist, certified
- 4 by the State Board of Nursing or a national nursing organization
- 5 recognized by the State Board of Nursing and lawfully permitted
- 6 to perform that service under the act of May 22, 1951 (P.L.317,
- 7 No.69), known as The Professional Nursing Law, and a policy,
- 8 contract or certificate provides for reimbursement for that
- 9 service, the insured or any other person covered shall be
- 10 entitled to reimbursement either to the insured or to the
- 11 registered professional nurse providing that service. This
- 12 section does not apply to usual and customary nursing services
- 13 provided to patients in REGISTERED PROFESSIONAL NURSES WHO ARE
- 14 EMPLOYEES OF health care facilities as the term "health care
- 15 facilities" is defined in the act of July 19, 1979 (P.L.130,
- 16 No.48), known as the Health Care Facilities Act.
- 17 (b) Application of reimbursement process.--Nothing in this
- 18 section shall apply to the assignment of benefits and payment of
- 19 claims process of a stock insurance company and a mutual
- 20 insurance company as set forth in section 3(a)(1).
- 21 (c) Nonduplication of payments. -- Duplicate payments shall
- 22 not be made to either:
- 23 (1) both a nurse provider as set forth in subsection (a)
- and another provider; or
- 25 (2) to the same provider
- 26 for the same services provided in a single encounter.
- 27 Section 5. Rules and regulations.
- The department shall, in the manner provided by law,
- 29 promulgate the rules, regulations and forms necessary to carry
- 30 out this act. Following publication of the initial set of

- 1 proposed regulations in the Pennsylvania Bulletin, but prior to
- 2 their formal adoption, the department shall hold public hearings
- 3 thereon.
- 4 Section 6. Construction of act.
- 5 Nothing in this act shall be deemed to affect or impair the
- 6 act of May 22, 1951 (P.L.317, No.69), known as The Professional
- 7 Nursing Law, nor to confer upon any public or private
- 8 organization or agency the power to interpret or enforce this
- 9 act, except as may be provided for therein.
- 10 Section 7. Effective date.
- 11 This act shall take effect in 90 days.
