## AN ACT

Amending the act of August 9, 1955 (P.L.323, No.130), entitled "An act relating to counties of the third, fourth, fifth, sixth, seventh and eighth classes; amending, revising, consolidating and changing the laws relating thereto," further regulating flags placed on graves.

6 The General Assembly of the Commonwealth of Pennsylvania

7 hereby enacts as follows:

8 Section 1. Section 1922 of the act of August 9, 1955 9 (P.L.323, No.130), known as The County Code, is amended to read: 10 Section 1922. Flags to Decorate Graves.--(a) It shall be 11 the duty of the county commissioners to provide flags on each 12 Memorial Day with which to decorate the graves of all deceased 13 service persons buried within the county. The flags to be used 14 for such purposes shall be of one standard size, colorfast and 15 American-made, and shall be purchased at the expense of the county from moneys in the county treasury. 16

17 (b) Such flags shall be furnished to the various veterans'18 organizations in such numbers as they shall require for their

1 respective communities.

2 (c) The moneys expended by any county under the provisions
3 of this section shall be in addition to moneys appropriated by
4 counties for Memorial Day purposes.

5 (d) The authorities in charge of any cemetery are authorized 6 to remove such flags when the same become unsightly or 7 weatherworn at any time not less than ninety days after the 8 flags have been placed on graves.

9 (e) Any authority or person in charge of any cemetery, who

10 shall remove or cause the removal of such flags prior to the

11 expiration of ninety days after the flags have been placed on

12 graves, shall be guilty of a summary offense and upon conviction

13 thereof shall be sentenced to pay a fine not to exceed three

14 hundred dollars (\$300), and upon failure to pay such fine, to

15 <u>undergo imprisonment not to exceed ninety days.</u>

16 Section 2. This act shall take effect in 60 days.
