## AN ACT

- Amending Title 75 (Vehicles) of the Pennsylvania Consolidated 2
- Statutes, providing for establishment of a program under
- 3 which persons assigned points for violations may do certain
- 4 work for removal of points.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- hereby enacts as follows: 6
- 7 Section 1. Title 75 of the Pennsylvania Consolidated
- 8 Statutes is amended by adding a section to read:
- § 1537.1. Program for removal of points.
- (a) Program established. -- The department shall establish and 10
- administer a program under which a person who has points 11
- 12 assigned to his record may work, as provided in subsection (b),
- 13 for the removal of assigned points. The department shall develop
- quidelines for persons who apply for participation in the 14
- program as to the types of work and number of hours which will 15
- be acceptable, and the documentation which will be required from 16

- 1 the party for whom the work is to be performed.
- 2 (b) Application. -- A person who has had points assigned to
- 3 his record may apply to the department for removal of points by
- 4 submitting, in the form and manner prescribed by the department,
- 5 evidence that he has made arrangements to do any of the
- 6 <u>following on a voluntary, unpaid basis:</u>
- 7 (1) Work in the emergency room of a local hospital.
- 8 (2) Work with a local ambulance or rescue service.
- 9 (3) Perform other work in the community found acceptable
- by the department.
- 11 (c) Acceptance by department.--If the department agrees to
- 12 the arrangements of the applicant, it shall so notify him. The
- 13 notice shall state the type and hours of work required and the
- 14 number of points which will be removed if the agreement is
- 15 fulfilled.
- 16 (d) Removal of points. -- When the department receives
- 17 evidence satisfactory to it that the agreed upon work has been
- 18 completed, it shall promptly remove the proper number of points
- 19 from the person's record. No more than six points shall be
- 20 removed from a person's record for work performed under this
- 21 section.
- 22 (e) Applicability.--Only points assessed for violations
- 23 enumerated in section 1535(a) (relating to schedule of
- 24 convictions and points) may be removed under this section.
- 25 <u>(f) Nonexclusive.--The removal of points under this section</u>
- 26 shall be in addition to, and not in place of, the removal of
- 27 points under section 1537 (relating to removal of points).
- 28 Section 2. This act shall take effect in 60 days.
