AN ACT

1 Making appropriations to the Governor and the Pennsylvania
2 Emergency Management Agency for disaster relief and for
3 allocations to various municipalities in Westmoreland, ←
4 SOMERSET and Fayette Counties for reimbursement for flood
5 damages.

6 The General Assembly of the Commonwealth of Pennsylvania
7 hereby enacts as follows:

8 Section 1. (a) Pursuant to section 17(b) of Article VIII of
9 the Constitution of the Commonwealth of Pennsylvania, the sum of
10 \$11,000,000, or as much thereof as may be necessary, is hereby
11 appropriated to the Governor in accordance with 35 Pa.C.S. Ch.
12 73A (relating to the Governor and disaster emergencies) to
13 alleviate the hardships and repair the damage caused by the
14 storm of September 27, 1985, in Pennsylvania. This appropriation
15 shall also be used to reimburse municipalities for extraordinary
16 emergency actions undertaken during the storm of September 27,

1 1985.

2 (b) The sum of ~~\$1,594,000~~ \$1,600,000, or as much thereof as <—
3 may be necessary, is hereby appropriated to the Pennsylvania
4 Emergency Management Agency for the fiscal year July 1, 1985, to
5 June 30, 1986, to reimburse certain municipalities for flood
6 damages incurred in the storm of July 8 and 9 of 1985.

7 Section 2. The appropriation in section 1(b) shall be

24 Section 3. (a) All moneys received from the Federal
25 Government for the purpose of disaster relief assistance or for
26 damage caused by the storm of September 27, 1985, are hereby
27 appropriated to the departments, boards, commissions or agencies
28 designated by the Governor.

29 (b) The appropriation in section 1(a) shall be used to pay
30 eligible State and Federal expenditures until Federal moneys are

1 available. When the Federal moneys are made available, the
2 amount of State funds expended for Federal purposes shall be
3 reimbursed and shall lapse.

4 Section 4. The sum appropriated in section 1(b) shall be in
5 addition to any sums received under section 224 of the act of
6 June 30, 1985 (P.L. , No.5A), known as the General
7 Appropriation Act of 1985.

8 SECTION 5. THE SUM OF \$46,400, OR AS MUCH THEREOF AS MAY BE <—
9 NECESSARY, IS HEREBY APPROPRIATED TO THE PENNSYLVANIA EMERGENCY
10 MANAGEMENT AGENCY TO REIMBURSE THE FOLLOWING MUNICIPALITIES FOR
11 FLOOD DAMAGES INCURRED AS A RESULT OF THE STORM OF AUGUST 13,
12 1984:
