AN ACT

Amending the act of April 12, 1951 (P.L.90, No.21), entitled "An 2 act relating to alcoholic liquors, alcohol and malt and 3 brewed beverages; amending, revising, consolidating and changing the laws relating thereto; regulating and 5 restricting the manufacture, purchase, sale, possession, consumption, importation, transportation, furnishing, holding 7 in bond, holding in storage, traffic in and use of alcoholic liquors, alcohol and malt and brewed beverages and the 8 9 persons engaged or employed therein; defining the powers and 10 duties of the Pennsylvania Liquor Control Board; providing for the establishment and operation of State liquor stores, 11 12 for the payment of certain license fees to the respective 13 municipalities and townships, for the abatement of certain nuisances and, in certain cases, for search and seizure 14 15 without warrant; prescribing penalties and forfeitures; 16 providing for local option, and repealing existing laws,"

- 1 providing for the arbitration of grievances of certain
- 2 persons.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. The act of April 12, 1951 (P.L.90, No.21), known
- 6 as the Liquor Code, is amended by adding a section to read:
- 7 <u>Section 303.1. Arbitrator of Grievances.--A Liquor Store</u>
- 8 General Manager 1 or 2 Supervisory shall have the same right of
- 9 appeal from an unfavorable decision in the case of discharge,
- 10 <u>disciplinary demotion</u>, or suspension as a Liquor Store Manager
- 11 <u>1, 2 or 3 or a Liquor Subwarehouse Supervisor 1 or 2.</u>
- 12 Section 2. This act shall apply to any person who was
- 13 employed or is employed in the capacity of a Liquor Store
- 14 General Manager 1 or 2 Supervisory on and after January 1, 1985.
- 15 Section 3. This act shall take effect immediately.
