AN ACT

- 1 Authorizing the release of Project 70 restrictions imposed on
- 2 certain lands owned by the County of Delaware, in return for
- the imposition of Project 70 restrictions on certain lands
- 4 owned by the County of Delaware.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Authorization.
- 8 Pursuant to the requirements of section 20 of the act of June
- 9 22, 1964 (Sp.Sess., P.L.131, No.8), known as the Project 70 Land
- 10 Acquisition and Borrowing Act, the General Assembly hereby
- 11 authorizes the release of the restrictions imposed by section 20
- 12 of the Project 70 Land Acquisition and Borrowing Act from the
- 13 lands owned by the County of Delaware and more particularly
- 14 described in section 3 of this act in exchange for the
- 15 imposition of the restrictions in section 20 of the Project 70
- 16 Land Acquisition and Borrowing Act on lands owned by the County
- 17 of Delaware and more particularly described in section 4 of this
- 18 act.

- 1 Section 2. Freedom of restrictions.
- 2 The lands described in section 3 of this act and owned by the
- 3 County of Delaware shall be free of the restrictions on use and
- 4 alienation imposed by section 20 of the act of June 22, 1964
- 5 (Sp.Sess., P.L.131, No.8), known as the Project 70 Land
- 6 Acquisition and Borrowing Act, upon the imposition of and
- 7 recording of the Project 70 deed restrictions set forth in
- 8 section 5 of this act on the parcel of replacement land owned by
- 9 the County of Delaware and located in the Township of Upper
- 10 Providence, Delaware County, described in section 4 of this act.
- 11 Section 3. Land to be free from restrictions.
- 12 The parcel of land authorized to be released from
- 13 restrictions is more particularly described as follows:
- 14 Beginning at the intersection of Providence Road (L.R. 141)
- 15 and Rose Tree Road (L.R. 23030); thence extending along the
- 16 center line of said Providence Road north 23 degrees, 53 minutes
- 17 30 seconds west 167.28 feet to a point; thence extending north
- 18 66 degrees 39 minutes 50 seconds 500.00 feet to a point; thence
- 19 extending south 23 degrees 53 minutes 30 seconds east 402.56
- 20 feet to a point on the center line of Rose Tree Road; thence
- 21 extending south 89 degrees 52 minutes 10 seconds west along the
- 22 center line of said Rose Tree Road 546.77 feet to the point and
- 23 place of beginning.
- 24 Containing 3.26 acres of land more or less.
- 25 Section 4. Land on which restrictions are to be imposed.
- 26 The replacement parcel to be subject to restrictions in
- 27 exchange for the parcel described in section 3 is more
- 28 particularly described as follows:
- 29 Beginning at an interior point on the northerly side of a
- 30 certain 30-feet wide easement (formerly Copples Lane, unopened)

- 1 at a corner of Lot No. 4 on said plan and in line of land now or
- 2 late of Tomassian (all as shown on said plan); thence extending
- 3 from said beginning point, along land now or late of Tomassian,
- 4 south 87 degrees east 55.42 feet to a point at an angle in said
- 5 30-feet wide easement; thence extending still along land now or
- 6 late of Tomassian, land now or late of Weiss and partly along
- 7 land now or late of Edwards, north 68 degrees 37 minutes 55
- 8 seconds east, along the northwesterly side of said 30-feet wide
- 9 easement; 197.73 feet to a point an angle in said 30-feet wide
- 10 easement; thence extending still along land now or late of
- 11 Edwards and along the northwesterly side of said 30-feet wide
- 12 easement, north 53 degrees 41 minutes east 79.40 feet to a point
- 13 a corner of land now or late of Devit; thence extending along
- 14 the same and along the northwesterly side of said 30-feet wide
- 15 easement; north 54 degrees 05 minutes east 320.03 feet to a
- 16 point; thence extending north 25 degrees 42 minutes west,
- 17 leaving said side of said easement, 182.46 feet to a point a
- 18 corner of land now or late of Lewis; thence extending along the
- 19 same and land now or late of Snowden and Rigby, north 64 degrees
- 20 18 minutes east 365 feet to a point in line of land now or late
- 21 of the County of Delaware (Martin Park); thence extending along
- 22 the same the 2 following courses and distances: (1) south 25
- 23 degrees 42 minutes east 420.12 feet to a point; and (2) south 71
- 24 degrees 40 minutes 49 seconds west 155.72 feet to a point a
- 25 corner of land now or late of Calloway; thence extending along
- 26 the same lands now or late of Young, McCann, Dessauer and
- 27 Wooters, Wilson, Creighton, Walde and Kuder, south 68 degrees 29
- 28 minutes 49 seconds west 917.91 feet to a point, a corner of Lot
- 29 No. 5 on said plan; thence extending along the same and Lot No.
- 30 4, north 03 degrees east, crossing the bed of the said 30-feet

- 1 wide easement, 137.47 feet to the first mentioned point and
- 2 place of beginning.
- 3 Containing 5.4099 acres of land more or less.
- 4 Section 5. Description of deed restrictions.
- 5 The deed restriction to be transferred to the parcel
- 6 described in section 4 of this act shall read as follows:
- 7 This indenture is given to provide land for recreation,
- 8 conservation and historical purposes as said purposes are
- 9 defined in the act of June 22, 1964 (Sp.Sess., P.L.131, No.8),
- 10 known as the Project 70 Land Acquisition and Borrowing Act.
- 11 Section 6. Restriction of revenue.
- 12 The revenue and interest thereon from the lease or sale of
- 13 the land described in section 3 of this act shall be deposited
- 14 in a special account established by the County of Delaware. The
- 15 special account shall be used for rehabilitation and development
- 16 of park and recreation lands and facilities by the County of
- 17 Delaware. No funds shall be dispensed from the account until a
- 18 plan has been developed for the use of such funds by the County
- 19 of Delaware and such plan has been approved by the Department of
- 20 Community Affairs.
- 21 Section 7. Effective date.
- This act shall take effect immediately.
