20	(d) Courts of common pleas
21	(1) The annual salary of a president judge of a court of
22	common pleas shall be fixed in accordance with the following

3	(ii) Philadelphia, [\$67,500] <u>\$72,500</u> .
4	(iii) Judicial districts having six or more judges,
5	[\$66,000] <u>\$71,000</u> .
6	(iv) Judicial districts having three to five judges,
7	[\$65,500] <u>\$70,500</u> .
8	(v) Judicial districts having one or two judges,
9	[\$65,000] <u>\$70,000</u> .
10	(vi) Administrative judges of the divisions of the
11	Court of Common Pleas of Philadelphia County; divisions
12	of six or more judges, [\$66,000] <u>\$71,000</u> .
13	(vii) Administrative judges of the divisions of the
14	Court of Common Pleas of Philadelphia County with
15	divisions of five or less judges, [\$65,500] <u>\$70,500</u> .
16	(viii) Administrative judge of divisions of the
17	Court of Common Pleas of Allegheny County with divisions
18	of six or more judges, [\$66,000] <u>\$71,000</u> .
19	(ix) Administrative judge of divisions of the Court
20	of Common Pleas of Allegheny County of five or less
21	judges, [\$65,500] <u>\$70,500</u> .
22	(2) The other judges of the courts of common pleas shall
23	be paid an annual salary of [\$65,000] <u>\$70,000</u> .
