AN ACT

1 Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An
2 act relating to the public school system, including certain
3 provisions applicable as well to private and parochial
4 schools; amending, revising, consolidating and changing the
5 laws relating thereto," further providing for limits of
6 certain payments.

7 The General Assembly of the Commonwealth of Pennsylvania
8 hereby enacts as follows:

9 Section 1. Section 2502.5(b) of the act of March 10, 1949
10 (P.L.30, No.14), known as the Public School Code of 1949,
11 amended July 1, 1985 (P.L.103, No.31), is amended to read:

12 Section 2502.5. Limitation of Certain Payments.--* * *

13 (b) Notwithstanding any other provisions of law, for the
14 school year 1982-1983 and 1983-1984, no school district shall be
15 paid under subsections (d) and (e) of section 2502 and section
16 2502.11 or for the school year 1984-1985 and each school year
17 thereafter, no school district shall be paid under subsections
18 (d) and (e) of section 2502, section 2502.11 and section 2502.13

1 an amount in excess of one hundred percent (100%) of the total
2 reimbursable instructional expenditures of the school district.
3 For the 1982-1983 school year, all school districts qualifying
4 for payments under subsections (d) and (e) of section 2502 and
5 section 2502.11 shall be limited to an increase payment on
6 account of those sections which shall not exceed nine percent
7 (9%) over the sums received on account of section 2502.9 for the
8 1981-1982 school year, nor shall any school district receive an
9 increase of less than two percent (2%) of the 1982-1983 school
10 year payments on account of the 1981-1982 school year. For the
11 1984-1985 school year and each school year thereafter, each
12 school district qualifying for payments under subsections (d)
13 and (e) of section 2502 and section 2502.11 shall be limited to
14 an increase payment on account of those sections which shall not
15 exceed eight and forty-five one hundredths percent (8.45%) over
16 the sums received on account of such sections for the school
17 year 1983-1984, nor shall any school district receive an
18 increase of less than [two percent (2%)] four percent (4%) of
19 such payments for the school year 1983-1984: Provided, however,
20 That such payments for the school year 1983-1984 shall be
21 computed using a Factor for Educational Expense of one thousand
22 six hundred fifty-six dollars (\$1,656) and a maximum payment
23 increase of seven and forty-five one hundredths percent (7.45%)
24 and a minimum payment increase of two percent (2%) and the
25 eighty percent (80%) guarantee provided for in section
26 2502.5(e).

28 Section 2. This act shall take effect immediately.
