## A SUPPLEMENT

- To the act of July 10, 1986 (P.L. , No.124), entitled, "An 1 2 act providing for the capital budget for the fiscal year 1986-1987," itemizing transportation assistance projects to 3 be constructed or acquired by the Department of Transportation, together with their estimated financial costs; authorizing the incurring of debt without the approval 7 of the electors for the purpose of financing the projects to be constructed or acquired or assisted by the Department of 8 Transportation; stating the estimated useful life of the 9 10 projects; and making appropriations.
- 11 The General Assembly of the Commonwealth of Pennsylvania
- 12 hereby enacts as follows:
- 13 Section 1. Short title.
- 14 This act shall be known and may be cited as the Capital
- 15 Budget Transportation Assistance Project Itemization Act for
- 16 1986-1987.
- 17 Section 2. Total authorizations.
- 18 The total authorization for the capital projects in the
- 19 category of transportation assistance projects itemized in
- 20 section 3 with respect to which an interest is to be acquired in
- 21 or constructed by the Department of Transportation, its

- 1 successors or assigns, and to be financed by the incurring of
- 2 debt, shall be \$40,174,000.
- 3 Section 3. Itemization of transportation assistance projects.
- 4 Additional capital projects in the category of transportation
- 5 assistance projects for mass transit in which an interest is to
- 6 be acquired in or constructed by the Department of
- 7 Transportation, its successors or assigns, and to be financed by
- 8 the incurring of debt, are hereby itemized, together with their

- 2 Section 4. Debt authorization.
- 3 The Governor, Auditor General and State Treasurer are hereby
- 4 authorized and directed to borrow, from time to time, in
- 5 addition to any authorization heretofore or hereafter enacted,
- 6 on the credit of the Commonwealth, subject to the limitations
- 7 provided in the current capital budget, money not exceeding in
- 8 the aggregate the sum of \$40,174,000 as may be found necessary
- 9 to carry out the acquisition and construction of the
- 10 transportation assistance projects specifically itemized in a
- 11 capital budget.
- 12 Section 5. Issue of bonds.
- 13 The indebtedness authorized in this act shall be incurred,
- 14 from time to time, and shall be evidenced by one or more series
- 15 of general obligation bonds of the Commonwealth in such
- 16 aggregate principal amount for each series as the Governor,
- 17 Auditor General and State Treasurer shall determine, but the
- 18 latest stated maturity date shall not exceed the estimated
- 19 useful life of the projects being financed as stated in section
- 20 6.
- 21 Section 6. Estimated useful life and term of debt.
- 22 (a) Estimated useful life. -- The General Assembly states that
- 23 the estimated useful life of the transportation assistance
- 24 public improvement projects itemized in this act is as follows:
- 25 (1) Rolling stock, 15 years.
- 26 (2) Passenger buses, 12 years.
- 27 (3) Furniture and equipment, 10 years.
- 28 (4) All others, 30 years.
- 29 (b) Term of debt.--The maximum term of the debt authorized
- 30 to be incurred under this act is 30 years.

- 1 Section 7. Appropriations.
- 2 The net proceeds of the sale of the obligations authorized in
- 3 this act are hereby appropriated from the Capital Facilities
- 4 Fund to the Department of Transportation in the maximum amount
- 5 of \$40,174,000 to be used by it exclusively to defray the
- 6 financial cost of the transportation assistance projects
- 7 specifically itemized in a capital budget. After reserving or
- 8 paying the expenses of the sale of the obligation, the State
- 9 Treasurer shall pay to the Department of Transportation the
- 10 moneys as required and certified by it to be legally due and
- 11 payable.
- 12 Section 8. Federal funds.
- 13 In addition to those funds appropriated in section 7, all
- 14 moneys received from the Federal Government for the projects
- 15 specifically itemized in this act are also hereby appropriated
- 16 for those projects.
- 17 Section 9. Effective date.
- 18 This act shall take effect immediately.
