## AN ACT

Amending the act of May 17, 1921 (P.L.789, No.285), entitled, as 2 amended, "An act relating to insurance; establishing an 3 insurance department; and amending, revising, and consolidating the law relating to the licensing, 5 qualification, regulation, examination, suspension, and 6 dissolution of insurance companies, Lloyds associations, 7 reciprocal and inter-insurance exchanges, and certain 8 societies and orders, the examination and regulation of fire 9 insurance rating bureaus, and the licensing and regulation of insurance agents and brokers; the service of legal process 10 upon foreign insurance companies, associations or exchanges; 11 providing penalties, and repealing existing laws," further 12 13 defining "exchange." 14 The General Assembly of the Commonwealth of Pennsylvania 15 hereby enacts as follows: 16 Section 1. Section 101 of the act of May 17, 1921 (P.L.789, 17 No.285), known as The Insurance Department Act of one thousand 18 nine hundred and twenty-one, amended May 17, 1933 (P.L.798, 19 No.119), is amended to read: 20 Section 101. Certain Words Defined .-- The word "company," as 21 used in this act, shall be construed to include only 22 incorporated insurance companies, and corporations possessing 23 the power to insure owners of real property, mortgagees, and

- 1 others interested in real property from loss by reason of
- 2 defective titles, liens, and encumbrances, whether incorporated
- 3 under the laws of this Commonwealth, or of any other State,
- 4 territory or district, or under the laws of any foreign country.
- 5 Except where otherwise indicated, the word "association," as
- 6 used in this act, shall be construed to include only
- 7 individuals, partnerships, or associations of individuals,
- 8 authorized to engage in the business of insurance in the
- 9 Commonwealth as insurers on the Lloyds plan.
- 10 The word "exchange," as used in this act, shall be construed
- 11 to include only individuals, partnerships, and corporations,
- 12 authorized by the laws of the Commonwealth to exchange with each
- 13 other inter-insurance or reciprocal insurance contracts. The
- 14 word shall include any aggregation of counties, municipalities,
- 15 cities, boroughs, townships, villages, school districts or other
- 16 <u>public entities</u>, <u>whether incorporated or unincorporated</u>."
- 17 Section 2. This act shall take effect in 60 days.
