## AN ACT

- 1 Providing that certain funds received under the Federal Job
- 2 Training Partnership Act shall be used to provide support
- 3 services related to job training; and providing for
- 4 eligibility for such services.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Short title.
- 8 This act shall be known and may be cited as the Dislocated
- 9 Worker Training Assistance Act.
- 10 Section 2. Statement of purpose.
- 11 It is the intention of the General Assembly that dislocated
- 12 workers without adequate means of support to meet their basic
- 13 personal needs may receive support services necessary to enroll
- 14 in and remain in appropriate job training programs and to
- 15 encourage dislocated workers to enroll in training programs in

- 1 an expeditious manner after their lay-off notice is received.
- 2 Section 3. Definitions.
- 3 The following words and phrases when used in this act shall
- 4 have the meanings given to them in this section unless the
- 5 context clearly indicates otherwise:
- 6 "Department." The Department of Labor and Industry of the
- 7 Commonwealth.
- 8 "Dislocated worker." Individuals who are eligible under
- 9 section 302 of the Job Training Partnership Act (Public Law 97-
- 10 300, 96 Stat. 1322).
- 11 Section 4. Establishment of needs-based payment fund by grant
- 12 recipients.
- Every entity who applies for a grant under Title III of the
- 14 Job Training Partnership Act (Public Law 97-300, 96 Stat. 1322),
- 15 may apply for additional funds under this act to support needs-
- 16 based payments for dislocated workers enrolled in those programs

- 17 on a form and in the manner prescribed by the department,
- 18 SUBJECT TO THE APPROVAL OF THE DEPARTMENT.
- 19 Section 5. Eligibility for needs-based payments.
- 20 (a) Eligible individuals.--Individuals eligible for needs-
- 21 based payments under this act are dislocated workers who meet
- 22 all of the following requirements:
- 23 (1) They are enrolled in a Title III program.
- 24 (2) They are not earning a wage.
- 25 (3) Their unemployment compensation payments have been
- 26 exhausted under any State or Federal program, including
- 27 specific eligibility under the Trade Act of 1974 (93-618, 19
- 28 U.S.C. § 2101 et seq.), as amended.
- 29 Individuals who are otherwise eligible for employment or
- 30 training services may not be denied such services by reason of

- 1 being eligible for needs-based payments which could be provided
- 2 under this act.
- 3 (b) Level of payment.--Needs-based payments shall be
- 4 authorized so each recipient of a Title III grant would be
- 5 permitted to establish a level of payment tailored to the
- 6 economy of the local area and the individual need of each
- 7 dislocated worker. THE MAXIMUM PAYMENT SHALL NOT EXCEED THE <-

- 8 MAXIMUM CASH ASSISTANCE PAYMENT FOR THAT COUNTY: PROVIDED,
- 9 HOWEVER, THAT PARTICIPANTS WITH NO OTHER INCOME SHALL BE
- 10 ELIGIBLE TO RECEIVE UP TO THE MAXIMUM PAYMENT LEVEL.
- 11 PARTICIPANTS WITH OTHER SOURCES OF INCOME SHALL BE ELIGIBLE TO
- 12 RECEIVE A NEEDS-BASED PAYMENT CONSISTENT WITH THE LEVEL
- 13 AUTHORIZED FOR PARTICIPANTS IN THE TITLE II PROGRAM OPERATED IN
- 14 THE AREA.
- 15 (c) Extent of payment.--Payments shall be made up to the
- 16 extent to which funds are appropriated for the program, BUT IN
- 17 NO CASE WILL PAYMENTS BE PERMITTED FOR A PERIOD OF TRAINING
- 18 WHICH EXCEEDS TWO YEARS.
- 19 (d) Suspension of payment.--Each recipient of a Title III
- 20 grant must assure that payments are disallowed for days of
- 21 training which the participant fails to attend., regardless of
- 22 <del>cause.</del>
- 23 (e) Final approval. Final approval of the needs based
- 24 payment system shall rest with the department.
- 25 Section 6. Incentive bonuses.
- 26 The department may also fund demonstration projects which
- 27 offer incentive bonuses for those dislocated workers who enter
- 28 an employment and training program under the Job Training
- 29 Partnership Act (Public Law 97 300, 96 Stat. 1322), if
- 30 enrollment takes place within the first six weeks of being

- 1 determined eligible for unemployment insurance payments. The
- 2 extent and duration of such payments shall be determined by the
- 3 recipient of a Title III grant, but the payment system shall be
- 4 approved by the department.
- 5 Section 7 6. Dislocated worker programs.
- 6 Funds not allocated for use for needs-based payments or bonus
- 7 payments shall be used for general employment and training
- 8 programs for dislocated workers.
- 9 Section 8 7. Reporting.
- 10 The department shall submit a report to the General Assembly,
- 11 no later than July 31 each year on the need for needs-based
- 12 payments in Title III programs. The General Assembly shall have

- 13 complete access to all data upon which the annual report is
- 14 based.
- 15 Section 9 8. Effective date.
- 16 This act shall take effect July 1, 1987.
