AN ACT

Amending the act of April 9, 1929 (P.L.177, No.175), entitled 1 2 "An act providing for and reorganizing the conduct of the 3 executive and administrative work of the Commonwealth by the Executive Department thereof and the administrative 4 departments, boards, commissions, and officers thereof, 5 6 including the boards of trustees of State Normal Schools, or 7 Teachers Colleges; abolishing, creating, reorganizing or 8 authorizing the reorganization of certain administrative 9 departments, boards, and commissions; defining the powers and 10 duties of the Governor and other executive and administrative 11 officers, and of the several administrative departments, 12 boards, commissions, and officers; fixing the salaries of the Governor, Lieutenant Governor, and certain other executive 13 14 and administrative officers; providing for the appointment of certain administrative officers, and of all deputies and 15 16 other assistants and employes in certain departments, boards, 17 and commissions; and prescribing the manner in which the 18 number and compensation of the deputies and all other assistants and employes of certain departments, boards and 19 20 commissions shall be determined, " establishing a Missing 21 Children Coordination Office in the Office of Attorney 22 General; and providing for its powers and duties.

23 The General Assembly of the Commonwealth of Pennsylvania

24 hereby enacts as follows:

1	Section 1. The act of April 9, 1929 (P.L.177, No.175), known
2	as The Administrative Code of 1929, is amended by adding an
3	article to read:
4	ARTICLE IX-C
5	MISSING CHILDREN COORDINATION OFFICE
6	<u>Section 901-C. Missing Children Coordination Office(a)</u>
7	There is hereby established, within the Office of Attorney
8	<u>General, a Missing Children Coordination Office to coordinate</u>
9	activities throughout this Commonwealth relating to the problem
10	<u>of missing children.</u>
11	(b) The Missing Children Coordination Office shall be headed
12	by a person to be known as the Commissioner on Missing Children,
13	who shall be appointed by the Attorney General. The Commissioner
14	<u>on Missing Children shall be a person who by reason of training,</u>
15	experience and attainment is qualified to administer and
16	coordinate activities relating to missing children. Compensation
17	shall be set by the Executive Board.
18	(c) The Attorney General shall appoint such additional
19	professional, technical and clerical staff as shall be necessary
20	for the performance or function of the office.
21	Section 902-C. Powers and Duties of the Missing Children
22	Coordination OfficeThe Missing Children Coordination Office
23	shall have the power and its duty shall be:
24	(1) To establish a clearinghouse or central registry for
25	missing children and to establish a central repository for all
26	information concerning missing children.
27	(2) To establish a toll-free telephone number for use in
28	accepting citizen reports of sightings of missing children
29	within this Commonwealth.
30	(3) To develop Statewide media access so that missing

1	children's photographs can be disseminated throughout this
2	<u>Commonwealth as fast as possible.</u>
3	(4) To provide coordination with and secure the cooperation
4	of other State and Federal agencies and the National Center for
5	Missing and Exploited Children in investigating cases of missing
б	<u>children.</u>
7	(5) To investigate and to render assistance to other law
8	enforcement agencies, upon request, in cases involving missing
9	<u>children.</u>
10	(6) To coordinate the actions of private volunteer
11	organizations which may be able to provide assistance in
12	searches for missing children.
13	(7) To provide assistance in returning missing children from
14	this Commonwealth who are located out of State.
15	(8) To provide support services to local law enforcement
16	agencies, such as special expertise or equipment and assistance
17	in crime analysis, in cases involving more than one jurisdiction
18	or agency.
19	(9) To draw up emergency preparedness plans to ensure the
20	most effective and efficient use of State resources during a
21	missing child investigation.
22	(10) To assist in the investigation of child exploitation
23	cases such as those cases of child pornography and child
24	prostitution or child sex rings which have links to organized
25	crime, or display an internal organization that transcends the
26	geographical limits of a single jurisdiction.
27	(11) To develop special training curriculum and training
28	materials for criminal justice professionals, medical
29	professionals and other youth service professionals to help them
30	handle missing child cases and cases of child victimization.

1	(12) To assist in the development of education and
2	prevention programs for the community, for parents and for
3	children, and to disseminate these materials to the public.
4	(13) To compile and analyze statistics and data concerning
5	missing and exploited children.
6	(14) To recommend to the Governor and the General Assembly
7	changes in State programs and policies that will reduce the
8	problems of missing children and child abduction and abuse.
9	(15) To otherwise work with and coordinate, on a Statewide
10	basis, activities of citizens, groups and law enforcement
11	authorities relating to the problem of missing children.
12	Section 2. This act shall take effect in 60 days.
