## AN ACT

- 1 Amending the act of July 28, 1953 (P.L.723, No.230), entitled,
  2 as amended, "An act relating to counties of the second class
  3 and second class A; amending, revising, consolidating and
  4 changing the laws relating thereto," restricting certain
- 5 persons from bidding on contracts.
- 6 The General Assembly of the Commonwealth of Pennsylvania
- 7 hereby enacts as follows:
- 8 Section 1. Section 2001 of the act of July 28, 1953
- 9 (P.L.723, No.230), known as the Second Class County Code, is
- 10 amended by adding subsections to read:
- 11 Section 2001. County Commissioners to Make Contracts. -- The
- 12 County Commissioners may make contracts for lawful purposes and
- 13 for the purposes of carrying into execution the provisions of
- 14 this section and the laws of the Commonwealth.
- 15 \* \* \*
- 16 (q) No person who or entity which, as a contractor or
- 17 subcontractor, supplied goods or services to a government or

- 1 government instrumentality and has been convicted of, or has
- 2 pleaded quilty or nolo contendere to, a Federal or State crime
- 3 <u>involving fraud upon a government or a government</u>
- 4 instrumentality for acts or omissions arising out of the
- 5 supplying of goods or services, and no entity in which that
- 6 person or entity has a substantial interest, may bid on a
- 7 contract for a period of three (3) years after such conviction
- 8 or plea. For purposes of this subsection, the following words
- 9 <u>and phrases shall have the following meanings:</u>
- 10 (1) "Crime" means any criminal act committed after the
- 11 effective date of this amendatory act for which the maximum
- 12 possible penalty exceeds a fine of three hundred dollars (\$300)
- 13 or exceeds imprisonment for ninety (90) days.
- 14 (2) "Entity" means any association, corporation, limited
- 15 partnership, partnership, or other business or nonprofit
- 16 <u>organization</u>.
- 17 (3) "Fraud" includes, but is not limited to:
- 18 (i) A misrepresentation of a material fact that is not made
- 19 honestly and in good faith.
- 20 (ii) A promise, representation or prediction as to the
- 21 <u>future that is not made honestly and in good faith.</u>
- 22 (iii) An intentional failure to disclose a material fact.
- 23 (iv) A fictitious or pretended purchase or sale of a
- 24 security.
- 25 (v) The gaining, through the sale of a security, of an
- 26 <u>underwriting or promotion fee or profit or a selling or managing</u>
- 27 fee or profit that is so gross or exorbitant as to be
- 28 unconscionable, including a scheme, device or artifice to obtain
- 29 <u>such a profit, fee or commission.</u>
- 30 <u>(vi) A scheme, device or artifice to defraud a prospective</u>

- 1 or actual customer, client or subscriber of securities, money or
- 2 property.
- 3 (4) "State" means the District of Columbia and any
- 4 possession, state, territory or trusteeship of the United
- 5 States.
- 6 (5) "Substantial interest" means serving as a director,
- 7 limited partner, officer, partner or proprietor, or owning more
- 8 than ten per centum (10%) of the number of shares of voting
- 9 stock or more than twenty per centum (20%) of the total number
- 10 of shares of stock.
- 11 (h) In the case of a bid involving the collection,
- 12 <u>transportation</u>, <u>treatment</u>, <u>storage or disposal of solid waste or</u>
- 13 hazardous waste under the act of July 7, 1980 (P.L.380, No.97),
- 14 known as the Solid Waste Management Act, the following shall
- 15 <del>apply:</del>
- 16 (1) A bid may be rejected by the county commissioners if:
- 17 (i) the county commissioners have reason to believe that the
- 18 bidder's responsibility, character and general fitness for
- 19 business do not command the confidence of the public and may not
- 20 be conducive to the honest and efficient conduct of business in
- 21 <u>the best interest of the public; or</u>
- 22 (ii) the bidder's prior performance record in the
- 23 collection, transportation, treatment, storage or disposal of
- 24 solid waste exhibited insufficient reliability, expertise or
- 25 competency to warrant the belief that the bidder would be likely
- 26 to exhibit sufficient reliability, expertise or competence with
- 27 respect to the contract being bid.
- 28 (2) The county may require the following information to be
- 29 <u>submitted with the bid:</u>
- 30 (i) if the bidder has an equity interest in a company which

- 1 collects, transports, treats, stores or disposes of solid waste
- 2 or hazardous waste, the name and address of that company;
- 3 <u>(ii) a description of the bidder's experience and</u>
- 4 credentials in collection, transportation, treatment, storage or
- 5 <u>disposal of solid waste or hazardous waste, including past or</u>
- 6 present licenses;
- 7 (iii) if the bidder is an entity, the names of the officers
- 8 and directors or partners;
- 9 <u>(iv) a list and explanation of Federal, State and local</u>
- 10 notices of violation, prosecutions, administrative orders and
- 11 <u>license revocations, for the ten (10) years immediately</u>
- 12 preceding the bid submission, if the action is pending or has
- 13 resulted in a finding or a settlement of a violation of law by
- 14 the bidder or its employes, and, in the case of an entity, by an
- 15 <u>officer or director or a partner, relating to the collection,</u>
- 16 transportation, treatment, storage or disposal of solid waste or
- 17 hazardous waste;
- 18 (v) a list and explanation of judgments of civil liability
- 19 and convictions against the bidder or its employes and, in the
- 20 <u>case of an entity, against an officer or director or a partner;</u>
- 21 <u>(vi) a list of agencies outside of this Commonwealth which</u>
- 22 had regulatory authority over the bidder in connection with the
- 23 collection, transportation, treatment, storage or disposal of
- 24 solid waste or hazardous waste; and
- 25 (vii) other information that the county commissioners deem
- 26 <u>relevant to the competency, reliability or good character of the</u>
- 27 <del>bidder.</del>
- 28 (i) (H) The county may require the following information to
- 29 be submitted with the bid: a sworn statement by the bidder and,
- 30 if the affiant is an entity, by every person or entity having a

- substantial interest therein, listing all Federal and state 1
- 2 convictions of, and pleas of guilty or nolo contendere to, any
- 3 crime within three (3) years prior to the date of the statement,
- 4 said statement to be dated no more than one (1) week prior to
- the date set for the opening of bids. 5
- Section 2. This act shall take effect in 60 days. 6
