AN ACT

- 1 Amending Title 75 (Vehicles) of the Pennsylvania Consolidated
- 2 Statutes, providing for a speed limit of 65 miles per hour on
- 3 rural interstate highways and on the Pennsylvania Turnpike.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Section 3362 of Title 75 of the Pennsylvania
- 7 Consolidated Statutes is amended to read:
- 8 § 3362. Maximum speed limits.
- 9 (a) General rule. -- Except when a special hazard exists that
- 10 requires lower speed for compliance with section 3361 (relating
- 11 to driving vehicle at safe speed), the limits specified in this
- 12 subsection or established under this subchapter shall be maximum
- 13 lawful speeds and no person shall drive a vehicle at a speed in
- 14 excess of the following maximum limits:
- 15 (1) 35 miles per hour in any urban district.
- 16 (2) 65 miles per hour on rural interstate highways and
- on the Pennsylvania Turnpike.
- 18 [(2)] (3) 55 miles per hour in other locations.

- 1 [(3)] <u>(4)</u> Any other maximum speed limit established
- 2 under this subchapter.
- 3 (b) Posting of speed limit. -- No maximum speed limit
- 4 established under subsection (a)(1) [or], (3) or (4) shall be
- 5 effective unless posted on fixed or variable official traffic-
- 6 control devices erected in accordance with regulations adopted
- 7 by the department which regulations shall require posting at the
- 8 beginning and end of each speed zone and at intervals not
- 9 greater than one-half mile.
- 10 (c) Penalty. -- Any person violating this section is guilty of
- 11 a summary offense and shall, upon conviction, be sentenced to
- 12 pay a fine of \$35. Any person exceeding the maximum speed limit
- 13 by more than five miles per hour shall pay an additional fine of
- 14 \$2 per mile for each mile in excess of five miles per hour over
- 15 the maximum speed limit.
- 16 (d) Rural interstate highways. -- The department shall
- 17 determine what constitutes a rural interstate highway. The
- 18 determination shall be based on the population of the area in
- 19 which the highway is located and on the number of motor vehicles
- 20 which use the highway's access and exit ramps. A section of an
- 21 <u>interstate highway may be designated as rural and the speed</u>
- 22 limit of that section may be set at 65 miles per hour, even
- 23 though another portion of that highway, because it is located in
- 24 an area of dense population and heavy vehicular ingress and
- 25 egress, is not designated as rural and the speed limit on that
- 26 <u>section is 55 miles per hour.</u>
- 27 Section 2. This act shall take effect immediately.
