## AN ACT

- Amending the act of April 29, 1937 (P.L.487, No.115), entitled, as reenacted and amended, "An act to provide for the 2 3 permanent personal registration of electors in cities of the 4 second class, cities of the second class A, cities of the third class, boroughs, towns, and townships as a condition of 6 their right to vote at elections and primaries, and their 7 enrollment as members of political parties as a further 8 condition of their right to vote at primaries; prescribing certain procedure for the conduct of elections and primaries 9 and the challenge and proof of qualifications of electors; 10 requiring the county commissioners of the various counties to 11 12 act as a registration commission therefor; and prescribing 13 the powers and duties of citizens, parties, political bodies, 14 registration commissions, commissioners, registrars, 15 inspectors of registration and other appointees of 16 registration commissions, county election boards, election officers, municipal officers, departments and bureaus, police 17 18 officers, courts, judges, prothonotaries, sheriffs, county 19 commissioners, peace officers, county treasurers, county 20 controllers, registrars of vital statistics, certain public utility corporations, real estate brokers, rental agents, and 21 22 boards of school directors; and imposing penalties," 23 eliminating certain items relating to sex, race and physical 24 description from certain registration forms.
- 25 The General Assembly of the Commonwealth of Pennsylvania
- 26 hereby enacts as follows:

- 23 or voting machine booth, without assistance, and, if so, his
- 24 declaration of the fact and his statement of the exact nature of
- 25 such disability; [(15)] (11) the designation of the political
- 26 party of the elector, for the purpose of voting at primaries;
- 27 [(16)] (12) the affidavit of registration, which shall be signed
- 28 by the elector, attested by the signature of the registrar or
- 29 clerk and dated by him; [(17) his height, in feet and inches;
- 30 (18) the color of his hair; (19) the color of his eyes; and

- 1 (20)] and (13) the date of his birth. Each registration card
- 2 shall also have a sufficient number of spaces thereon for the
- 3 insertion of --[(21)] (14) the city of the second class, the city
- 4 of the second class A, the city of the third class, the borough,
- 5 town, township, ward and election district, if any, in which the
- 6 elector resides and to which he may from time to time remove,
- 7 together with his street address in each city of the second
- 8 class, city of the second class A, city of the third class,
- 9 borough, town or township, and the other data required to be
- 10 given upon such removal; [(22)] (15) the date of each election
- 11 and primary at which the elector votes, the number and letter,
- 12 if any, of the stub of the ballot issued to him or his number in
- 13 the order of admission to the voting machines; and [(23)] (16)
- 14 the signature or initials of the election officer who enters the
- 15 record of voting on the card.

- 17 Section 18.1. Manner of Mail Registration by Persons in
- 18 Military Service, Persons in the Merchant Marine, Persons in
- 19 Religious and Welfare Groups Officially Attached To and Serving
- 20 with the Armed Forces and Civilian Federal Personnel Overseas
- 21 and Their Spouses and Dependents. -- In addition to any other
- 22 method herein provided, the following persons may also be
- 23 registered by mail in the manner hereinafter set forth under
- 24 this section: (1) any person in military service, his spouse and
- 25 dependents; or (2) any person in the Merchant Marine, his spouse
- 26 and dependents; or (3) any person in religious and welfare
- 27 groups officially attached to and serving with the armed forces,
- 28 his spouse and dependents; or (4) any person who is a civilian
- 29 employee of the United States outside the territorial limits of
- 30 the several States of the United States and the District of

- 7 the statement of the applicant, the signature of the applicant,
- 8 and shall provide sufficient space for the following
- 9 information: (1) The surname of the applicant, (2) his Christian
- 10 name or names, (4) the street or road and number, if any, of his
- 11 home residence and the date of leaving same, providing that, in
- 12 the event there is no street address, the registrant must list
- 13 the nearest cross street or road, (5) if his residence was a
- 14 portion only of a house, the location or number of the room or
- 15 rooms, apartment, flat or floor which he occupied, (6) the date
- 16 his residence began at the place which is his home residence,
- 17 (7) his home residence address when he last registered and the
- 18 year of such registration, including any former registration
- 19 under any other surname, (8) [the sex of the applicant, (9) the
- 20 color of the applicant: Provided, however, That an application
- 21 shall not be rejected because the color of the applicant is not
- 22 indicated thereon, (10)] the state or territory of the United

- 18 any, in which the applicant resided on the date of leaving home
- 19 residence and to which he may from time to time remove after
- 20 returning to his home residence, together with his street
- 21 address in each city of the second class, city of the second
- 22 class A, city of the third class, borough, town or township and
- 23 the other data required to be given upon such removal, [(23)]
- 24 (16) the date of each election and primary at which the
- 25 applicant votes after registration, the number and letter, if
- 26 any, of the stub of the ballot issued to him, or his number in
- 27 the order of admission to the voting machines, and [(24)] (17)
- 28 the signature or initials of the election officer, commissioner,
- 29 register or clerk, who enters the record of voting on the card.

- 6 Than Those Enumerated in Section 18.1 of This Act.--Any elector

- 24 rejected because the color of the applicant is not indicated
- 25 thereon, (10)] the state or territory of the United States or
- 26 the foreign country where he was born, [(13)] (9) whether he is
- 27 unable by reason of illiteracy to read the names on the ballot
- 28 or on voting machines labels, [(14)] (10) whether he has a
- 29 physical disability which will render him unable to see or mark
- 30 the ballot or operate the voting machine or to enter the voting

- 2 so, his declaration of that fact and his statement of the exact

- 10 that the official registration application card is intended by
- 11 such elector for use as (check one):

- 15 Each official registration application card for electors
- 16 registering in the manner prescribed by this section shall also
- 17 have a sufficient number of spaces thereon for the insertion of
- 18 [(22)] (15) the city of the second class, city of the second
- 19 class A, city of the third class, borough, town, township, ward
- 20 and election district, if any, in which the applicant resides
- 21 and to which he may, from time to time, remove together with his
- 22 street address in each city of the second class, city of the
- 23 second class A, city of the third class, borough, town or
- 24 township, and the other data required to be given upon such
- 25 removal, [(23)] (16) the date of each election and primary at
- 26 which the applicant votes after registration, the number and
- 27 letter, if any, of the stub of the ballot issued to him or his
- 28 number in the order of admission to the voting machines, and
- 29 [(24)] (17) the signature or initials of the election officer,
- 30 commissioner, registrar or clerk, who enters the record of

- 1 voting on the card. Immediately following the spaces for
- 2 inserting the information as provided in this subsection, the
- 3 applicant shall affix his signature exactly as it appears in (1)
- 4 and (2) of this subsection.

- 6 Section 2. This act shall take effect in 60 days.
