AN ACT

- 1 Amending Title 51 (Military Affairs) of the Pennsylvania
- 2 Consolidated Statutes, providing a pension for certain
- 3 disabled veterans.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Title 51 of the Pennsylvania Consolidated
- 7 Statutes is amended by adding a section to read:
- 8 § 7703. Disabled veteran's pension.
- 9 (a) Amount and eligibility.--In addition to any other
- 10 assistance provided by the Commonwealth and in addition to any
- 11 compensation provided by the Federal Government, every veteran
- 12 whose service-connected disability is certified 100% shall be
- 13 paid a pension of \$100 per month. Applications for the pensions
- 14 shall be made to and in the form prescribed by the department.
- 15 The Adjutant General shall determine the eligibility of every
- 16 applicant for a pension, and his decision in the matter shall be
- 17 final.

- 1 (b) Regulations.--The Adjutant General shall promulgate such
- 2 regulations as may be necessary to implement this program.
- 3 (c) Definition.--As used in this section, the term "veteran
- 4 whose service-connected disability is certified 100%" means any
- 5 person who served in the armed forces of the United States, or
- 6 any woman's organization officially connected therewith, during
- 7 <u>an established war or armed conflict service dates, and who gave</u>
- 8 this Commonwealth as his place of residence at the time of
- 9 <u>entering the armed forces of the United States and is currently</u>
- 10 <u>a resident of this Commonwealth and who, while performing duties</u>
- 11 connected with that service, suffered an injury or incurred a
- 12 <u>disease which resulted in the veteran having a disability</u>
- 13 certified 100% by the service unit of the armed forces in which
- 14 the veteran served or by the United States Veterans
- 15 Administration. The term does not include any person separated
- 16 from the military or naval forces of the United States, or any
- 17 woman's organization officially connected therewith, under other
- 18 than honorable conditions. The term shall include veterans whose
- 19 service-connected disability is certified 100% as a result of
- 20 peacetime combat-related actions as defined by the Department of
- 21 Military Affairs. The department shall, by regulation, establish
- 22 criteria to determine eligibility based on participation in a
- 23 peacetime combat-related situation, which shall include, but not
- 24 <u>be limited to, hostile fire or terrorist attack.</u>
- 25 Section 2. This act shall take effect immediately.
