AN ACT

Amending the act of July 28, 1966 (3rd Sp.Sess., P.L.91, No.4), entitled, as amended, "An act restricting the establishment 2 3 and maintenance of junkyards and automotive dismantlers and recyclers along highways; providing for the screening of 5 outdoor junkyards and automotive dismantlers and recyclers; prescribing a license fee; conferring powers and imposing duties on the Secretary of Transportation; providing 7 authority to take property by eminent domain in certain 8 9 cases; making an appropriation; and providing penalties," further providing for the screening of certain junkyards, 10 automotive dismantlers and recyclers. 11 12 The General Assembly of the Commonwealth of Pennsylvania 13 hereby enacts as follows: 14 Section 1. Sections 4 and 6 of the act of July 28, 1966 (3rd 15 Sp.Sess., P.L.91, No.4), referred to as the Junkyard and 16 Automotive Recycler Screening Law, amended July 13, 1977 (P.L.77, No.28), are amended to read: 17 18 Section 4. No license shall be granted for the 19 establishment, maintenance, use or operation of a junkyard or 20 automotive dismantler and recycler within one thousand feet of 21 the nearest edge of the right-of-way of any highway except the

- 1 (a) Junkyards and automotive dismantlers and recyclers which
- 2 are lawfully in existence prior to January 1, 1967.
- 3 (b) Junkyards and automotive dismantlers and recyclers
- 4 which, because of screening by natural objects, plantings,
- 5 fences, or other means found appropriate by the secretary, are
- 6 not visible from the main-traveled way of the highway.
- 7 (c) Junkyards and automotive dismantlers and recyclers
- 8 located within areas zoned for industrial use under authority of
- 9 law and which are properly screened as provided in section 6.
- 10 (d) Junkyards and automotive dismantlers and recyclers
- 11 located within unzoned areas which the secretary shall find are
- 12 used for industrial activities.
- 13 Section 6. Any junkyard or automotive dismantler and
- 14 recycler lawfully in existence on January 1, 1967 which is
- 15 within one thousand feet of the nearest edge of the right-of-way
- 16 of a highway, and which is not in any of the classes specified
- 17 in subsections (b)[, (c)] and (d) of section 4, shall be
- 18 screened, if physically and economically feasible, by the
- 19 secretary at locations on the highway right-of-way or in areas
- 20 acquired for such purposes outside the right-of-way, so as not
- 21 to be visible from the main-traveled way of the highway. No junk
- 22 or any other motor vehicle incapable of meeting State inspection
- 23 requirements shall be placed between the highway and the
- 24 screening.
- 25 Section 2. This act shall take effect in 60 days.
