AN ACT

Amending the act of July 5, 1984 (P.L.587, No.119), entitled "An 2 act empowering the Department of Transportation to preserve 3 and improve rail freight service in the Commonwealth by 4 making grants, loans or other assistance available to 5 qualified applicants; authorizing a comprehensive rail study; 6 making an appropriation; and making repeals, " CHANGING THE 7 NAME OF THE RAIL FREIGHT POLICY COMMITTEE; INCREASING THE 8 MEMBERSHIP ON THE COMMITTEE; FURTHER PROVIDING FOR THE SELECTION OF THE CHAIRPERSON; EXTENDING CERTAIN GRANTS OVER 9 TWO FISCAL PERIODS; AND extending the Rail Freight Policy 10 11 ADVISORY Committee for an additional five years. 12 The General Assembly of the Commonwealth of Pennsylvania 13 hereby enacts as follows: 14 Section 1. Section 4(d) of the act of July 5, 1984 (P.L.587, <--No.119), known as the Rail Freight Preservation and Improvement 15 16 Act, is amended to read: Section 4. Rail Freight Policy Committee. 17 * * * 18 19 SECTION 1. THE DEFINITION OF "COMMITTEE" IN SECTION 3 OF THE 20 ACT OF JULY 5, 1984 (P.L.587, NO.119), KNOWN AS THE RAIL FREIGHT 21 PRESERVATION AND IMPROVEMENT ACT, IS AMENDED TO READ:

- 7 CREATED BY THIS ACT.

- 9 SECTION 2. SECTION 4 OF THE ACT IS AMENDED TO READ:
- 10 SECTION 4. RAIL FREIGHT [POLICY] ADVISORY COMMITTEE.
- 11 (A) CREATION. -- THERE IS HEREBY CREATED A RAIL FREIGHT
- 12 [POLICY] ADVISORY COMMITTEE, WHICH SHALL CONSIST OF [13] 24
- 13 MEMBERS. THE MEMBERS SHALL BE [THE SECRETARY OF TRANSPORTATION,
- 14 EX OFFICIO, WHO SHALL ACT AS CHAIRMAN, THE SECRETARY OF
- 15 COMMERCE, EX OFFICIO, THE SECRETARY OF COMMUNITY AFFAIRS, EX
- 16 OFFICIO, THE CHAIRMAN OF THE PUBLIC UTILITY COMMISSION, EX
- 17 OFFICIO, THREE MEMBERS OF THE HOUSE OF REPRESENTATIVES TO BE
- 18 APPOINTED BY THE SPEAKER, TWO SHALL BE MEMBERS OF THE MAJORITY
- 19 PARTY, AND ONE SHALL BE A MEMBER FROM THE MINORITY PARTY, THREE
- 20 MEMBERS OF THE SENATE TO BE APPOINTED BY THE PRESIDENT PRO
- 21 TEMPORE, TWO SHALL BE MEMBERS OF THE MAJORITY PARTY, AND ONE
- 22 SHALL BE A MEMBER FROM THE MINORITY PARTY, TWO REPRESENTATIVES
- 23 OF RAILROAD COMPANIES, ONE OF A CLASS I RAILROAD AND ONE OF A
- 24 CLASS III RAILROAD, TO BE APPOINTED BY THE GOVERNOR, WHO SHALL
- 25 HAVE EXTENSIVE EXPERIENCE AND KNOWLEDGE OF RAIL FREIGHT
- 26 TRANSPORTATION ACTIVITIES THROUGHOUT THE COMMONWEALTH, AND ONE
- 27 REPRESENTATIVE OF A RAILROAD SHIPPER, TO BE APPOINTED BY THE
- 28 GOVERNOR, WHO SHALL HAVE EXTENSIVE EXPERIENCE AND KNOWLEDGE OF
- 29 RAIL FREIGHT TRANSPORTATION ACTIVITIES THROUGHOUT THE
- 30 COMMONWEALTH.] AS FOLLOWS:

3	(3) THE CHAIRMAN OF THE PENNSYLVANIA PUBLIC UTILITY
4	COMMISSION, EX OFFICIO.
5	(4) THE CHAIRMAN AND MINORITY CHAIRMAN OF THE SENATE
6	TRANSPORTATION COMMITTEE.
7	(5) THE CHAIRMAN AND MINORITY CHAIRMAN OF THE
8	TRANSPORTATION COMMITTEE OF THE HOUSE OF REPRESENTATIVES.
9	(6) SEVENTEEN MEMBERS OF THE PUBLIC REPRESENTING THE
10	AREAS OF CONCERN SPECIFIED WHO SHALL HAVE EXTENSIVE
11	EXPERIENCE AND KNOWLEDGE OF RAIL FREIGHT TRANSPORTATION
12	ACTIVITIES THROUGHOUT THE COMMONWEALTH TO BE APPOINTED BY THE
13	GOVERNOR AS FOLLOWS:
14	(I) TWO REPRESENTATIVES OF CLASS I RAILROAD
15	COMPANIES.
16	(II) THREE REPRESENTATIVES OF REGIONAL
17	RAILROAD/SHORT LINE OPERATION.
18	(III) SIX REPRESENTATIVE RAIL SHIPPERS, EACH TO
19	REPRESENT ONE OF THE FOLLOWING AREAS:
20	(A) COAL.
21	(B) STEEL.
22	(C) LUMBER.
23	(D) INTERMODAL.
24	(E) CHEMICAL.
25	(F) FOOD PRODUCTS/AGRICULTURE.
26	(IV) ONE REPRESENTATIVE FROM THE PENNSYLVANIA
27	CHAMBER OF COMMERCE.
28	(V) TWO REPRESENTATIVES OF REGIONAL/LOCAL ECONOMIC
29	DEVELOPMENT GROUPS.
30	(VI) TWO REPRESENTATIVES OF REGIONAL/LOCAL PLANNING

- 1 <u>COMMISSIONS.</u>
- 2 <u>(VII) ONE REPRESENTATIVE OF RAIL</u>
- 3 <u>CONTRACTORS/SUPPLIERS.</u>
- 4 EACH MEMBER MAY DESIGNATE A REPRESENTATIVE TO SERVE IN HIS OR
- 5 HER STEAD. A MEMBER WHO DESIGNATES A REPRESENTATIVE SHALL NOTIFY
- 6 THE CHAIRMAN, IN WRITING, OF THE DESIGNATION.
- 7 (B) TERMS OF APPOINTEES. -- THE TERM OF ALL MEMBERS OF THE
- 8 COMMITTEE APPOINTED BY THE GOVERNOR SHALL BE FOR THREE YEARS,
- 9 HOWEVER, THE INITIAL TERMS OF THESE MEMBERS SHALL BE AS FOLLOWS:
- 10 (1) ONE YEAR FOR THE REPRESENTATIVE OF A CLASS I
- 11 RAILROAD.
- 12 (2) TWO YEARS FOR THE REPRESENTATIVE OF A CLASS III
- 13 RAILROAD.
- 14 (3) THREE YEARS FOR THE REPRESENTATIVE OF A RAILROAD
- 15 SHIPPER.
- 16 ANY MEMBER OF THE COMMITTEE MAY BE REAPPOINTED FOR AN ADDITIONAL
- 17 TERM OR TERMS. ANY PERSON APPOINTED TO FILL A VACANCY SHALL
- 18 SERVE ONLY FOR THE UNEXPIRED TERM.
- 19 (C) MEETINGS AND EXPENSES. -- THE COMMITTEE SHALL MEET AT
- 20 LEAST FOUR TIMES EVERY 12 MONTHS, BUT MAY HOLD SUCH ADDITIONAL
- 21 MEETINGS AS ARE CALLED BY THE CHAIRMAN OR BY PETITION OF AT
- 22 LEAST [FOUR] SEVEN COMMITTEE MEMBERS. THE [RAILROAD AND SHIPPER]
- 23 PUBLIC MEMBERS OF THE COMMITTEE SHALL BE ALLOWED PER DIEM
- 24 EXPENSES, TO BE SET BY THE COMMITTEE, BUT NOT TO EXCEED \$75. THE
- 25 DEPARTMENT SHALL PROVIDE APPROPRIATE STAFF SUPPORT TO ENABLE THE
- 26 COMMITTEE TO PROPERLY CARRY OUT ITS FUNCTIONS.
- 27 (d) Powers and duties. -- The power and duty of the committee
- 28 shall be to advise and comment on the comprehensive rail freight
- 29 study, to advise and comment on all phases of the rail freight
- 30 transportation program activities being undertaken or

- 1 financially assisted by the department, and to propose methods,
- 2 strategies or technologies for improving rail freight
- 3 transportation services systems or facilities within the
- 4 Commonwealth. The committee shall periodically submit reports of
- 5 its deliberations and conclusions to the Governor, members of
- 6 the General Assembly and the State Transportation Commission.
- 7 The committee shall terminate its existence on [November 30,
- 8 1988] <u>November 30, 1993</u>.
- 9 (E) CHAIRPERSON. -- THE MEMBERS OF THE COMMITTEE SHALL
- 10 ANNUALLY ELECT A CHAIRPERSON, VICE CHAIRPERSON AND A SECRETARY

- Section $\frac{2}{3}$. Section $\frac{5}{6}$ of the act, item vetoed by the
- 13 Governor July 5, 1984 (P.L.587, No.119), is amended to read:
- 14 Section 5. Comprehensive rail freight study.

- 16 (c) Appropriation.--The [sum of \$750,000, or as much thereof
- 17 as may be necessary, is hereby appropriated] General Assembly
- 18 shall annually appropriate funds to the department for the
- 19 exclusive purpose of carrying out the comprehensive rail freight
- 20 study, including department administrative expenses. Unexpended
- 21 funds appropriated shall remain available for expenditure until
- 22 [November 30, 1988] <u>November 30, 1993</u>.
- 23 SECTION 4. SECTION 6(B) OF THE ACT IS AMENDED TO READ:
- 24 SECTION 6. PROGRAM AUTHORITY.
- 25 * * *
- 26 (B) GUIDELINES FOR GRANTS.--THE FOLLOWING SHALL GOVERN ALL
- 27 GRANTS MADE UNDER THE AUTHORITY OF SUBSECTION (A):
- 28 (1) A RESPONSIBLE LEVEL OF LOCAL FINANCIAL
- 29 PARTICIPATION, TO BE DETERMINED BY THE DEPARTMENT, SHALL BE
- 30 REOUIRED FOR EACH CATEGORY OF PROJECT AUTHORIZED BY THIS

- 1 SECTION.
- 2 (2) A GRANT SHALL BE MADE ONLY UPON APPLICATION FILED BY
- 3 A GRANTEE REVIEWED AND APPROVED BY THE DEPARTMENT. NO GRANT
- 4 SHALL EXCEED THE AMOUNT REQUESTED BY A GRANTEE. AN AMENDED
- 5 GRANT REQUEST NEED NOT BE FILED BY A GRANTEE WHERE A PROPOSED
- 6 CONTRACT AMENDMENT DOES NOT EXCEED THE AMOUNT PREVIOUSLY
- 7 REQUESTED.
- 8 (3) A GRANT MAY BE MADE WITH REFERENCE TO ANY
- 9 APPROPRIATE PROJECT REGARDLESS OF WHEN IT WAS FIRST COMMENCED
- 10 OR CONSIDERED AND REGARDLESS OF WHETHER THE COSTS WITH
- 11 RESPECT THERETO SHALL HAVE BEEN INCURRED PRIOR TO THE TIME
- 12 THE PROJECT IS UNDERTAKEN OR THE PROJECT GRANT IS APPLIED FOR
- OR MADE. IN THE CASE OF A PROJECT INVOLVING ACCELERATED
- 14 MAINTENANCE OR REHABILITATION, GRANTS SHALL BE MADE BY THE
- 15 DEPARTMENT ONLY AFTER RECEIPT OF SATISFACTORY DOCUMENTATION
- 16 CONCERNING THE CONDITION OF THE RAIL FACILITIES INVOLVED
- 17 BEFORE AND AFTER THE ACCELERATED MAINTENANCE OR
- 18 REHABILITATION. WHERE THE DEPARTMENT CONTRACTS FOR A GRANT
- 19 BASED UPON ESTIMATED COSTS, PAYMENTS MAY BE MADE THEREUNDER
- 20 PRIOR TO THE TIME COSTS ARE ACTUALLY INCURRED, HOWEVER, THE
- 21 DEPARTMENT SHALL ADJUST THE PAYMENTS UNDER ANY AGREEMENT
- 22 BEFORE THE END OF THE FISCAL YEAR INVOLVED, BASED UPON THE
- 23 MOST RECENT AVAILABLE ACTUAL DATA.
- 24 (3.1) ANY GRANT MADE FOR PURPOSES OF ACCELERATED
- 25 MAINTENANCE PROJECTS OR CAPITAL PROJECTS SHALL CONTINUE FOR
- 26 TWO FISCAL YEARS AND SHALL NOT LAPSE AT THE END OF THE FISCAL
- 27 YEAR IN WHICH THAT GRANT WAS AWARDED.
- 28 (4) NO AGREEMENT SHALL IMPAIR, SUSPEND, CONTRACT,
- 29 ENLARGE OR EXTEND OR AFFECT IN ANY MANNER THE POWERS OF THE
- 30 PENNSYLVANIA PUBLIC UTILITY COMMISSION, THE INTERSTATE

- 1 COMMERCE COMMISSION OR ANY OTHER REGULATORY AGENCY HAVING
- 2 JURISDICTION OVER RAIL FREIGHT TRANSPORTATION SERVICES,
- 3 SYSTEMS AND FACILITIES.

- 5 Section 3 5. This act shall take effect immediately.
