A RESOLUTION

1 Proclaiming the month of October 1988 as "Choice For Me...Drug 2 Free month. 3 WHEREAS, Illicit drug and alcohol abuse has reached epidemic proportions and is of major concern to all Americans; and 5 WHEREAS, Illegal drug and alcohol use is a major public health threat and is one of the largest causes of preventable 6 7 disease, disability and death in the United States today; and 8 WHEREAS, Drug and alcohol abuse cost American society nearly \$100 billion a year in lost productivity; and 10 WHEREAS, Illegal drug use does not discriminate on the basis 11 of age, gender or socioeconomic status as evidenced by the 12 following statistics: (1) twenty-three million Americans age twelve and over 13 14 currently use illicit drugs; 15 (2) a nationwide Weekly Reader survey revealed that, of the 68,000 fourth graders polled, 34% reported peer pressure 16

to try wine coolers, 41% to smoke and 24% to use crack or

- 1 cocaine; and
- 2 (3) the fifteen to twenty-four year old age group is
- 3 dying at a faster rate than any other age group because of
- 4 accidents, homicides and suicides, many of which are related
- 5 to drug and alcohol abuse; and
- 6 WHEREAS, The American people indicate that drug abuse is one
- 7 of the most serious domestic problems facing this Nation
- 8 according to public opinion polls, and they have begun to take
- 9 steps to fight it; and
- 10 WHEREAS, A national campaign promoting a "Drug Free America"
- 11 during the month of October 1988 will be celebrated throughout
- 12 the United States, including designation of the week of October
- 13 24 through 30, 1988, as "Drug Free America Week", symbolized by
- 14 wearing the color red to demonstrate commitment to a healthy,
- 15 drug free lifestyle; and
- 16 WHEREAS, Counties throughout the Commonwealth of Pennsylvania
- 17 will support the rest of the United States in recognizing and
- 18 promoting the concept of "The Choice For Me...Drug Free";
- 19 therefore be it
- 20 RESOLVED, That the House of Representatives designate the
- 21 month of October 1988 as "Choice For Me...Drug Free" month in
- 22 recognition of and support of the participation of concerned
- 23 parents, educators, business leaders, private sector
- 24 organizations and government leaders efforts towards a "Drug
- 25 Free America."
