- 7 SECTION 102. DEFINITIONS.
- 8 THE FOLLOWING WORDS AND PHRASES WHEN USED IN THIS ACT SHALL
- 9 HAVE THE MEANINGS GIVEN TO THEM IN THIS SECTION UNLESS THE
- 10 CONTEXT CLEARLY INDICATES OTHERWISE:

- 17 OR MANAGEMENT AFFAIRS OF A MUNICIPAL RETIREMENT SYSTEM, OR THE
- 18 DESIGNEE OF THAT PERSON.
- 19 "FIREFIGHTER." A MUNICIPAL EMPLOYEE WHO HOLDS A FULL-TIME
- 20 POSITION IN THE FIREFIGHTING SERVICE OF A MUNICIPALITY AND HAS
- 21 RETIREMENT COVERAGE PROVIDED BY A RETIREMENT SYSTEM.
- 22 "MUNICIPALITY." A BOROUGH, CITY, COUNTY OF THE SECOND CLASS,
- 23 INCORPORATED TOWN OR TOWNSHIP, HOWEVER CONSTITUTED, WHETHER
- 24 OPERATING UNDER A LEGISLATIVE CHARTER; A MUNICIPAL CODE; AN
- 25 OPTIONAL CHARTER ADOPTED UNDER THE ACT OF JULY 15, 1957
- 26 (P.L.901, NO.399), KNOWN AS THE OPTIONAL THIRD CLASS CITY
- 27 CHARTER LAW; A HOME RULE CHARTER OR AN OPTIONAL PLAN ADOPTED
- 28 UNDER THE ACT OF APRIL 13, 1972 (P.L.184, NO.62), KNOWN AS THE
- 29 HOME RULE CHARTER AND OPTIONAL PLANS LAW; OR OTHER ARRANGEMENT;
- 30 OR AN ASSOCIATION OF THESE MUNICIPALITIES COOPERATING UNDER THE

- 3 "POLICE OFFICER." A MUNICIPAL EMPLOYEE WHO HOLDS A FULL-TIME
- 4 POSITION IN THE POLICE SERVICE OF A MUNICIPALITY AND HAS
- 5 RETIREMENT COVERAGE PROVIDED BY A RETIREMENT SYSTEM.
- 6 "POSTRETIREMENT ADJUSTMENT." AN INCREASE IN OR CHANGE IN THE
- 7 AMOUNT OF A RETIREMENT ANNUITY, RETIREMENT BENEFIT, SERVICE
- 8 PENSION OR DISABILITY PENSION BENEFIT GRANTED OR EFFECTIVE AFTER
- 9 ACTIVE EMPLOYMENT CEASES.
- 10 "PUBLIC EMPLOYEE RETIREMENT SYSTEM." AN ENTITY, WHETHER A
- 11 SEPARATE ENTITY OR PART OF A GOVERNMENTAL ENTITY, THAT COLLECTS
- 12 RETIREMENT AND OTHER EMPLOYEE BENEFIT CONTRIBUTIONS FROM
- 13 GOVERNMENT EMPLOYEES AND EMPLOYERS; HOLDS AND MANAGES THE
- 14 RESULTING ASSETS AS RESERVES FOR PRESENT AND FUTURE RETIREMENT
- 15 ANNUITY, RETIREMENT BENEFIT, SERVICE PENSION, OR DISABILITY
- 16 PENSION BENEFIT PAYMENTS; AND MAKES PROVISION FOR THESE PAYMENTS
- 17 TO QUALIFIED RETIREES AND BENEFICIARIES.
- 18 "RETIREMENT SYSTEM." A PUBLIC EMPLOYEE RETIREMENT SYSTEM.
- 19 "SPECIAL AD HOC ADJUSTMENT." A SPECIAL AD HOC MUNICIPAL
- 20 POLICE AND FIREFIGHTER POSTRETIREMENT ADJUSTMENT.
- 21 "SPECIAL AD HOC MUNICIPAL POLICE AND FIREFIGHTER
- 22 POSTRETIREMENT ADJUSTMENT." AN INCREASE IN OR CHANGE IN THE

- 5 (1) THE RETIREE HAS TERMINATED ACTIVE EMPLOYMENT WITH

- 10 ACTIVE EMPLOYMENT WITH A MUNICIPALITY AS A POLICE OFFICER OR

- 12 (3) THE RETIREE BEGAN RECEIVING THE RETIREMENT ANNUITY,
- 13 RETIREMENT BENEFIT, SERVICE PENSION OR DISABILITY PENSION

- 15 SECTION 302. AMOUNT OF SPECIAL AD HOC ADJUSTMENT.
- 16 (A) GENERAL RULE. -- EXCEPT AS PROVIDED IN SUBSECTIONS (B) AND
- 17 (C), A MUNICIPAL RETIREMENT SYSTEM SHALL PAY A RETIRED POLICE

- 21 MISCELLANEOUS PROVISIONS
- 22 SECTION 1101. LIMITATION OF PRIOR ACT.
- 23 THE PROVISIONS OF SECTION 7 OF THE ACT OF JULY 9, 1981
- 24 (P.L.208, NO.66), KNOWN AS THE PUBLIC EMPLOYEE RETIREMENT STUDY
- 25 COMMISSION ACT, SHALL NOT BE APPLIED TO THIS ACT.
- 26 SECTION 1102. REPEALS.
- 27 ALL ACTS AND PARTS OF ACTS ARE REPEALED INSOFAR AS THEY ARE

- SECTION 1103. EFFECTIVE DATE. 29
- 30 THIS ACT SHALL TAKE EFFECT IN 60 DAYS.
