## AN ACT

- Amending the act of July 7, 1980 (P.L.380, No.97), entitled "An 2 act providing for the planning and regulation of solid waste 3 storage, collection, transportation, processing, treatment, 4 and disposal; requiring municipalities to submit plans for 5 municipal waste management systems in their jurisdictions; authorizing grants to municipalities; providing regulation of 7 the management of municipal, residual and hazardous waste; requiring permits for operating hazardous waste and solid 8 9 waste storage, processing, treatment, and disposal 10 facilities; and licenses for transportation of hazardous 11 waste; imposing duties on persons and municipalities; 12 granting powers to municipalities; authorizing the 13 Environmental Quality Board and the Department of 14 Environmental Resources to adopt rules, regulations, 15 standards and procedures; granting powers to and imposing duties upon county health departments; providing remedies; 16 prescribing penalties; and establishing a fund, " providing 17 for the licensure of persons transporting sewage sludge; and 18 19 requiring prior approval of disposal sites.
- 20 The General Assembly of the Commonwealth of Pennsylvania
- 21 hereby enacts as follows:
- 22 Section 1. Section 501 of the act of July 7, 1980 (P.L.380,
- 23 No.97), known as the Solid Waste Management Act, is amended by
- 24 adding a subsection to read:
- 25 Section 501. Permits and licenses required; transition scheme;

- 1 reporting requirements.
- 2 \* \* \*
- 3 (b.1) It shall be unlawful for any person to transport
- 4 <u>sewage sludge for treatment or disposal unless the person has</u>
- 5 <u>first obtained a license from the department to conduct such</u>
- 6 transportation activities. A condition for licensure shall be
- 7 that the person submit evidence satisfactory to the department
- 8 that he has a site, approved by the department, for disposal of
- 9 the sludge. The site so designated shall be the sole site for
- 10 <u>disposal of the sludge unless the person gives prior notice to</u>
- 11 and receives the approval of the department to dispose of the
- 12 <u>sewage sludge at another site</u>, for which a permit for disposal
- or application of sewage sludge has been issued.

- 15 Section 2. This act shall take effect in 60 days.
