AN ACT

- Amending the act of July 1, 1981 (P.L.191, No.57), entitled "An act establishing certain fees to be charged by registers of 3 wills in counties of the fifth, sixth, seventh and eighth class and providing for fees in counties of the second, second A, third and fourth class, "fixing the fees to be levied by register of wills in counties of the second through 7 fourth class. 8 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 10 Section 1. Section 2 of the act of July 1, 1981 (P.L.191, 11 No.57), entitled "An act establishing certain fees to be charged 12 by registers of wills in counties of the fifth, sixth, seventh 13 and eighth class and providing for fees in counties of the second, second A, third and fourth class," is amended to read: 14 15 Section 2.
