REFERRED TO COMMITTEE ON STATE GOVERNMENT, SEPTEMBER 26, 1989

AN ACT

1 Authorizing and directing the Department of General Services,
2 with the approval of the Governor and the Secretary of
3 Environmental Resources, to convey to Morris Township a road
4 situate in Morris Township, Tioga County, Pennsylvania.

5 The General Assembly of the Commonwealth of Pennsylvania
6 hereby enacts as follows:

7 Section 1. The Department of General Services, with the
8 approval of the Governor and the Secretary of Environmental
9 Resources, is hereby authorized and directed on behalf of the
10 Commonwealth of Pennsylvania to grant and convey to Morris
11 Township the following road (known as Love Hollow Road) situate
12 in Morris Township, Tioga County, Pennsylvania, bounded and
13 described as follows:

14 Beginning on the existing center line of the Wilson Hill Road
15 T-460 at the intersection of the Love Hollow Road within lands
16 of Amos B. Witmer; thence by the existing center line of the
17 Love Hollow Road by lands of Amos B. Witmer north 76 degrees 54
18 minutes 50 seconds east 104.59 feet to a point on the existing
19 center line of the Love Hollow Road at the common boundary of

1 lands of Amos B. Witmer and lands of the Department of
2 Environmental Resources; thence by the existing center line of
3 the said Love Hollow Road the following 24 courses and distances
4 within lands of the Department of Environmental Resources:

5 (1) south 85 degrees 28 minutes 01 second east a distance of
6 60.08 feet;

7 (2) south 45 degrees 12 minutes 08 seconds east a distance
8 of 118.20 feet;

26 by the existing center line of the said Love Hollow Road by
27 lands of Joseph P. Magness and Carl Levan the following four
28 courses and distances:

7 to a point on the existing center line of the Love Hollow Road

10 Love Hollow Road by lands of Carl Levan and lands of Brian J.
11 Magness the following four courses and distances:

12 (1) south 81 degrees 07 minutes 22 seconds east a distance
13 of 53.04 feet;

14 (2) north 47 degrees 54 minutes 25 seconds east a distance
15 of 85.32 feet;

16 (3) north 25 degrees 15 minutes 27 seconds east a distance

18 (4) north 08 degrees 27 minutes 56 seconds west a distance
19 of 25.23 feet;

20 to a point on the existing center line of the Love Hollow Road
21 at the common boundary of lands aforementioned and the
22 Department of Environmental Resources; thence by the existing
23 center line of the said Love Hollow Road within lands of the
24 Department of Environmental Resources the following 28 courses
25 and distances:

24 being the northerly terminus of Love Hollow Road. Having a total
25 distance of 7768.6 feet.

26 Section 2. The conveyance shall be made under and subject to
27 all easements, servitudes and rights of others, including, but
28 not confined to, rights of telephone, telegraph, water,
29 electric, sewer, gas or pipeline companies, as well as under and
30 subject to any interest, estates or tenancies vested in third

1 persons, whether or not appearing of record, for any portion of
2 the land.

3 Section 3. The deed of conveyance shall contain a clause
4 that the property conveyed shall be used for public purposes by
5 Morris Township and if at any time Morris Township or its
6 successor conveys the property or permits the property to be
7 used for any purpose other than those specified in this section,
8 the title to the property shall immediately revert to and revest
9 in the Commonwealth of Pennsylvania.

10 Section 4. The deed of conveyance shall be approved as
11 provided by law and shall be executed by the Secretary of
12 General Services in the name of the Commonwealth of
13 Pennsylvania.

14 Section 5. Costs and fees incidental to the conveyance shall
15 be borne by the grantee.

16 Section 6. This act shall take effect immediately.
