AN ACT

- 1 Amending the act of February 1, 1966 (1965 P.L.1656, No.581),
- 2 entitled "An act concerning boroughs, and revising, amending
- and consolidating the law relating to boroughs, " further
- 4 providing for certain reimbursement.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Sections 701 and 702 of the act of February 1,
- 8 1966 (1965 P.L.1656, No.581), known as The Borough Code, amended
- 9 January 28, 1988 (P.L.21, No.10), are amended to read:
- 10 Section 701. State Association of Boroughs. -- (a) The
- 11 boroughs of the Commonwealth are authorized to organize a State
- 12 Association of Boroughs for the purpose of advancing the
- 13 interests of the boroughs. Any borough may join the said
- 14 association by motion of council and payment of the annual dues.
- 15 Council may designate one or more delegates from the elected or
- 16 appointed officials of the borough to attend the annual meeting
- 17 of the association, which shall be held in the Commonwealth in
- 18 accordance with the procedure adopted by the association. In
- 19 addition to any compensation allowed by law for each delegate,

- 1 the borough may, for each delegate, pay expenses which shall be
- 2 limited to the registration fee, mileage for use of personal
- 3 vehicle or reimbursement of actual transportation expense going
- 4 to and returning from such meeting plus all other actual
- 5 expenses that the council may have agreed to pay. Every delegate
- 6 attending the annual meeting shall submit to the council an
- 7 itemized account of expenses incurred thereat. The council may
- 8 authorize borough employes to be compensated at their regular
- 9 employe rate during their attendance at the annual meeting. The
- 10 borough council solely may authorize council members who are not
- 11 employed by the borough to receive reimbursement for lost wages
- 12 or salary while attending the annual meeting. However,
- 13 <u>sufficient documentation of such wages or salary must be</u>
- 14 provided to the borough council to justify said reimbursement.
- 15 The time spent in attending said meeting shall not be more than
- 16 four days, including the time employed in traveling thereto and
- 17 therefrom. Each borough, becoming a member of the association,
- 18 shall pay such reasonable dues as may be fixed by the
- 19 association.
- 20 (b) The dues and other revenues received by the association
- 21 shall be used to pay for services, publications and other
- 22 expenses authorized or ratified by the association, or incurred
- 23 in behalf of the association, by its officers and committees.
- 24 Section 702. County and Regional Associations of Boroughs.--
- 25 The boroughs of any county or of two or more adjoining or nearby
- 26 counties, may organize a county or regional association of
- 27 boroughs, composed of elected and appointed borough officials in
- 28 such county or counties, organized for the purpose of furthering
- 29 the interests of the boroughs in the association and their
- 30 inhabitants. Any borough may annually appropriate a sum of

- 1 money, not exceeding seventy-five dollars (\$75) for the support
- 2 of such association. For attendance at a meeting of the county
- 3 or regional association of which such borough is a member, the
- 4 borough may, for each delegate, pay expenses which shall be
- 5 limited to the registration fee, mileage for use of personal
- 6 vehicle or reimbursement of actual transportation expense going
- 7 to and returning from such meeting plus all other actual
- 8 expenses that the council may have agreed to pay. Every delegate
- 9 attending the annual meeting shall submit to the council an
- 10 itemized account of expenses incurred thereat. The council may
- 11 authorize borough employes to be compensated at their regular
- 12 employe rate during their attendance at the annual meeting. The
- 13 borough council solely may authorize council members who are not
- 14 employed by the borough to receive reimbursement for lost wages
- 15 or salary while attending the annual meeting. However,
- 16 <u>sufficient documentation of such wages or salary must be</u>
- 17 provided to the borough council to justify said reimbursement.
- 18 Any such county or regional association of boroughs shall have
- 19 the option of admitting to membership representatives of
- 20 political subdivisions other than boroughs within such county or
- 21 counties but representatives of such other political
- 22 subdivisions shall have no voice or vote in any matter that is
- 23 or may be of concern solely to boroughs.
- 24 Section 2. This act shall take effect in 60 days.
