AN ACT

- 1 Providing for the licensing of professional home inspectors;
- 2 granting powers to and imposing duties on the Secretary of
- 3 Labor and Industry; and providing a civil penalty.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Short title.
- 7 This act shall be known and may be cited as the Professional
- 8 Home Inspector Licensure Act.
- 9 Section 2. Definitions.
- 10 The following words and phrases when used in this act shall
- 11 have the meanings given to them in this section unless the
- 12 context clearly indicates otherwise:
- 13 "Associate home inspector." A person who is employed by a
- 14 licensed professional home inspector to conduct inspections of
- 15 residential homes or buildings on behalf of the professional
- 16 home inspector.
- 17 "Professional home inspector." A person who, for

- 1 compensation, engages in the business of inspecting residential
- 2 homes or buildings for buyers or others.
- 3 "Secretary." The Secretary of Labor and Industry of the
- 4 Commonwealth.
- 5 Section 3. Professional home inspector to be licensed.
- 6 (a) System established.--The secretary shall establish a
- 7 system for the licensure of professional home inspectors.
- 8 (b) License requirement. -- No person may engage in the
- 9 business of home inspections, either part-time or full-time, or
- 10 in any other manner act as a professional home inspector or
- 11 associate home inspector unless the person is licensed by the
- 12 secretary.
- 13 (c) Application. -- A professional home inspector or associate
- 14 home inspector shall be licensed by the secretary upon
- 15 submission of an application and payment of a reasonable
- 16 application fee sufficient to cover the cost of implementing the
- 17 provisions of this act. The fee shall be prescribed by the
- 18 secretary.
- 19 (d) Renewals.--The secretary may require biennial renewal of
- 20 application for licensure and may stagger the renewal dates and
- 21 adjust the application fees accordingly.
- 22 Section 4. Application for professional home inspector license.
- 23 (a) License criteria. -- The secretary shall establish the
- 24 criteria for the granting of a license. The applicant for a
- 25 professional home inspector's license shall, as a condition
- 26 precedent to obtaining a license, take a licensing examination
- 27 as prescribed by the secretary, and score a passing grade. Prior
- 28 to taking the examination:
- 29 (1) The applicant shall:
- 30 (i) be at least 21 years of age; and

- 1 (ii) be a high school graduate or produce proof
- 2 satisfactory to the secretary of an education equivalent
- 3 thereto; and
- 4 (2) The applicant shall:
- 5 (i) have been engaged as a licensed associate home
- 6 inspector for at least two years and have completed 250
- 7 fee-paid inspections; or
- 8 (ii) possess educational or experience
- 9 qualifications which the secretary deems to be the
- 10 equivalent of the qualifications listed in subparagraph
- 11 (i). If this subparagraph is used as the basis for
- 12 licensing, an equivalency examination shall be
- administered by the secretary and a passing grade shall
- 14 be required.
- 15 (b) Written application. -- An application for a license as a
- 16 professional home inspector shall be made in writing, to the
- 17 secretary, upon a form provided for the purpose by the
- 18 secretary, and shall contain such information concerning the
- 19 applicant as the secretary shall require.
- 20 (c) Place of business. -- The application shall state the
- 21 place of business for which the license is desired.
- 22 (d) Time for submission.--The application must be received
- 23 by the secretary within three years of the date upon which the
- 24 applicant took the examination.
- 25 Section 5. Application for associate home inspector license.
- 26 (a) Examination required.--Each applicant shall, as a
- 27 condition precedent to obtaining a license, take the associate
- 28 home inspector's license examination and score a passing grade.
- 29 Prior to taking the examination, the applicant shall be at least
- 30 21 years of age.

- 1 (b) Written application. -- An application for a license as an
- 2 associate home inspector shall be made in writing, to the
- 3 secretary, upon a form provided for the purpose by the
- 4 secretary, and shall contain such information concerning the
- 5 applicant as the secretary shall require.
- 6 (c) Sworn statement. -- The applicant shall submit a sworn
- 7 statement by the professional home inspector with whom he
- 8 desires to be affiliated certifying that the professional home
- 9 inspector will actively supervise and train the applicant.
- 10 (d) Time for submission.--The application must be received
- 11 by the secretary within three years of the date upon which the
- 12 applicant took the examination.
- 13 Section 6. Exceptions.
- 14 (a) Eligibility for professional home inspector's license.--
- 15 (1) A person who has engaged in the business of home
- inspections for a minimum of one year prior to the effective
- 17 date of this act and has conducted at least 250 fee-paid
- inspections, and who successfully completes the written
- 19 examination to be administered by the secretary, shall be
- 20 eligible to apply for a professional home inspector's
- 21 license.
- 22 (2) Any registered professional engineer in this
- 23 Commonwealth who has at least 20 years of related working
- 24 experience in design and inspection for residential or
- commercial construction shall be eligible to apply for and
- 26 receive a professional home inspector's license.
- 27 (3) Any person who holds a current building inspection
- 28 certification from the Pennsylvania Building Officials
- 29 Conference shall be eligible to apply for and receive a
- 30 professional home inspector's license.

- 1 (b) Exemption.--A person eligible for licensing under
- 2 subsection (a) shall be exempt from the provisions of this act
- 3 relating to associate home inspectors.
- 4 (c) Duration of exception.--Subsection(a)(1) shall remain in
- 5 effect for a period of three years after the effective date of
- 6 this act.
- 7 Section 7. Secretary to investigate.
- 8 The secretary shall, on his initiative or in response to
- 9 complaints, investigate on a continuous basis allegations of
- 10 violations of this act and gather evidence of violations of this
- 11 act or any regulation adopted under this act.
- 12 Section 8. Grounds for fines or revocations.
- 13 The secretary may fine or refuse to grant or may suspend or
- 14 revoke a license of a professional home inspector for any of the
- 15 following acts or omissions related to the conduct of the
- 16 business of inspecting residential homes or buildings:
- 17 (1) Making or authorizing any material statement,
- written or oral, which is known to be untrue or misleading.
- 19 (2) Failing to carry appropriate general liability and
- 20 professional liability insurance policies providing coverage
- 21 for negligent acts.
- 22 (3) Expressing an opinion not based on practical
- 23 experience and honest conviction.
- 24 (4) Acting in bad faith toward a client.
- 25 (5) Disclosing any information concerning the results of
- 26 an inspection without first obtaining the approval of the
- 27 client for whom the inspection was performed.
- 28 (6) Accepting compensation, monetary or otherwise, from
- 29 more than one interested party for the same service without
- first obtaining the consent of all interested parties.

- 1 (7) Accepting or offering commissions or allowances,
- directly or indirectly, from other parties dealing with his
- 3 client in connection with work for which the professional
- 4 home inspector is responsible.
- 5 (8) Failing to promptly disclose to a client any
- 6 interest in a business that may affect the client.
- 7 (9) Allowing an interest in a business other than home
- 8 inspection to affect the quality or result of an inspection.
- 9 (10) Using a home inspection as a vehicle to obtain
- 10 additional work in another field.
- 11 (11) Attempting to appraise or express an opinion
- 12 concerning the market value of any property under inspection.
- 13 (12) Engaging in a pattern of conduct which includes any
- of the acts or omissions prohibited in this section or any
- other unconscionable or fraudulent commercial practice
- prohibited by the secretary pursuant to regulations
- 17 promulgated under this act.
- 18 Section 9. Notice to be given.
- 19 Upon refusal to grant a license or upon suspension or
- 20 revocation of a license issued to a professional home inspector,
- 21 the secretary shall notify the professional home inspector, in
- 22 writing, by certified mail. The person shall be given a hearing
- 23 by a review board if, within 60 days after receipt of notice, he
- 24 files with the secretary a written request for a hearing.
- 25 Section 10. Review board.
- The review board for the hearings provided for in section 9
- 27 shall be convened and appointed by the secretary when necessary
- 28 and shall consist of one professional home inspector, one lay
- 29 person and the secretary. Appointments to the review board shall
- 30 be rotated to prevent any indication of permanent appointment.

- 1 Section 11. Civil penalties.
- 2 The secretary may impose upon a professional home inspector
- 3 who violates this act a civil penalty of not more than \$2,000
- 4 for the first offense and not more than \$5,000 for the second
- 5 and each subsequent offense. The civil penalty shall be issued
- 6 for and recovered by and in the name of the secretary and shall
- 7 be collected and enforced by summary proceedings.
- 8 Section 12. Rules and regulations.
- 9 The secretary shall promulgate rules and regulations to
- 10 administer and enforce this act.
- 11 Section 13. Effective date.
- 12 This act shall take effect in 90 days.
