AN ACT

- 1 Amending Title 75 (Vehicles) of the Pennsylvania Consolidated
- 2 Statutes, further providing for the installation and
- 3 maintenance of Emergency Call Box Systems along interstate
- 4 highways and turnpikes.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Section 6115 of Title 75 of the Pennsylvania
- 8 Consolidated Statutes is amended to read:
- 9 § 6115. [Emergency telephones along Pennsylvania Turnpike.]
- 10 Emergency Call Box Systems along interstate highways
- 11 <u>and turnpikes.</u>
- 12 [The Pennsylvania Turnpike Commission shall provide for the
- 13 installation and maintenance of an emergency telephone along
- 14 every two miles on both sides of the highway along a 50-mile
- 15 stretch of the Pennsylvania Turnpike between Exits 8 and 11.
- 16 These emergency telephones shall be kept in operation for one

- 1 year on a test basis, after which the commission shall report to
- 2 the General Assembly its findings as to the use of the equipment
- 3 and the cost of maintaining it. This report shall be the basis
- 4 for a final decision as to whether emergency telephones should
- 5 be installed and maintained along the entire Pennsylvania
- 6 Turnpike and its extensions.]
- 7 (a) Interstate highways.--The department shall provide for
- 8 the installation and maintenance of the Emergency Call Box
- 9 System along the interstate highways utilizing 90% Federal
- 10 <u>funding and 10% State funding.</u>
- 11 (b) Turnpikes.--The Pennsylvania Turnpike Commission shall
- 12 provide for the installation and maintenance of the Emergency
- 13 <u>Call Box System along the turnpikes.</u>
- 14 (c) Spacing. -- The Emergency Call Box Systems spacing shall
- 15 be 1/2 mile between call boxes on both sides of the interstate
- 16 highways and turnpikes as recommended by the National Highway
- 17 Research Board.
- (d) Compatibility. -- The Emergency Call Box Systems shall be
- 19 compatible with the existing Pennsylvania Turnpike system.
- 20 Section 2. The Department of Transportation is ordered to
- 21 select the initial projects and implement the same within 90
- 22 days of the enactment date of this act.
- 23 Section 3. This act shall take effect immediately.
