## AN ACT

- Amending the act of March 1, 1974 (P.L.90, No.24), entitled "An 2 act relating to the labeling, distribution, storage, transportation, use, application and disposal of pesticides 3 4 and devices; providing for registration and examination of 5 such materials; the licensing of pesticide dealers and pest management consultants and imposing penalties, " regulating 6 the application of pesticides by the Department of 7 8 Transportation; and further providing for prohibited acts. 9 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 10 11 Section 1. Section 8 of the act of March 1, 1974 (P.L.90, No.24), known as the Pennsylvania Pesticide Control Act of 1973, 12 13 is amended by adding a subsection to read: 14 Section 8. Prohibited Acts. -- \* \* \* (u) No person shall remove, alter or deface, or conspire 15 16 with another person to remove, alter or deface, a sign posted 17 under section 18.1.
- 19 Section 18.1. Application of Pesticides by Department of

Section 2. The act is amended by adding a section to read:

- 1 <u>Transportation.--(a)</u> The Department of Transportation or its
- 2 <u>contracted pesticide applicators shall inform all roadside</u>
- 3 property owners, both resident and nonresident, of a proposed
- 4 application of a pesticide along their property at least thirty
- 5 <u>days prior to the proposed application</u>.
- 6 (1) The notification shall include the date and time of the
- 7 spraying, the names of the pesticides to be used and the
- 8 telephone number of the district roadside management specialist.
- 9 (2) The notification shall be either by certified mail or by
- 10 personal notification. If personal notification is used, the
- 11 Department of Transportation must secure a signature from the
- 12 property owner, indicating that the property owner was informed.
- 13 (3) A property owner shall have the right to prohibit the
- 14 application of pesticides within one thousand feet of his
- 15 property, and a resident shall have the right to prohibit the
- 16 <u>application of pesticides within one thousand feet of his</u>
- 17 residence.
- 18 (i) Prohibition of the application of pesticides under this
- 19 clause shall be effected by notice to the Department of
- 20 Transportation's district roadside management specialist not
- 21 <u>less than ten days prior to the scheduled application.</u>
- 22 (ii) The department's notification to owners and residents
- 23 shall explain their right to prohibit pesticide application
- 24 <u>under this clause.</u>
- 25 (iii) The district roadside management specialist shall
- 26 <u>maintain a registry of all owners and residents who have</u>
- 27 prohibited application of pesticides under this clause. Prior to
- 28 applying pesticides, personnel of the Department of
- 29 <u>Transportation or its contracted applicators shall consult the</u>
- 30 registry to determine where pesticide application is prohibited.

- 1 (iv) Roadside maintenance along areas where the use of
- 2 pesticides has been prohibited under this clause shall make use
- 3 <u>of nonchemical management methods</u>.
- 4 (4) Any change in the date and time of a proposed
- 5 application of pesticides by the Department of Transportation or
- 6 its contracted applicators must conform to the notification
- 7 requirements of this subsection.
- 8 (b) The Department of Transportation shall post signs along
- 9 roadways that are scheduled to be sprayed no later than forty-
- 10 eight hours prior to the proposed spraying application.
- 11 (1) The signs shall be not less than eighteen inches by
- 12 twenty-four inches in size and shall contain the words "PennDOT
- 13 <u>Chemical Pesticide Spray Area."</u>
- 14 (2) Signs shall be placed at one-half-mile intervals along
- 15 the roadside which is scheduled for pesticide spraying.
- 16 (3) The first and last sign sites along the roadway to be
- 17 sprayed shall include an additional sign, listing a telephone
- 18 number for public information, the names of the pesticides to be
- 19 used and the date and time of the proposed spraying.
- 20 (4) Each sign will remain in place for no less than ten days
- 21 <u>following a chemical pesticide application.</u>
- 22 (c) (1) The Department of Transportation and its contracted
- 23 applicators shall have their spray vehicles posted with signs
- 24 containing the words "Chemical Pesticide Spraying Vehicle" in
- 25 letters no less than two inches in height. The signs shall be
- 26 posted on both sides of the vehicle.
- 27 (2) Each chemical pesticide spray vehicle and vehicles
- 28 transporting pesticides shall have the name of the chemicals
- 29 being used or transported clearly displayed on the dashboard of
- 30 the vehicle in order to enable emergency personnel to take

- 1 proper action in the event of an accident or leakage.
- 2 (d) No pesticide shall be applied unless it has a clearly
- 3 perceptible odor. The odor may either be from the pesticide
- 4 <u>itself or from one of the inert ingredients.</u>
- 5 (e) (1) No pesticide shall be applied within one thousand
- 6 feet of a lake, creek, stream, river or wetlands.
- 7 (2) No pesticide shall be applied within one thousand feet
- 8 of a household, school, institution, commercial business or
- 9 <u>publicly owned property.</u>
- 10 (3) No pesticide shall be applied within one thousand feet
- 11 of a domestic animal pasture, hayfield or crop field.
- 12 (4) Pesticides shall not be applied on days when wind
- 13 conditions cause drift from the boundaries of the target
- 14 roadside property or whenever wind speed is in excess of three
- 15 <u>miles per hour.</u>
- 16 (5) Pesticide spray vehicles shall not travel more than five
- 17 miles per hour to prevent wind drift from the motion of the
- 18 vehicle or its possible combination with natural wind drift.
- 19 (6) Pesticides shall not be mixed or combined for spraying.
- 20 A minimum ten-day period must elapse before application of a
- 21 second pesticide in an area where a pesticide has been applied.
- 22 (f) (1) Pesticide manufacturers shall provide the secretary
- 23 with a list of the active and inactive, or inert, ingredients of
- 24 <u>all pesticides used by the Department of Transportation and its</u>
- 25 <u>contracted applicators</u>.
- 26 (2) All information filed with the secretary relating to the
- 27 registration of pesticides, as provided for in this act, shall
- 28 be made available to the public to the extent that, in the
- 29 judgment of the secretary, the information will not reveal a
- 30 trade secret, as protected under this act. In addition, any

- 1 person shall have the right to receive the material safety data
- 2 sheet, as defined in section 2 of the act of October 5, 1984
- 3 (P.L.734, No.159), known as the Worker and Community Right-to-
- 4 Know Act, or a copy of the label for any chemical to which he
- 5 <u>may have been exposed</u>.
- 6 (3) A physician shall be able to obtain from the secretary a
- 7 <u>list of the active and inactive, or inert, ingredients when</u>
- 8 pesticide poisoning has occurred. The list will be provided to
- 9 facilitate treatment and not to violate trade secret
- 10 <u>information</u>.
- 11 (4) A Department of Transportation district roadside
- 12 management specialist shall not expend funds for roadside
- 13 spraying of pesticides without first providing a detailed cost
- 14 <u>analysis of all of the various alternatives to pesticide</u>
- 15 spraying for roadside management pertinent to his district which
- 16 <u>clearly indicates that roadside pesticide spraying is more cost</u>
- 17 effective than any of the various alternatives for roadside
- 18 management. The cost analysis shall include all of the
- 19 alternatives -- organic, biological and mechanical -- and shall
- 20 include a copy of the "Integrated Pest Management Plan"
- 21 pertinent to his district.
- 22 Section 3. This act shall take effect in 60 days.
