7	The General Assembly of the Commonwealth of Pennsylvania
8	hereby enacts as follows:
9	Section 1. The act of March 10, 1949 (P.L.30, No.14), known
10	as the Public School Code of 1949, is amended by adding a
11	section to read:
12	Section 1368. Drug and Alcohol Testing Program(a) The
13	Secretary of Education shall, in the interest of pupil safety,
14	promulgate regulations within eighteen (18) months after the
15	effective date of this section to establish a program to require
16	school districts to conduct preemployment, periodic recurring,
17	random and post-accident testing of school bus drivers, to
18	determine if the school bus drivers have used alcohol or

1 controlled substances in violation of the regulations or the

2 <u>law.</u>

3 (b) The regulations shall:

- 4 (1) Develop minimum drug and alcohol thresholds which would
 5 indicate impairment of faculties.
- 6 (2) Determine what types of tests are appropriate to detect
 7 violations of the regulations or the law.
- 8 (3) Provide that a test which indicates the use by a school 9 bus driver of alcohol or a controlled substance in violation of 10 the regulations or the law shall be confirmed by a second test,
- 11 and that the second test shall, if appropriate, be of a higher
- 12 laboratory quality than the first.
- 13 (4) Require that all school bus drivers in this Commonwealth
- 14 be tested at least every six (6) months for the use of alcohol
- 15 or controlled substances in violation of the regulations or the
- 16 <u>law.</u>
- 17 (5) Develop guidelines for the disqualification, suspension

18 or dismissal of school bus drivers for violation of the

- 19 regulations or the law.
- 20 (c) As used in this section, the term "school bus driver"
- 21 means a person who drives either a school conveyance or a
- 22 private conveyance under contract for the transportation of
- 23 pupils to and from school.
- 24 Section 2. This act shall take effect in 60 days.
