## AN ACT

- 1 Amending Title 75 (Vehicles) of the Pennsylvania Consolidated
- 2 Statutes, further providing for the use of registration
- 3 plates issued to manufacturers and dealers.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Section 102 of Title 75 of the Pennsylvania
- 7 Consolidated Statutes is amended by adding a definition to read:
- 8 § 102. Definitions.
- 9 Subject to additional definitions contained in subsequent
- 10 provisions of this title which are applicable to specific
- 11 provisions of this title, the following words and phrases when
- 12 used in this title shall have, unless the context clearly
- 13 indicates otherwise, the meanings given to them in this section:
- 14 \* \* \*
- 15 <u>"Farm equipment." A vehicle designed or used exclusively for</u>
- 16 agricultural operations and only incidentally operated or moved
- 17 upon highways, including, but not limited to, farm tractors,

- 1 choppers and balers.
- 2 \* \* \*
- 3 Section 2. Section 1335(c) of Title 75 is amended and the
- 4 section is amended by adding a subsection to read:
- 5 § 1335. Registration plates for manufacturers and dealers.
- 6 \* \* \*
- 7 (a.2) Exemption. -- The following types of dealers and
- 8 manufacturers are exempt from posting of the bond specified in
- 9 subsection (a):
- 10 <u>(1) Farm equipment dealers.</u>
- 11 (2) Mobile home dealers.
- 12 (3) Modular housing manufacturers.
- 13 \* \* \*
- 14 (c) Exemption from individual registration. -- Vehicles
- 15 displaying dealer registration plates may be operated on the
- 16 highway without registering each vehicle individually, provided
- 17 that the plates are used in accordance with the limitations of
- 18 [section] sections 1336 (relating to use of dealer registration
- 19 plates) and 1337.1 (relating to use of multipurpose dealer
- 20 <u>registration plates</u>).

- 22 Section 3. Section 1336 of Title 75 is amended to read:
- 23 § 1336. Use of dealer registration plates.
- 24 (a) General rule.--
- 25 (1) Dealer registration plates may be used on any
- vehicle owned or in possession of a dealer or manufacturer,
- 27 but only if the vehicle is being held for sale[, is]. The
- 28 <u>vehicle shall be</u> unladen except for safety equipment, jumper
- 29 cables and similar items [or is being used for any of the
- 30 following purposes:

- 1 (1) For the personal use of the dealer or members of his
- 2 immediate family, or when the dealer is a corporation, for
- 3 the personal use of the officers or members of their
- 4 immediate families, or for the personal use of the regular
- 5 employees of the dealer.] and must be in transit to or from a
- 6 <u>location from which it is purchased or offered for sale.</u>
- 7 (2) The vehicle may be used laden for any of the
- 8 <u>following purposes:</u>
- 9 [(2)] <u>(i)</u> For teaching students enrolled in an approved
- driver education course how to operate a vehicle and for the
- 11 new driver to take an examination for a driver's license.
- [(3)] (ii) For testing vehicles in the possession of the
- dealer or manufacturer.
- [(4)] <u>(iii)</u> For demonstrating vehicles in the possession
- of the dealer or manufacturer.
- [(5)] <u>(iv)</u> For loaning to customers whose vehicles are
- 17 being repaired.
- [(6)] <u>(v)</u> For loaning to prospective purchasers for a
- 19 period not exceeding five days for the purpose of
- 20 demonstrating vehicles.
- 21 (b) Records. -- Records shall be kept by the dealer in a
- 22 manner prescribed by the department indicating which vehicles
- 23 have been used as provided in subsection [(a)(2), (5) and (6)]
- 24 (a)(2)(i), (iv) and (v). The records shall be open to inspection
- 25 by representatives of the department and police officers.
- 26 (c) Nonapplicability. -- The provisions of this section shall
- 27 not apply to work or service vehicles owned by a manufacturer or
- 28 <u>dealer</u>.
- 29 Section 4. Title 75 is amended by adding a section to read:
- 30 § 1337.1. Use of multipurpose dealer registration plates.

- 1 Subject to the requirement that the vehicles on which
- 2 <u>multipurpose dealer registration plates conform to the weight</u>
- 3 and size limits for which the plates were purchased, the
- 4 <u>multipurpose dealer registration plates may be used on motor</u>
- 5 <u>vehicles owned by or in possession of a dealer or manufacturer.</u>
- 6 Section 5. Section 1926 of Title 75 is amended by adding a
- 7 subsection to read:
- 8 § 1926. Dealers and miscellaneous motor vehicle business.
- 9 \* \* \*
- 10 (d) Multipurpose dealer registration plate. -- The annual fee
- 11 for a multipurpose dealer registration plate shall be \$24 for
- 12 passenger cars, the appropriate fee specified in section 1913
- 13 (relating to motor homes) for motor homes and the appropriate
- 14 fee specified in section 1916 (relating to trucks and truck
- 15 <u>tractors</u>) for trucks and truck tractors.
- 16 Section 6. Section 2306 of Title 75 is amended to read:
- 17 § 2306. Exemptions.
- 18 No person who acts solely as either a notary or messenger for
- 19 motor vehicle forms or a farm equipment dealer, mobile home
- 20 <u>dealer or modular housing manufacturer</u> shall be bound by the
- 21 provisions of this chapter.
- 22 Section 7. This act shall take effect in 60 days.
