AN ACT

- 1 Amending the act of July 20, 1917 (P.L.1158, No.401), entitled
- 2 "An act to fix, regulate, and establish the fees to be
- 3 charged and received by constables in this Commonwealth,"
- 4 changing fees and adding provisions relating to training and
- 5 certification; and making a repeal.
- 6 The General Assembly of the Commonwealth of Pennsylvania
- 7 hereby enacts as follows:
- 8 Section 1. Section 1 of the act of July 20, 1917 (P.L.1158,
- 9 No.401), referred to as the Constable Fee Law, amended July 9,
- 10 1987 (P.L.243, No.46), is amended to read:
- 11 Section 1. Be it enacted, &c., That, from and after the
- 12 passage of this act, the fees to be charged and received by
- 13 constables in this Commonwealth shall be as follows:
- 14 [For executing a warrant on behalf of the Commonwealth or a
- 15 political subdivision thereof, for each defendant, five dollars
- 16 plus fifteen cents for each mile.
- 17 For conveying defendants, except vagrants, to jail, on

- 1 mittimus or warrants, for each defendant, five dollars plus
- 2 fifteen cents per mile. Where more than one defendant is
- 3 conveyed simultaneously, the constable shall be reimbursed only
- 4 for the miles actually traveled. In no case shall the constable
- 5 be reimbursed for the mileage as if each defendant were conveyed
- 6 separately.
- 7 For arresting persons guilty of a breach of the peace,
- 8 riotous or disorderly conduct, drunkenness, or who may be
- 9 engaged in the commission of any unlawful act tending to imperil
- 10 the personal security or endanger the property of the citizens,
- 11 or violating any ordinance of any borough, township or political
- 12 subdivision, for the violation of which a fine or penalty is
- 13 imposed, or offending or suspected of offending against the laws
- 14 of this Commonwealth, protecting timberlands, or the violation
- 15 of any other law of this Commonwealth authorizing arrest by
- 16 constable without process, and bringing such offender before a
- 17 justice of the peace, for each defendant, five dollars; and for
- 18 every act in or about the arrest or commitment of vagrants, five
- 19 dollars for each vagrant so arrested, or arrested and committed,
- 20 and mileage as hereinafter provided.
- 21 For levying a fine or forfeiture on a warrant, fifty cents.
- 22 For taking the body of a defendant into custody on a warrant,
- 23 where bail is afterwards entered before delivery of body to the
- 24 jailer, five dollars.
- 25 For executing discharge to jailer, five dollars.
- 26 For executing bail-piece, two dollars fifty cents.
- 27 For executing a search-warrant, and making return thereon,
- 28 one dollar.
- 29 For making returns to the court of common pleas, two dollars
- 30 and fifty cents.

- 1 For serving summons, complaints, notices on suitor or tenant,
- 2 either personally or by leaving copy, five dollars plus one
- 3 dollar fifty cents for each additional defendant.
- 4 For serving subpoena, in all cases, five dollars for the
- 5 first witness, plus fifteen cents for each mile, plus two
- 6 dollars for each additional witness.
- 7 For executing landlord's warrant, three dollars.
- 8 For taking inventory of goods, each item, two cents.
- 9 For levying or distraining goods, including schedule of
- 10 property levied upon and set aside, fifteen dollars.
- 11 For advertising personal property to public sale, two dollars
- 12 and fifty cents.
- For appraisement on landlord's distraint, five dollars.
- 14 For posting notice of execution sale or sale on landlord's
- 15 distraint and advertisement, plus actual cost of advertising,
- 16 five dollars.
- 17 For selling goods levied or distrained, ten dollars.
- 18 For clerk hire at said sales, when necessary, ten dollars per
- 19 day.
- 20 For watchman taking charge of property levied on, when
- 21 necessary, ten dollars per day, also reasonable expenses of
- 22 insurance, arranging goods for sale, heat, light, storage, rent,
- 23 transportation, feeding livestock, and similar expenses incurred
- 24 in caring for and keeping goods and chattels levied upon, when
- 25 the same is necessary and advantageous, or when requested by the
- 26 plaintiff or defendant to incur such expense.
- 27 For receiving and paying over money paid after a levy,
- 28 without sale, one dollar and fifty cents.
- For bill of sale, when demanded, each item two cents.
- 30 For putting up notice of distress on the premises, fifty

- 1 cents.
- 2 For making return of no levy or not found on any process, one
- 3 dollar fifty cents.
- 4 For executing order for possession, seven dollars.
- 5 For forcible ejectment on order for possession, twenty-five
- 6 dollars.
- 7 For serving complaint in landlord and tenant proceedings,
- 8 five dollars.
- 9 For taking inventory of goods on an execution, each item, two
- 10 cents.
- 11 For appraising property where exemption is claimed by
- 12 defendant, one dollar.
- 13 For traveling expenses in the performance of any duty or
- 14 service hereinbefore set forth, or in the performance of any
- 15 other duty or service required by law, each mile going and
- 16 returning, fifteen cents to be computed by the route usually
- 17 traveled in going from points and places where said constables
- 18 may reside, or where he receives any paper to be executed, to
- 19 the points or places required to be traveled: Provided, That in
- 20 no case shall more mileage be demanded or received than for the
- 21 miles actually traveled except that in all political
- 22 subdivisions other than cities of the first class a minimum fee
- 23 of one dollar fifty cents shall be allowed as mileage.
- 24 For services not herein specially provided for the same fee
- 25 may be charged and received as for similar services.]
- 26 (a) Actual mileage for travel by motor vehicle shall be
- 27 reimbursed at a rate equal to the highest rate allowed by the
- 28 Internal Revenue Service. If travel is by other than motor
- 29 <u>vehicle</u>, reimbursement shall be for actual, vouchered travel
- 30 <u>expenses.</u>

- 1 (b) If more than one defendant is transported
- 2 <u>simultaneously</u>, <u>reimbursements</u> <u>shall</u> <u>be</u> <u>for</u> <u>actual</u> <u>miles</u>
- 3 traveled and the cost shall be divided between or among the
- 4 <u>defendants</u>.
- 5 (c) A constable or deputy constable, when he is transporting
- 6 <u>a prisoner, serving a warrant in a court case or serving a</u>
- 7 warrant on a defendant of the opposite sex, may at his
- 8 <u>discretion</u> be accompanied by a second constable or deputy
- 9 constable who is certified pursuant to this act. In such cases,
- 10 each officer shall receive the fee set by this section. In other
- 11 civil and criminal cases, the issuing authority may authorize
- 12 <u>such a payment to a second officer.</u>
- 13 (d) In civil cases, constable fees must be paid in advance
- 14 to the court for services desired to be performed. Such fees
- 15 shall not be refundable to the plaintiff if a case is settled or
- 16 <u>a debt is satisfied less than forty-eight hours prior to a</u>
- 17 <u>scheduled sale or ejectment, in which case the constable or</u>
- 18 deputy constable shall be paid for holding the sale or carrying
- 19 out an ejectment, respectively.
- 20 (e) Fees shall be paid by the court to the constable as soon
- 21 as possible, and in no case more than fifteen days after the
- 22 latter of the following occurs: (1) the service is performed;
- 23 and (2) the request for payment is submitted.
- 24 (f) Fees in civil cases shall be as follows:
- 25 (1) For serving a complaint, summons or notice on suitor or
- 26 <u>tenant</u>, either personally or by leaving a copy, ten dollars,
- 27 plus five dollars for each additional tenant at the same
- 28 <u>address</u>.
- 29 (2) For levying goods, including schedule of property levied
- 30 <u>upon and set aside, thirty-five dollars.</u>

- 1 (3) For advertising personal property to public sale, five
- 2 <u>dollars per posting (maximum of fifteen dollars) plus actual</u>
- 3 cost of advertising.
- 4 (4) For selling goods levied, thirty-five dollars.
- 5 (5) For clerk hired at sale, twenty dollars.
- 6 (6) For making return of not found or nulla bona (no goods),
- 7 ten dollars.
- 8 (7) For executing order of possession, ten dollars.
- 9 <u>(8) For ejectment, seventy dollars.</u>
- 10 (9) For making return of service, other than not found, two
- 11 <u>dollars and fifty cents.</u>
- 12 (10) For providing courtroom security as ordered, ten
- 13 dollars per hour, prorated to the nearest whole dollar, assessed
- 14 against one or more parties as determined by the court.
- 15 (q) Fees in criminal cases shall be as follows:
- 16 (1) For executing a warrant or for effectuating the payment
- 17 of fines and costs by attempting to execute a warrant, fifteen
- 18 dollars per warrant.
- 19 (2) For taking custody of a defendant, five dollars per
- 20 defendant.
- 21 (3) For conveyance of defendant to or from court, five
- 22 dollars per defendant.
- 23 (4) For attendance at arraignment or hearing, five dollars
- 24 per defendant.
- 25 (5) For executing discharge, five dollars per defendant.
- 26 (6) For executing commitment, five dollars per defendant.
- 27 (7) For executing release, five dollars per defendant.
- 28 (8) For making returns to the court, two dollars and fifty
- 29 <u>cents.</u>
- 30 (9) For holding a defendant while awaiting the arrival of

- 1 the district justice at his or her office, ten dollars per
- 2 defendant per hour beyond the first half hour, assessed to the
- 3 court.
- 4 (10) For conveying defendants for fingerprinting, five
- 5 <u>dollars per defendant.</u>
- 6 (11) For fingerprinting or overseeing the fingerprinting of
- 7 <u>defendants at the direction of the district justice, ten dollars</u>
- 8 per defendant, plus ten dollars per defendant per hour beyond
- 9 the first half hour.
- 10 (12) For providing courtroom security as ordered, ten
- 11 dollars per hour, prorated to the nearest whole dollar, assessed
- 12 against one or more parties as determined by the court.
- 13 (13) For serving subpoenas, ten dollars for the first
- 14 witness, plus two dollars and fifty cents for each additional
- 15 witness at the same address. The same fee shall be payable for
- 16 <u>attempting to serve subpoenas at a wrong address supplied by the</u>
- 17 party requesting the service.
- 18 (h) For civil and criminal services not specifically
- 19 provided for, the court shall pay the same fee as it pays for
- 20 <u>services provided for herein which it determines to be similar</u>
- 21 to those performed.
- 22 (i) The board may, with the review and approval of the
- 23 commission, provide interpretations of the fee provisions of
- 24 this act, establish procedures for the payment and collection of
- 25 fees and from time to time authorize higher fees to be charged
- 26 <u>and received by constables and deputy constables than those</u>
- 27 provided herein.
- 28 (I) THE COUNTY COMMISSIONERS MAY ESTABLISH PROCEDURES FOR
- 29 THE PAYMENT AND COLLECTION OF FEES.
- 30 (j) In all criminal cases wherein the defendant is

- 1 discharged or indigent, or the case is dismissed, the court
- 2 shall assess to the county the fee provided in this section,
- 3 <u>except that, in cases of private criminal complaints wherein the</u>
- 4 <u>defendant is discharged prior to the indictment or the filing of</u>
- 5 any information, or the case is otherwise dismissed at the
- 6 <u>summary offense hearing</u>, the court shall assess the fee to the
- 7 <u>affiant</u>.
- 8 Section 2. The act is amended by adding sections to read:
- 9 <u>Section 1.1 No constable or deputy constable shall demand or</u>
- 10 receive any fee, surcharge or mileage provided by this act
- 11 <u>unless he or she has been certified pursuant to this act.</u>
- 12 <u>Section 1.2 The following words and phrases when used in</u>
- 13 this act shall have the meanings given to them in this section
- 14 unless the context clearly indicates otherwise:
- 15 <u>"Account." The Constables' Education and Training Account</u>
- 16 <u>established in section 1.9.</u>
- 17 "Board." The Constables' Education and Training Board
- 18 established in section 1.3.
- 19 "Commission." The Pennsylvania Commission on Crime and
- 20 <u>Delinquency of the Commonwealth.</u>
- 21 <u>"Term of office of a deputy constable." The term of office</u>
- 22 of the constable who appointed him or her.
- 23 <u>Section 1.3. (a) There is hereby established within the</u>
- 24 <u>commission an advisory board to be known as the Constables'</u>
- 25 Education and Training Board.
- 26 (b) The board shall be composed of seven members, with one
- 27 appointed by each of the following:
- 28 <u>(1) The Governor.</u>
- 29 (2) The President pro tempore of the Senate.
- 30 (3) The Speaker of the House of Representatives.

- 1 (4) The Majority Leader of the Senate.
- 2 (5) The Majority Leader of the House of Representatives.
- 3 (6) The Minority Leader of the Senate.
- 4 (7) The Minority Leader of the House of Representatives.
- 5 (c) Appointments and terms. -- Every member of the board, at
- 6 the time of his or her appointment or reappointment to the
- 7 board, shall be either: (i) a constable; or (ii) a member of
- 8 the bar of the Supreme Court of Pennsylvania who served
- 9 previously as a constable.
- 10 Officials and employees of the Commonwealth or of any political
- 11 <u>subdivision</u>, if <u>qualified</u> as herein provided, shall be eligible
- 12 for membership on the board. All members of the board shall
- 13 serve for a period of three years, except that the first persons
- 14 appointed by the Majority Leader of the Senate and the Majority
- 15 Leader of the House of Representatives shall serve for a period
- 16 of two years, and the first persons appointed by the Minority
- 17 Leader of the Senate and the Minority Leader of the House of
- 18 Representatives shall serve for a period of one year. Members of
- 19 the board appointed or reappointed under clause (i) may complete
- 20 their term of office on the board if they cease to be a
- 21 constable but may not be reappointed thereafter; provided,
- 22 however, that no constable may be appointed, be reappointed, or
- 23 serve as a board member unless he or she is certified pursuant
- 24 to this act. Failure of a board member to be current in his or
- 25 <u>her certification shall result in the immediate and automatic</u>
- 26 forfeiture of board membership.
- 27 (d) A member appointed to fill a vacancy created by any
- 28 reason other than expiration of a term shall be appointed for
- 29 the unexpired term of the member whom he or she is to succeed in
- 30 the same manner as the original appointment.

- 1 (e) The members of the board shall serve without
- 2 <u>compensation but shall be reimbursed the necessary and actual</u>
- 3 <u>expenses incurred in attending meetings of the board and in the</u>
- 4 performance of their duties under this act.
- 5 (f) Members of the board may be removed by the appointing
- 6 <u>authority for good cause upon written notice from such</u>
- 7 appointing authority specifically setting forth the cause for
- 8 removal.
- 9 (g) The members of the board shall elect a chairman from
- 10 among the members to serve for a period of one year. A chairman
- 11 may be elected to serve successive terms. The Governor shall
- 12 <u>designate the first chairman for organizational purposes only.</u>
- 13 (h) The chairman shall summon the members of the board to
- 14 the first meeting within thirty days after his appointment, or
- 15 within thirty days after the appointment of a sufficient number
- 16 of members to constitute a quorum, whichever is later. The board
- 17 <u>shall meet as often as it deems necessary but at least four</u>
- 18 times each year. Meetings may be called by the chairman of the
- 19 board or by any four members thereof, in either case upon at
- 20 <u>least ten days' written notice to all members of the board. A</u>
- 21 quorum shall consist of four members.
- 22 Section 1.4. The board, with the review and approval of the
- 23 commission, shall:
- 24 (a) Establish, implement and administer the Constables'
- 25 Education and Training Program according to the minimum
- 26 <u>requirements set forth in this act.</u>
- 27 (b) Establish, implement and administer requirements for the
- 28 minimum courses of study and training for constables and deputy
- 29 <u>constables.</u>
- 30 (c) Establish, implement and administer requirements for

- 1 courses of study and in-service training for constables and
- 2 <u>deputy constables</u>.
- 3 (d) Establish, implement and administer requirements for a
- 4 <u>continuing education program for constables and deputy</u>
- 5 constables concerning subjects the board may deem necessary and
- 6 appropriate for the continued education and training of
- 7 constables and deputy constables.
- 8 (e) Approve or revoke the approval of any school which may
- 9 be utilized for the educational and training requirements of
- 10 this act.
- 11 (f) Establish the minimum qualifications for instructors and
- 12 <u>certify instructors</u>.
- (g) Consult and cooperate, and may contract, with
- 14 universities, colleges, law schools, community colleges and
- 15 <u>institutes for the development of basic and continuing education</u>
- 16 courses for constables and deputy constables.
- 17 (h) Promote the most efficient and economical program for
- 18 constable and deputy constable training by utilizing existing
- 19 facilities, programs and qualified State and local personnel.
- 20 (i) Certify constables and deputy constables who have
- 21 satisfactorily completed the basic and continuing education and
- 22 training requirements of this act and issue appropriate
- 23 certificates to them.
- 24 (j) Make rules and regulations and perform other duties as
- 25 <u>may be reasonably necessary or appropriate to administer the</u>
- 26 education and training program for constables and deputy
- 27 constables.
- (k) Make an annual report to the Governor and to the General
- 29 <u>Assembly concerning:</u>
- 30 (1) The administration of the Constables' Education and

- 1 Training Program.
- 2 (2) The activities of the board.
- 3 (3) The costs of the program.
- 4 (4) Proposed changes, if any, in this act.
- 5 <u>Section 1.5. The Constables' Education and Training Program</u>
- 6 shall include training for a total of eighty hours, the content
- 7 of which shall be determined by regulation. Any constable or
- 8 deputy who is in office as of the effective date of this
- 9 amendatory act shall be afforded one and only one opportunity,
- 10 prior to the expiration of his current term, to satisfactorily
- 11 complete this program by examination without the necessity of
- 12 class attendance.
- 13 <u>Section 1.6.</u> The board, with the review and approval of the
- 14 commission, shall establish a mandatory continuing education
- 15 program for constables and deputy constables, which shall
- 16 <u>include no more than forty hours per year, concerning subjects</u>
- 17 the board may deem necessary and appropriate for the continued
- 18 education and training of constables and deputy constables.
- 19 <u>Section 1.7. All constables and deputy constables who are in</u>
- 20 office as of the effective date of this amendatory act shall be
- 21 deemed to be certified under and in compliance with sections
- 22 1.5, 1.6 and 1.8 of this act for the balance of their current
- 23 term of office.
- 24 <u>Section 1.8. No constable or deputy constable shall carry or</u>
- 25 use a firearm in the performance of his or her duties unless he
- 26 or she is currently certified or qualified in firearms pursuant
- 27 to at least one of the following:
- 28 (a) The act of June 18, 1974 (P.L.359, No.120), referred to
- 29 <u>as the Municipal Police Education and Training Law.</u>
- 30 (b) The act of October 10, 1974 (P.L.705, No.235), known as

- 1 the "Lethal Weapons Training Act."
- 2 (c) The act of February 9, 1984 (P.L.3, No.2), known as the
- 3 "Deputy Sheriffs' Education and Training Act."
- 4 (d) Any other firearms program which has been approved by
- 5 the board with the review and approval of the commission.
- 6 Section 1.9. (a) There is hereby established a special
- 7 restricted account within the General Fund of the State
- 8 Treasury, which shall be know as the Constables' Education and
- 9 Training Account, for the purposes of financing training program
- 10 expenses, the costs of administering the program and all other
- 11 costs associated with the activities of the board and the
- 12 <u>implementation of this act.</u>
- (b) There is hereby assessed a surcharge of two dollars on
- 14 each fee payable under this act for each service lawfully
- 15 performed or to be performed by every constable or deputy
- 16 constable, except that no county shall be required to pay this
- 17 surcharge on behalf of any indigent or other defendant in a
- 18 criminal case.
- 19 (c) The surcharges collected under subsection (b), if
- 20 <u>collected by a constable or deputy constable, shall be turned</u>
- 21 over within one week to the issuing authority. The issuing
- 22 authority shall, within one week of collecting or receiving any
- 23 surcharges, remit the same to the Department of Revenue for
- 24 deposit into the account.
- 25 (d) Disbursements from the account shall be made by the
- 26 <u>commission</u>.
- 27 (e) The Auditor General shall conduct an audit of the
- 28 account as he or she may deem necessary or advisable from time
- 29 to time, but not less than once every three years.
- 30 Section 3. The act of November 29, 1990 (P.L.574, No.147),

- 1 entitled, "An act amending Title 42 (Judiciary and Judicial
- 2 Procedure) of the Pennsylvania Consolidated Statutes, further
- 3 providing for the jurisdiction of the Philadelphia Municipal
- 4 Court; and adding provisions relating to constables," is
- 5 repealed.
- 6 Section 4. This act shall take effect as follows:
- 7 (1) Section 3 of this act shall take effect immediately.
- 8 (2) The remainder of this act shall take effect in 30
- 9 days.
