AN ACT

- 1 Amending Title 18 (Crimes and Offenses) of the Pennsylvania
- 2 Consolidated Statutes, prohibiting certain individuals from
- 3 preventing others from entering or leaving a medical
- 4 facility; providing exceptions; and imposing penalties.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Title 18 of the Pennsylvania Consolidated
- 8 Statutes is amended by adding a section to read:
- 9 § 5516. Harassment at medical facilities.
- 10 (a) Offense defined.--A person commits a misdemeanor of the
- 11 third degree if he prevents or attempts to prevent an individual
- 12 <u>from entering or leaving a medical facility by doing any of the</u>
- 13 <u>following:</u>
- 14 (1) Physically detaining the individual.
- 15 (2) Physically obstructing, impeding or hindering the
- 16 <u>individual's passage.</u>
- 17 (b) Exception. -- This section shall not prohibit an assembly
- 18 related to a labor dispute conducted in accordance with the act

- 1 of May 18, 1937 (P.L.674, No.177), known as the Pennsylvania
- 2 Labor Mediation Act, or the act of July 23, 1970 (P.L.563,
- 3 No.195), known as the Public Employe Relations Act.
- 4 (c) Penalty. -- A person convicted of violating this section
- 5 shall be sentenced to pay a fine of not more than \$1,000 or to
- 6 serve a term of imprisonment of not more than 90 days, or both.
- 7 (d) Definitions.--As used in this section, the following
- 8 words and phrases shall have the meanings given to them in this
- 9 <u>subsection:</u>
- 10 <u>"Action." The term does not include speech.</u>
- 11 <u>"Medical facility." A doctor's office or an agency, clinic,</u>
- 12 facility or office operated under the direction or regulatory
- 13 <u>authority of the Department of Health.</u>
- 14 "Person." The term does not include any of the following:
- 15 <u>(1) The chief executive officer of a medical facility.</u>
- 16 (2) The chief executive officer's designee.
- 17 (3) An agent of a medical facility.
- 18 (4) A law enforcement officer acting within the proper
- 19 scope of his authority.
- 20 Section 2. This act shall take effect immediately.
