AN ACT

- 1 Amending Title 75 (Vehicles) of the Pennsylvania Consolidated 2 Statutes, further providing for handicapped placard.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. Sections 1334, 1338 and 1342 of Title 75 of the
- 6 Pennsylvania Consolidated Statutes are amended to read:
- 7 § 1334. Return of registration plate.
- 8 (a) General rule.--Registration plates shall be returned to
- 9 the department under the following circumstances:
- 10 (1) A registration plate shall be returned if the
- 11 registrant no longer has a vehicle titled in this
- 12 Commonwealth.
- 13 (2) A legislative registration plate shall be returned
- on the expiration or termination of the term of office of the
- 15 legislative member.
- 16 (3) A dealer or "Miscellaneous Motor Vehicle Business"
- 17 registration plate shall be returned if the business is

- 1 discontinued.
- 2 (4) A [handicapped] <u>disability</u> registration plate shall
- 3 be returned if the person to whom it was issued no longer
- 4 qualifies under section 1338 (relating to [handicapped]
- 5 <u>disability</u> plate and placard).
- 6 (b) Time for return of plate. -- Each registration plate
- 7 required to be returned under this section shall be returned to
- 8 the department within five days of the occurrence requiring its
- 9 return.
- 10 (c) Statement accompanying returned plate.--Each returned
- 11 registration plate shall be accompanied by a statement of the
- 12 reason for the return of the plate and the date of the
- 13 occurrence requiring its return.
- 14 § 1338. [Handicapped] <u>Disability</u> plate and placard.
- 15 (a) [Handicapped] <u>Disability</u> plate. -- On the application of
- 16 any person who:
- 17 (1) is blind;
- 18 (2) does not have full use of an arm or both arms;
- 19 (3) cannot walk 200 feet without stopping to rest;
- 20 (4) cannot walk without the use of, or assistance from,
- a brace, cane, crutch, another person, prosthetic device,
- 22 wheelchair or other assistive device;
- 23 (5) is restricted by lung disease to such an extent that
- the person's forced (respiratory) expiratory volume for one
- second, when measured by spirometry, is less than one liter
- or the arterial oxygen tension is less than 60 mm/hg on room
- 27 air at rest;
- 28 (6) uses portable oxygen;
- 29 (7) has a cardiac condition to the extent that the
- 30 person's functional limitations are classified in severity as

- 1 Class III or Class IV according to the standards set by the
- 2 American Heart Association;
- 3 (8) is severely limited in his or her ability to walk
- 4 due to an arthritic, neurological or orthopedic condition; or
- 5 (9) is a person in loco parentis of a person specified
- 6 in paragraph (1), (2), (3), (4), (5), (6), (7) or (8);
- 7 the department shall issue a special registration plate for one
- 8 passenger car or other vehicle with a registered gross weight of
- 9 not more than 9,000 pounds, designating the vehicle so licensed
- 10 as being used by a [handicapped] person with a disability.
- 11 Special plates for [handicapped] persons with disabilities may
- 12 also be issued for vehicles operated exclusively for the use and
- 13 benefit of [handicapped] <u>such</u> persons.
- 14 (b) [Handicapped] <u>Disability</u> parking placard.--On the
- 15 initial application or renewal application of any person who
- 16 meets the qualifications of subsection (a), the department shall
- 17 issue one special parking placard of such size and design as the
- 18 department shall specify, designating the vehicle in which it is
- 19 displayed as being used for the transportation of a
- 20 [handicapped] person with a disability. When parking the
- 21 designated vehicle, the [handicapped] <u>disability</u> parking placard
- 22 shall be prominently displayed in such a manner that it may be
- 23 viewed from the front and rear of the vehicle by hanging it from
- 24 the front windshield rearview mirror of a vehicle only when that
- 25 vehicle is utilizing a parking space reserved for persons with
- 26 disabilities. When there is no rearview mirror, or the placard
- 27 is not designed in such a manner to accommodate hanging from a
- 28 rearview mirror, the placard shall be displayed on the
- 29 dashboard. Placards may also be issued for use in vehicles when
- 30 operated for the use and benefit of [handicapped] persons with

- 1 disabilities.
- 2 [(c) Physician's statement.--
- 3 (1) Any person applying for a special plate or parking
- 4 placard for handicapped persons must present a statement,
- 5 certified by a physician licensed to practice in this
- 6 Commonwealth or in a contiguous state, that the handicapped
- 7 person is handicapped as provided in subsection (a).
- 8 (2) Any person applying for a renewal of registration of
- 9 a special plate for handicapped persons must comply with this
- 10 subsection. Once a handicapped person has been duly certified
- by a physician as being handicapped, as provided in
- 12 subsection (a), the applicant need not submit a certification
- for subsequent renewals of registration for a special plate
- 14 for handicapped persons. A person who was issued a
- handicapped plate under this section and no longer qualifies
- for one shall not be charged a replacement fee for a regular
- 17 registration plate upon payment of the regular registration
- 18 fee.
- 19 (3) In lieu of a physician's statement, a person
- 20 applying for a special plate or parking placard may present a
- 21 statement from a police officer certifying that the person
- does not have full use of a leg, or both legs, or is blind.
- 23 (4) The department shall phase out existing handicapped
- 24 placards as soon as practicable and issue a new series to
- 25 persons who comply with this section.]
- 26 (c) Physician's statement.--Except as provided in subsection
- 27 (d), a person applying for a special plate or parking placard
- 28 for a person with a disability must present a statement,
- 29 <u>certified by a physician licensed to practice in this</u>
- 30 Commonwealth or in a contiguous state, that the person has a

- 1 disability as provided in subsection (a). Once a person has been
- 2 <u>duly certified by a physician as having a disability, as</u>
- 3 provided in subsection (a), the applicant need not submit a
- 4 certification for subsequent renewals of registration for a
- 5 special plate for a person with a disability. A person who was
- 6 <u>issued a disability plate under this section and no longer</u>
- 7 <u>qualifies for one shall not be charged a replacement fee for a</u>
- 8 regular registration plate upon payment of the regular
- 9 <u>registration fee.</u>
- 10 (d) Exceptions.--In lieu of a physician's statement, a
- 11 person applying for a special plate or parking placard may
- 12 present a statement from a police officer certifying that the
- 13 person does not have full use of a leg, or both legs, or is
- 14 <u>blind or a statement from an organization dedicated to helping</u>
- 15 persons with disabilities that the applicant is a volunteer
- 16 <u>driver for such persons</u>.
- [(d)] (e) Penalty.--Any person violating this section
- 18 commits a summary offense and shall, upon conviction, be
- 19 sentenced to pay a fine of not more than \$100.
- 20 § 1342. Veteran plates and placard.
- 21 (a) Severely disabled veteran plate. -- On the application of
- 22 a veteran whose service-connected disability is certified at
- 23 100% by the service unit of the armed forces in which the
- 24 veteran served or by the United States Veterans' Administration
- 25 or who has a service-connected disability of the type enumerated
- 26 in section 1338 (relating to [handicapped] disability plate and
- 27 placard), the department shall issue a special registration
- 28 plate designating the vehicle as belonging to a [severely
- 29 disabled] veteran with a severe disability. The registration
- 30 plate shall have a white background, shall have blue numbers or

- 1 letters as the department may determine, shall have the words,
- 2 "disabled veteran," in at least ten-point bold type, inscribed
- 3 in red at the bottom of the plate, and shall include the
- 4 international symbol for handicapped access. Only one special
- 5 registration plate shall be issued to a veteran under this
- 6 section. It may be used only on one passenger vehicle or one
- 7 other vehicle with a registered gross weight of not more than
- 8 9,000 pounds.
- 9 (b) Severely disabled veteran placard.--On the application
- 10 of any person who meets the qualifications of subsection (a),
- 11 the department shall issue one special parking placard of such
- 12 size and design as the department shall specify, designating the
- 13 vehicle in which it is displayed as being used for the
- 14 transportation of a [severely disabled] veteran with a severe
- 15 <u>disability</u>. Such placard shall be prominently displayed on the
- 16 right front dash of the vehicle when it is in use for the
- 17 transportation of such [severely disabled] veteran with a severe
- 18 <u>disability</u>.
- 19 (c) Disabled veteran plates. -- On the application of any
- 20 veteran having a disability certified by the service unit of the
- 21 armed forces in which the veteran served or by the United States
- 22 Veterans' Administration as service-connected, the department
- 23 shall issue a special registration plate designating the vehicle
- 24 as belonging to a [disabled] veteran who is disabled. The
- 25 registration plate shall have a white background, shall have
- 26 numbers or letters as the department may determine and shall
- 27 have the words "disabled veteran" in at least ten-point bold
- 28 type inscribed at the bottom of the plate. Only one special
- 29 registration plate shall be issued to a veteran under this
- 30 section. It may be used only on one passenger vehicle or one

- 1 other vehicle with a registered gross weight of not more than
- 2 9,000 pounds.
- 3 (d) Prisoner of war plate. -- On the application of an ex-
- 4 prisoner of war whose imprisonment while in the service of the
- 5 armed forces of the United States is certified by the
- 6 appropriate branch of the armed forces, the department shall
- 7 issue a special registration plate designating the vehicle as
- 8 belonging to an ex-prisoner of war. The registration plate shall
- 9 contain the letters "POW" and such other numbers or letters as
- 10 the department may determine and shall have the words "prisoner
- 11 of war" in at least ten-point bold type inscribed at the bottom
- 12 of the plate. The special registration plate may be used only on
- 13 one passenger vehicle or one other vehicle with a registered
- 14 gross weight of not more than 9,000 pounds.
- 15 (e) Documentation of eligibility. -- The department may
- 16 require current holders of disabled veteran registration plates
- 17 and placards to provide documentation of their eligibility under
- 18 this section where current documentation is not sufficient.
- 19 Section 2. This act shall take effect immediately.
