AN ACT

- 1 Relating to rural health care; providing for voice, video or
- 2 data communication links; establishing eligibility criteria;
- 3 providing for duties of the Bureau of Planning within the
- 4 Department of Health; and making an appropriation.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Short title.
- 8 This act shall be known and may be cited as the Med-Link
- 9 Pilot Program Act.
- 10 Section 2. Definitions.
- 11 The following words and phrases when used in this act shall
- 12 have the meanings given to them in this section unless the
- 13 context clearly indicates otherwise:
- 14 "Bureau." The Bureau of Planning within the Department of
- 15 Health.
- 16 "Med-Link." A voice, video or data communication and
- 17 information network between rural health care providers and

- 1 sources of medical expertise, support, data, information and
- 2 training.
- 3 "Med-Link Pilot Program." A program administered by the
- 4 bureau to develop voice, video or data communication and
- 5 information networks; review applications; and provide technical
- 6 and financial assistance to participants.
- 7 "Rural health care provider." Any hospital, health care
- 8 professional or other licensed health care unit located in a
- 9 geographic area with a population size and density determined by
- 10 the bureau.
- 11 Section 3. Med-Link Pilot Program.
- 12 (a) Establishment.--There is created a Med-Link Pilot
- 13 Program, which shall be administered by the bureau.
- 14 (b) Grants.--The bureau shall provide grants from the sums
- 15 appropriated to establish Med-Link systems linking rural health
- 16 care providers with other sources of medical support, data,
- 17 information and training.
- 18 Section 4. Eligibility.
- 19 The bureau shall consider grant proposals addressing the
- 20 health care information and communication needs of rural areas
- 21 offered by applicants who can demonstrate innovative
- 22 applications of telecommunication and information technologies
- 23 linking rural health care providers with sources of medical
- 24 support, data, information and training. To be considered for
- 25 grants, proposals must do all of the following:
- 26 (1) Account for the number of hospitals and other
- institutions which will be linked by the Med-Link system.
- 28 (2) Accurately estimate the number of rural residents
- 29 who will be the indirect beneficiaries of the Med-Link grant.
- 30 (3) Provide information on how the programs will operate

- on a 24-hour basis and incorporate back-up systems.
- 2 (4) Improve rural access to a continuum of health care
- 3 information and services.
- 4 (5) Result in illness prevention and improved care.
- 5 (6) Capitalize on technology and communication networks.
- 6 Section 5. Technical assistance.
- 7 The bureau shall provide technical expertise to health care
- 8 providers interested in establishing a program. The bureau may
- 9 consult with private industries, consultants, academic research
- 10 institutes and other individuals or organizations involved in
- 11 telecommunications and information networks.
- 12 Section 6. Grant amounts.
- Grants shall be awarded in amounts ranging from \$15,000 to
- 14 \$45,000 a year and may be awarded for a period not to exceed
- 15 three years. In determining the amount of an award, the bureau
- 16 shall consider the scope of the program, the number of health
- 17 care providers and consumer entities involved and the likely
- 18 increase in access to and availability of health care
- 19 information and services to rural residents.
- 20 Section 7. Reports.
- 21 The grantees shall be monitored by the bureau and shall
- 22 prepare reports as the bureau requires. If it is determined that
- 23 a grantee is using grant funds for purposes inconsistent with
- 24 this act, the bureau shall require repayment of all or part of
- 25 the grant to the Commonwealth.
- 26 Section 8. Further duties of bureau.
- 27 To promote maximum effectiveness of any program created under
- 28 this act, the bureau shall do all of the following:
- 29 (1) Arrange for the waiver of administrative impediments
- 30 to the implementation of the program, so long as the waiver

- is consistent with the health, safety and general welfare of
- 2 the rural residents who are the indirect beneficiaries of the
- 3 information and services.
- 4 (2) Consult with Federal, State and local officials to
- 5 secure the coordination of related programs and obtain
- 6 waivers.
- 7 (3) Provide the General Assembly with legislative
- 8 recommendations to facilitate the provisions of this act.
- 9 Section 9. Appropriation.
- The sum of \$425,000, or as much thereof as may be necessary,
- 11 is hereby appropriated to the Bureau of Planning for the fiscal
- 12 year July 1, 1993, to June 30, 1994, for start-up costs and
- 13 expenses of the bureau.
- 14 Section 10. Effective date.
- 15 This act shall take effect in 60 days.
