## AN ACT

Providing the Early Childhood Education Professional Loan 2 Forgiveness Program for Pennsylvania residents who graduate 3 from institutions of higher education and who apply their 4 educational training to positions in approved child-care 5 facilities in this Commonwealth. 6 The General Assembly finds and declares as follows: 7 (1)Parents who work need to depend on daily child-care services which provide a safe, healthy and educationally 9 sound program for their children. 10 There is a growing crisis in child care due to an 11 increasing shortage of child-care professionals which is a result of low wages and poor benefits. 12 13 (3) Child caregiver turnover is currently approximately 14 33% for child day-care centers in this Commonwealth. Child-care teachers earn one-third of the salary of 15 (4)

Two-thirds of the child-care teachers in this

Commonwealth hold four year degrees but make less than the

comparably educated public school teachers.

- 3 (6) Research has shown that young children in group
- 4 settings thrive emotionally, socially, physically and
- 5 intellectually when they have an adequate number of adults
- 6 specifically trained in child development and early childhood
- 7 education with whom to interact.
- 8 (7) With current salaries at approximately \$11,200
- 9 annually for child-care teachers, many of those individuals
- 10 with the same educational credentials as public school
- 11 teachers have chosen to abandon careers in child care for
- teaching jobs which guarantee a minimum annual salary of
- 13 \$18,500 plus benefits.
- 14 (8) Payment of a portion of student loans for child-care
- professionals establishes a commitment by the Commonwealth to
- 16 encourage individuals trained in child development and early
- 17 childhood education to apply that training in the growing
- 18 field of child care.
- 19 The General Assembly of the Commonwealth of Pennsylvania
- 20 hereby enacts as follows:
- 21 Section 1. Short title.
- 22 This act shall be known and may be cited as the Early
- 23 Childhood Education Professional Loan Forgiveness Act.
- 24 Section 2. Definitions.
- 25 The following words and phrases when used in this act shall
- 26 have the meanings given to them in this section unless the
- 27 context clearly indicates otherwise:
- 28 "Agency." The Pennsylvania Higher Education Assistance
- 29 Agency.
- 30 "Approved child-care facility." A child day-care center or

- 1 group day-care home located in this Commonwealth which is
- 2 subject to and in compliance with regulations issued by the
- 3 Department of Public Welfare.
- 4 "Program." The Early Childhood Education Professional Loan
- 5 Forgiveness Program.
- 6 "Qualified applicant." A person who meets the following
- 7 criteria:
- 8 (1) Has successfully completed an undergraduate program
- 9 at an accredited college or university with either a
- 10 bachelor's degree or an associate's degree in the human
- 11 services field which includes at least 15 credit hours in
- 12 child development or related areas.
- 13 (2) Has borrowed through the agency-administered
- Guaranteed Student Loan Programs.
- 15 Section 3. Early Childhood Education Professional Loan
- 16 Forgiveness Program.
- 17 Qualified applicants who are selected for the program in
- 18 accordance with this act shall be eligible for payment by the
- 19 agency of a portion of the debt incurred by the applicant
- 20 through the agency-administered Guaranteed Student Loan Programs
- 21 for the education necessary to successfully complete the
- 22 specified bachelor's degree or associate's degree programs in
- 23 Pennsylvania. For each calendar year that the applicant is a
- 24 full-time professional in an approved Commonwealth child-care
- 25 facility, the agency may forgive a proportional part of the
- 26 applicant's loan so that the loan may be entirely forgiven over
- 27 four years of full-time employment in an approved child-care
- 28 facility. For a graduate with a bachelor's or associate's degree
- 29 in the specified areas, no more than \$2,500 shall be forgiven in
- 30 any year, and no more than \$10,000 shall be forgiven for any

- 1 applicant. Payments shall be made in accordance with the
- 2 procedures established by the agency.
- 3 Section 4. Loan forgiveness awards.
- 4 Recipients of the loan forgiveness awards shall be those
- 5 child-care professionals who are working in approved child-care
- 6 facilities in this Commonwealth. Each child-care professional
- 7 shall be required to submit such documentation of eligibility as
- 8 the agency may require.
- 9 Section 5. Funding.
- 10 Loan forgiveness awards shall be made to the extent that
- 11 funds are appropriated by the General Assembly. In the event
- 12 that funding is insufficient to fully fund all eligible
- 13 applicants, the agency shall make loan forgiveness awards to
- 14 those applicants who are renewing previous awards and then
- 15 provide awards to first time applicants as funding permits.
- 16 Section 6. Interagency responsibilities.
- 17 It shall be the responsibility of the agency, in cooperation
- 18 with the Department of Public Welfare, to administer the program
- 19 established by this act and to promulgate the necessary rules
- 20 and regulations. It shall be the responsibility of the
- 21 Department of Public Welfare to screen applicants and furnish a
- 22 list of all recipients and their pertinent information to the
- 23 agency. The agency shall make payments to the loan forgiveness
- 24 award recipients from this list in accordance with the
- 25 regulations adopted by the agency in cooperation with the
- 26 Department of Public Welfare.
- 27 Section 7. Effective date.
- This act shall take effect January 1, 1994.
