AN ACT

Amending Title 51 (Military Affairs) of the Pennsylvania 1 2 Consolidated Statutes, further providing for composition of 3 the State Veterans' Commission. 4 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 6 Section 1. Section 1702(b) of Title 51 of the Pennsylvania Consolidated Statutes is amended to read: § 1702. State Veterans' Commission. 9 (b) Composition. -- The commission shall be composed of: 10 The Adjutant General, ex officio, or his designee. 11 (1)12 (2) The State commander, commandant or head, or his designee, of each of the following named veterans' 13 14 organizations:
