AN ACT

- 1 Providing for advance notification of pesticide application
- 2 within schools, school grounds, athletic fields and
- 3 playgrounds.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Short title.
- 7 This act shall be known and may be cited as the Pesticide
- 8 Notification Act.
- 9 Section 2. Definitions.
- 10 The following words and phrases when used in this act shall
- 11 have the meanings given to them in this section unless the
- 12 context clearly indicates otherwise:
- 13 "Applicator." A certified applicator, private applicator,
- 14 commercial applicator or public applicator.
- 15 "Board." The Pesticide Advisory Board.

- 1 "Certified applicator." An individual who is certified under
- 2 section 16.1, 17 or 17.1 of the act of March 1, 1974 (P.L.90,
- 3 No.24), known as the Pennsylvania Pesticide Control Act of 1973,
- 4 as competent to use or supervise the use or application of any
- 5 pesticide.
- 6 "Commercial applicator." A certified applicator, whether or
- 7 not he is a private applicator with respect to some uses, who
- 8 uses or supervises the use of any pesticide on the property or
- 9 premises of another or on easements granted under State law, or
- 10 any applicator who uses or supervises the use of any restricted-
- 11 use pesticide on property owned or rented by him or his
- 12 employer, when not for purposes of producing an agricultural
- 13 product. The Secretary of Agriculture may by regulation deem
- 14 certain types of applicators using any pesticide on their own
- 15 property or that of their employer as commercial applicators.
- 16 "Department." The Department of Agriculture of the
- 17 Commonwealth.
- 18 "Indoor treatment." A treatment that includes an outside
- 19 perimeter treatment of the building if the primary purpose of
- 20 the treatment is to treat the inside of the building. The
- 21 Secretary of Agriculture shall define a perimeter treatment by
- 22 regulation and shall adopt the definitions provided in Federal
- 23 law.
- 24 "Insect." Any of the numerous small invertebrate animals
- 25 generally having a more or less obviously segmented body, for
- 26 the most part belonging to the class Insecta, comprising six-
- 27 legged, usually winged forms, as, for example, beetles, bugs,
- 28 bees and flies, and to other allied classes of arthropods whose
- 29 members are wingless and usually have more than six legs, as,
- 30 for example, spiders, mites, ticks, centipedes and wood lice.

- 1 "Integrated pest management plan." A decision-making process
- 2 which includes inspection and pest identification, monitoring of
- 3 pest and beneficial insect populations and recordkeeping of
- 4 same, injury-level assessment to determine when treatment is
- 5 needed, treatment selection and application with pest prevention
- 6 methods, such as habitat modification and sanitation measures,
- 7 and nontoxic controls being the primary selections and
- 8 evaluation of results.
- 9 "Land." All land and water areas, including airspace, and
- 10 all plants, animals, structures, buildings, contrivances and
- 11 machinery appurtenant thereto or situated thereon, fixed or
- 12 mobile, including any used for transportation.
- 13 "License." Written permission issued by the Department of
- 14 Agriculture to a business or person as authorized under the act
- 15 of March 1, 1974 (P.L.90, No.24), known as the Pennsylvania
- 16 Pesticide Control Act of 1973.
- 17 "Nematode." Invertebrate animals of the phylum
- 18 Nemathelminthes and class Nematoda, that is, unsegmented round
- 19 worms with elongated, fusiform or saclike bodies covered with
- 20 cuticle and inhabiting soil, water, plants or plant parts; may
- 21 also be called nemas or eelworms.
- 22 "Permit." A written certificate issued by the Secretary of
- 23 Agriculture or his authorized agent authorizing the purchase,
- 24 possession or use of pesticides classified for restricted use by
- 25 a private applicator.
- 26 "Person." An individual, partnership, association,
- 27 corporation or any organized group of persons, whether
- 28 incorporated or not.
- Pest." An insect, rodent, nematode, fungus, weed or other
- 30 form of terrestrial or aquatic plant or animal life or virus,

- 1 bacteria or other micro-organism, except viruses, bacteria or
- 2 other micro-organisms on or in living man or other living
- 3 animals, which the administrator declares to be a pest under
- 4 section 25(c)(1) of the Federal Insecticide, Fungicide, and
- 5 Rodenticide Act (61 Stat. 163, 7 U.S.C. § 136 et seq.).
- 6 "Pest control information sheet." A document which contains
- 7 the date of treatment, the name, address and telephone number of
- 8 the applicator, the pesticide utilized and any other information
- 9 that is required by the Secretary of Agriculture.
- 10 "Pest management consultant." An individual who is not a
- 11 licensed applicator and who for a fee offers or supplies
- 12 technical advice, supervision or aid or makes recommendations to
- 13 the user of pesticides classified for restricted use.
- 14 "Pesticide." A substance or mixture of substances intended
- 15 for preventing, destroying, repelling or mitigating any pest and
- 16 a substance or mixture of substances intended for use as a plant
- 17 regulator, defoliant or desiccant.
- 18 "Pesticide application technician." An individual employed
- 19 by a commercial applicator or governmental agency who, having
- 20 met the competency requirements as set forth in the act of March
- 21 1, 1974 (P.L.90, No.24), known as the Pennsylvania Pesticide
- 22 Control Act of 1973, is registered by the Secretary of
- 23 Agriculture to apply any pesticides under the direct supervision
- 24 of a certified applicator.
- 25 "Private applicator." A certified applicator who uses or
- 26 supervises the use of any pesticide which is classified for
- 27 restricted use for purposes of producing any agricultural
- 28 commodity on property owned or rented by him or his employer or,
- 29 if applied without compensation other than trading of personal
- 30 services between producers of agricultural commodities, on the

- 1 property of another person.
- 2 "Public applicator." A certified applicator who applies
- 3 pesticides as an employee of the Commonwealth or its
- 4 instrumentalities or any local agency.
- 5 "School." A public or private elementary or secondary school
- 6 wherein a resident of this Commonwealth may fulfill the
- 7 compulsory school attendance requirements and which meets the
- 8 applicable requirements of Title IV of the Civil Rights Act of
- 9 1964 (Public Law 88-352, 78 Stat. 241). The term also includes a
- 10 kindergarten program operated by a school.
- "Secretary." The Secretary of Agriculture of the
- 12 Commonwealth.
- 13 Section 3. Notification of pesticide treatments at schools.
- 14 (a) Indoor treatment.--For an indoor treatment at a school
- 15 building, the certified applicator or technician shall supply
- 16 the pest control information and a pest control sign, which
- 17 shall be at least 8 1/2 by 11 inches in size, to the chief
- 18 administrator or building manager. The chief administrator or
- 19 building manager shall notify all employees who work in the
- 20 building by doing all of the following:
- 21 (1) Posting the sign in an area of common access that
- 22 the individuals are likely to check on a regular basis at
- 23 least seven days before and for at least two days following
- each planned treatment.
- 25 (2) Providing the information sheet to every individual
- working in the building.
- 27 (3) Providing notice in writing to the parents or
- 28 quardians of the students enrolled in that school. The notice
- shall include the name, address and telephone number of the
- 30 applicator applying the treatment.

- 1 (b) Outdoor treatment.--For an outdoor treatment to be
- 2 applied anywhere on the school grounds, including, but not
- 3 limited to, athletic fields or playgrounds, the certified
- 4 applicator or technician shall supply the pest control
- 5 information sheet and a pest control sign, which shall be at
- 6 least 8 1/2 by 11 inches in size, to the chief administrator or
- 7 grounds manager. The pest control sign shall be posted at the
- 8 field or playground to be treated at least seven days before and
- 9 for two days after the planned treatment.
- 10 (c) Notification.--Personnel at a school with an athletic
- 11 field or a playground to be treated are required to notify in
- 12 writing the parents or guardians of the children attending the
- 13 school at the time the child is registered of the following:
- 14 (1) The school periodically applies pesticides indoors
- and on school grounds.
- 16 (2) Information on the application of pesticides is
- available at the request of the parents or guardians.
- 18 (d) Records.--Each school district shall maintain detailed
- 19 records of all chemical pest control treatments for a period of
- 20 at least 30 years so that chronic health problems suffered by
- 21 school personnel and students can be monitored.
- 22 (e) Integrated plan. -- Each school district shall, on or
- 23 before September 1, 1995, adopt an integrated pest management
- 24 plan that incorporates the standards developed by the secretary.
- 25 (f) Standards.--The board shall assist the secretary in
- 26 developing standards for the integrated pest management plan. In
- 27 developing these standards, the board shall consult with a
- 28 person who is knowledgeable in the area of integrated pest
- 29 management in schools. The standards shall include the
- 30 following:

- 1 (1) A requirement that the least toxic methods available
- to control pests, rodents, insects and weeds be used.
- 3 (2) A list of products that a school district is allowed
- 4 to use in its application.
- 5 (g) Restriction on application. -- The secretary shall require
- 6 that a pesticide may be applied in a school building or on
- 7 school grounds only during periods in which students are not
- 8 expected for normal academic instruction or organized
- 9 extracurricular activities for at least 24 hours following the
- 10 application.
- 11 Section 4. Effective date.
- 12 This act shall take effect in 60 days.
