AN ACT

- 1 Amending Title 42 (Judiciary and Judicial Procedure) of the
- 2 Pennsylvania Consolidated Statutes, further providing for
- 3 additional methods for the recording and copying of certain
- 4 records.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Sections 4323 and 4324 of Title 42 of the
- 8 Pennsylvania Consolidated Statutes are amended to read:
- 9 § 4323. Form of permanent recordation.
- 10 [Records which are classified as records of permanent value
- 11 shall, prior to destruction or other removal from the office of
- 12 the person having custody thereof, be processed in conformity
- 13 with general rules so that they may be reproduced by any
- 14 photostatic, photographic, microphotographic, microfilm, video
- 15 tape, magnetic tape, or other mechanical process which produces
- 16 a clear, accurate and permanent copy, microcopy or reproduction
- 17 of the original, in accordance with standards not less than
- 18 those approved for permanent records by the National Bureau of

- 1 Standards.] Any photostatic, photographic, microphotographic,
- 2 microfilm, microcard, miniature photographic, optical,
- 3 <u>electronic or other process which accurately reproduces the</u>
- 4 <u>original and forms a durable medium for recording, storing and</u>
- 5 reproducing the original in accordance with standards, policies
- 6 and procedures for the creation, maintenance, transmission or
- 7 reproduction of images of records approved by the governing
- 8 authority, but not less than those standards, policies and
- 9 procedures approved by the National Institute of Standards and
- 10 Technology, may be utilized. Any document within the scope of
- 11 this section and which previously has been recorded, copied or
- 12 recopied also may be reproduced by processes authorized by this
- 13 section.
- 14 § 4324. Copies of destroyed records.
- The photostatic, photographic, microphotographic,
- 16 microfilmed, miniature photographic, optical, electronic or
- 17 otherwise reproduced copy of any record destroyed or disposed of
- 18 as authorized pursuant to this subchapter, or a certified copy
- 19 thereof, shall be admissible in evidence in any matter, and
- 20 shall have the same force and effect as though the original
- 21 record had been produced and proved. It shall be the duty of the
- 22 person who would have had custody of the original record, had it
- 23 not been destroyed pursuant to law, to prepare enlarged, typed
- 24 or photographic copies of such reproduced records whenever their
- 25 production is required.
- 26 Section 2. This act shall take effect immediately.
