A JOINT RESOLUTION

- 1 Proposing an amendment to the Constitution of the Commonwealth
- of Pennsylvania, providing for the election by judicial
- districts of justices and judges of the Supreme, Superior and
- 4 Commonwealth Courts from established judicial districts.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby resolves as follows:
- 7 Section 1. The following amendment to the Constitution of
- 8 Pennsylvania is proposed in accordance with Article XI:
- 9 That sections 2, 3, 4 and 11 of Article V be amended to read:
- 10 § 2. Supreme Court.
- 11 The Supreme Court:
- 12 (a) shall be the highest court of the Commonwealth and in
- 13 this court shall be reposed the supreme judicial power of the
- 14 Commonwealth;
- 15 (b) shall consist of seven justices, to be elected from
- 16 judicial districts which shall be established by law, one of

- 1 whom shall be the Chief Justice; and
- 2 (c) shall have such jurisdiction as shall be provided by
- 3 law.
- 4 § 3. Superior Court.
- 5 The Superior Court shall be a statewide court, and shall
- 6 consist of the number of judges, which shall be not less than
- 7 [seven] 15 judges, to be elected from judicial districts which
- 8 shall be established by law, and have such jurisdiction as shall
- 9 be provided by this Constitution or by the General Assembly. One
- 10 of its judges shall be the president judge.
- 11 § 4. Commonwealth Court.
- 12 The Commonwealth Court shall be a statewide court, and shall
- 13 consist of the number of judges, to be elected from judicial
- 14 <u>districts which shall be established by law</u>, and have such
- 15 jurisdiction as shall be provided by law. One of its judges
- 16 shall be the president judge.
- 17 § 11. Judicial districts; boundaries.
- 18 [The] Except for the judicial districts fixed by law pursuant
- 19 to sections 2, 3 and 4, the number and boundaries of judicial
- 20 districts shall be changed by the General Assembly only with the
- 21 advice and consent of the Supreme Court.
