AN ACT

1 Amending Title 23 (Domestic Relations) of the Pennsylvania
2 Consolidated Statutes, further providing for the preplacement
3 report.

4 The General Assembly of the Commonwealth of Pennsylvania
5 hereby enacts as follows:

6 Section 1. Section 2530(b) of Title 23 of the Pennsylvania
7 Consolidated Statutes is amended to read:

8 § 2530. Home study and preplacement report.

9 * * *

10 (b) Preplacement report.--A preplacement report shall be
11 prepared by the agency or person conducting the home study.

12 (1) The preplacement report shall set forth all
13 pertinent information relating to the fitness of the adopting
14 parents as parents.

15 (2) The preplacement report shall [be based upon a study
16 which shall include an investigation of the home environment,
17 family life, parenting skills, age, physical and mental
18 health, social, cultural and religious background, facilities

1 and resources of the adoptive parents and their ability to
2 manage their resources. The preplacement report shall also
3 include the information required by section 6344(b) (relating
4 to information relating to prospective child-care
5 personnel).] contain those elements, as applicable, described
6 in section 2530.1 (relating to elements of preplacement
7 report).

8 (3) The preplacement report shall include a
9 determination regarding the fitness of the adopting parents
10 as parents.

11 (4) The preplacement report shall be dated and verified.
