## A RESOLUTION

- 1 Memorializing Congress to support House Resolution No. 3666 and
- 2 Senate Resolution No. 2007, the George C. Marshall
- 3 Commemorative Coin Acts.
- 4 WHEREAS, George Catlett Marshall was born in Uniontown,
- 5 Pennsylvania, on December 31, 1880; and
- 6 WHEREAS, General Marshall had a long and distinguished
- 7 military career beginning in 1902, which included service as
- 8 Army Chief of Staff from September 1, 1939, to November 20,
- 9 1945, and Secretary of Defense from September 1950 to September
- 10 1951; and
- 11 WHEREAS, General Marshall is also recognized as a true
- 12 statesman, serving as Secretary of State from January 1947 to
- 13 January 1949, crafting the Marshall Plan for European economic
- 14 recovery, and in 1953 becoming the first military man to receive
- 15 the Nobel Peace Prize; and
- 16 WHEREAS, We are approaching the 50th Anniversary of many of
- 17 the historic events that General Marshall helped to shape; and
- 18 WHEREAS, General Dwight D. Eisenhower noted that "Americans

- 1 have never been so deeply indebted to any other soldier."; and
- WHEREAS, Congressmen Murphy and Murtha and Senator Wofford
- 3 have introduced legislation authorizing the minting of a
- 4 commemorative coin in honor of General Marshall; and
- 5 WHEREAS, A surcharge on the sale of such coins would be paid
- 6 to the Friends of George C. Marshall for the purpose of
- 7 constructing and establishing the George C. Marshall Memorial
- 8 and Visitor Center in Uniontown, Pennsylvania; and
- 9 WHEREAS, The coin and memorial are both fitting tributes to
- 10 this distinguished Pennsylvanian; therefore be it
- 11 RESOLVED, That the House of Representatives of the
- 12 Commonwealth of Pennsylvania memorialize Congress to support
- 13 House Resolution No. 3666 and Senate Resolution No. 2007, the
- 14 George C. Marshall Commemorative Coin Acts; and be it further
- 15 RESOLVED, That copies of this resolution be transmitted to
- 16 the presiding officers of each house of Congress and to each
- 17 member of Congress from Pennsylvania.
