A RESOLUTION

- 1 Designating November 15, 1994, as "Diabetes Awareness and
- 2 Education Day" in Pennsylvania.
- 3 WHEREAS, The Commonwealth recognizes the importance of
- 4 diagnosing and treating diabetes effectively; and
- 5 WHEREAS, The Commonwealth recognizes the importance of
- 6 promoting diabetes awareness and education; and
- 7 WHEREAS, The current national yearly health expenditures, for
- 8 both direct and indirect costs associated with diabetes, are in
- 9 excess of \$92 billion; and
- 10 WHEREAS, The number of newly diagnosed diabetics across the
- 11 nation is approximately 677,000 each year; and
- 12 WHEREAS, The number of people with diabetes in the United
- 13 States is in excess of 6.5 million; and
- 14 WHEREAS, By ages 65 to 74, nearly 17% of white Americans, 25%
- 15 of African Americans and more than 33% of Hispanics have

- 1 diabetes; and
- WHEREAS, Diabetes is responsible for 8% of legal blindness;
- 3 and
- 4 WHEREAS, Other complications of diabetes include heart
- 5 disease, stroke, kidney disease and circulation problems; and
- 6 WHEREAS, Tight control of blood glucose levels in diabetics
- 7 has been shown to dramatically decrease the likelihood of the
- 8 occurrence of such complications, thus improving the patient's
- 9 quality of life and decreasing health care expenditures; and
- 10 WHEREAS, Education concerning diabetes and its treatment is
- 11 critical to improving blood glucose control; therefore be it
- 12 RESOLVED, That the House of Representatives designate
- 13 November 15, 1994, as "Diabetes Awareness and Education Day" in
- 14 Pennsylvania, in recognition of the value of education in
- 15 helping to treat diabetes in a cost-effective manner and to
- 16 improve the quality of life for those with diabetes; and be it
- 17 further
- 18 RESOLVED, That diabetics, their families and friends and
- 19 health care professionals in this Commonwealth are urged to
- 20 utilize this day to increase their awareness and understanding
- 21 of diabetes so that in the future diabetics will be better able
- 22 to care for their own needs and others will be better prepared
- 23 to serve the needs of diabetics.
