A RESOLUTION

1 Requesting the Senate not to adjourn sine die when they finish
2 on November 22, 1994, and requesting their possible return.

3 WHEREAS, The Senate amended and passed House Bill No. 666,
4 Printer's No. 4363, on November 15, 1994, by a vote of 44-3; and

5 WHEREAS, The House of Representatives concurred in the Senate
6 amendments to House Bill No. 666 by a vote of 162-32 on November
7 16, 1994; and

8 WHEREAS, House Bill No. 666 is now on Governor Robert P.
9 Casey's desk, awaiting his action; and

10 WHEREAS, The Governor has ten days to sign, veto or do
11 nothing at all with this legislation; and

12 WHEREAS, As amended, House Bill No. 666 would remove 28
13 counties from the Reformulated Fuels Program being mandated by
14 the 1990 amendments to the Clean Air Act (Public Law 95-95, 42
15 U.S.C. § 7401 et seq.); and

1 WHEREAS, The Senate has shown to the citizens of this
2 Commonwealth that they are committed to the removal of these 28
3 counties from the Reformulated Fuels Program by passing this
4 legislation with enough yea votes to override a veto; and

5 WHEREAS, House Bill No. 666 is very important to the citizens
6 of the 28 counties which were added to the program by the
7 Governor; therefore be it

8 RESOLVED, That the House of Representatives request that the
9 Senate remain available to return to session on November 30,
10 1994, or sooner, to vote on an override of the Governor's
11 possible veto of this legislation; and be it further

12 RESOLVED, That the House of Representatives request the
13 President pro tempore to commit to bringing the Senate back into
14 session prior to the sine die at 12 midnight on November 30,
15 1994, to consider a possible override of a veto of House Bill
16 No. 666; and be it further

17 RESOLVED, That a copy of this resolution be delivered to the
18 Senate President pro tempore, Robert Jubelirer.
