AN ACT

- 1 Establishing a public information and education program on
- 2 diethylstilbestrol in the Department of Health; and providing
- 3 for the powers and duties of the Department of Health and for
- 4 certain health insurance policies.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Short title.
- 8 This act shall be known and may be cited as the
- 9 Diethylstilbestrol Public Information and Education Act.
- 10 Section 2. Definitions.
- 11 The following words and phrases when used in this act shall
- 12 have the meanings given to them in this section unless the
- 13 context clearly indicates otherwise:
- 14 "Department." The Department of Health of the Commonwealth.
- 15 "Prenatal." In a stage of biological development which
- 16 follows conception but precedes birth; in utero.
- 17 Section 3. Public information and education program.
- 18 (a) Purpose. -- For the purpose of identifying persons who

- 1 have been exposed to the potential hazards and afflictions of
- 2 diethylstilbestrol, sometimes called DES, while pregnant or
- 3 prenatal and for the purpose of educating the public concerning
- 4 the symptoms and early detection of associated malignancies and
- 5 other abnormalities, the department shall establish, promote and
- 6 maintain a public and professional information and education
- 7 program on diethylstilbestrol.
- 8 (b) Information. -- The program shall be conducted throughout
- 9 this Commonwealth and shall include, but not be limited to, a
- 10 concerted effort at reaching those persons or the offspring of
- 11 those persons who have been exposed to diethylstilbestrol while
- 12 pregnant or prenatal in order to encourage them to seek medical
- 13 care for the screening, early detection or treatment and follow-
- 14 up of any diethylstilbestrol-related condition. The program
- 15 shall emphasize the need for examinations and the need to remain
- 16 informed about additional developments concerning
- 17 diethylstilbestrol.
- 18 (c) Regional screening. -- The department shall designate and
- 19 enter into contracts with health care providers for the purpose
- 20 of establishing regional screening programs for
- 21 diethylstilbestrol-exposed persons. In determining the provider
- 22 with which to contract, the department shall consider the
- 23 provider's compliance with standards mandated by Federal and
- 24 State laws, the location of the provider in relation to the
- 25 geographical distribution of persons exposed to
- 26 diethylstilbestrol and the capacity of the provider to properly
- 27 screen for breast cancer, vaginal cancer, cervical cancer,
- 28 vaginal adenosis, testicular cancer and any other malignancy and
- 29 abnormal conditions resulting from exposure to
- 30 diethylstilbestrol.

- 1 (d) Contract terms and fees.--Each contract for a regional
- 2 screening program shall be upon the terms and conditions as the
- 3 department determines. However, the expenses incurred shall be
- 4 reimbursed by the Commonwealth after applying against the total
- 5 cost of screening and diagnosis the amounts received from third-
- 6 party payers and less any fee charged each person receiving the
- 7 services. The department shall determine a sliding fee scale
- 8 based on the ability to pay.
- 9 (e) Training in detection.--Each health care provider that
- 10 enters into a contract as provided for in this section shall
- 11 conduct a training program in conjunction with the department
- 12 for purposes of instructing physicians, physician assistants and
- 13 nurses within the respective health services region in the
- 14 screening, early detection and treatment of diethylstilbestrol-
- 15 exposed persons.
- 16 Section 4. Registry.
- 17 The department shall establish and maintain a registry of
- 18 women who took diethylstilbestrol while pregnant and their
- 19 offspring who were exposed to diethylstilbestrol while prenatal
- 20 for the purpose of follow-up care and treatment of long-term
- 21 problems associated with diethylstilbestrol exposure. Enrollment
- 22 in the registry shall be upon a voluntary basis.
- 23 Section 5. Agency cooperation.
- 24 The department may request and shall receive from any
- 25 Commonwealth agency or political subdivision any assistance and
- 26 data as will enable the department to properly carry out its
- 27 activities under the provisions of this act.
- 28 Section 6. Annual report.
- 29 The department shall make an annual report to the General
- 30 Assembly of its findings and recommendations concerning the

- 1 effectiveness, impact and benefits derived from the program
- 2 provided for under section 3. The report shall be delivered on
- 3 or before the first day of February and shall contain an
- 4 evaluation of the program and any proposal for legislation
- 5 deemed necessary and proper.
- 6 Section 7. Insurance.
- 7 An individual or group health insurance policy shall not be
- 8 denied or canceled or fail to be renewed, or excessive rates
- 9 charged or restrictions or length of coverage imposed, because
- 10 the insured person has been exposed to diethylstilbestrol while
- 11 pregnant or prenatal.
- 12 Section 8. Regulations.
- 13 The department may adopt regulations to implement the
- 14 provisions of this act.
- 15 Section 9. Effective date.
- 16 This act shall take effect immediately.
