AN ACT

- Amending the act of June 1, 1945 (P.L.1242, No.428), entitled
 "An act relating to roads, streets, highways and bridges;
 amending, revising, consolidating and changing the laws
 administered by the Secretary of Highways and by the
 Department of Highways relating thereto," requiring the
 Department of Transportation to consult and coordinate with
 municipalities and historic districts prior to certain

- 11 Section 1. Section 410 of the act of June 1, 1945 (P.L.1242,
- 12 No.428), known as the State Highway Law, amended July 7, 1972
- 13 (P.L.738, No.173), is amended to read:
- 14 Section 410. Trees, Grasses, Shrubs and Vines along
- 15 Highways; Penalty. -- The department may cause trees, grasses,
- 16 shrubs and vines to be planted and maintained, and shall cause
- 17 receptacles for trash and litter to be maintained, along State
- 18 highways, within the legal right of way thereof, the same to be
- 19 paid for as a part of the costs of construction or maintenance

- 1 of the road. The department may enter into agreements with the
- 2 Department of Environmental Resources regarding the planting and
- 3 maintenance of such trees, grasses, shrubs and vines. The
- 4 Department of Transportation shall have the absolute right to
- 5 trim, cut and remove any trees, grasses, shrubs and vines
- 6 growing within the legal right of way of any State highway, and
- 7 to trim and cut away any trees, grasses, shrubs and vines
- 8 growing on adjacent property in so far as they overhang or
- 9 encroach upon the legal right of way of any State highway[.]:
- 10 Provided, That the Department of Transportation shall give
- 11 notice of, consult with and coordinate its activities with the
- 12 <u>municipalities and historic districts effected by its actions.</u>
- 13 Activity shall proceed with the general goal of conforming that
- 14 <u>activity to the general aesthetic standards set forth in the</u>
- 15 <u>affected municipalities and historic districts, employing means</u>
- 16 and methods which will carry out these standards and accomplish
- 17 the primary goals of the Department of Transportation.
- 18 It shall be unlawful for any person to cut, trim, remove or
- 19 otherwise damage any trees, grasses, shrubs or vines growing
- 20 within the legal right of way of a State highway, which have
- 21 been planted by any person or agency other than the abutting
- 22 property owner, without first having obtained the consent of the
- 23 secretary in writing. Any person who shall cut, trim, remove or
- 24 otherwise damage such trees, grasses, shrubs or vines without
- 25 first having obtained such written consent, shall on summary
- 26 conviction thereof be sentenced to pay a fine of not less than
- 27 one hundred dollars (\$100.00), or more than three hundred
- 28 dollars (\$300.00), for each act of cutting, trimming, removal or
- 29 damaging. This section shall not be construed to permit the
- 30 department to interfere with the right of any abutting property

- 1 owner to establish entrances to his property from State highways
- 2 at any point or points at which such owner may desire to
- 3 establish such entrances.
- Section 2. This act shall take effect immediately. 4
