- 24 Section 407. Sale of Malt or Brewed Beverages by Liquor
- 25 Licensees.--Every liquor license issued to a hotel, restaurant,

club, or a railroad, pullman or steamship company under this 1 subdivision (A) for the sale of liquor shall authorize the 2 3 licensee to sell malt or brewed beverages at the same places but 4 subject to the same restrictions and penalties as apply to sales of liquor, except that licensees [other than clubs] may sell 5 malt or brewed beverages for consumption off the premises where 6 sold in quantities of not more than one hundred ninety-two fluid 7 8 ounces in a single sale to one person. No licensee under this 9 subdivision (A) shall at the same time be the holder of any other class of license, except a retail dispenser's license 10 authorizing the sale of malt or brewed beverages only. 11 12 Section 2. This act shall take effect in 60 days.
