AN ACT

Providing for dual party relay services and for
 telecommunication device distribution.

3 The General Assembly of the Commonwealth of Pennsylvania

4 hereby enacts as follows:

5 Section 1. Short title.

6 This act shall be known and may be cited as the Dual Party

7 Relay Service and Telecommunication Device Distribution Program

8 Act.

9 Section 2. Definitions.

10 The following words and phrases when used in this act shall 11 have the meanings given to them in this section unless the 12 context clearly indicates otherwise:

13 "Center for independent living." A consumer-controlled, 14 community-based, cross-disability, nonresidential private, 15 nonprofit agency that is designed and operated within a local community by people with disabilities and provides an array of
 independent living services, as defined by the Rehabilitation
 Act of 1973 (Public Law 93-112, 29 U.S.C. § 701 et seq.).

4 "Commission." The Pennsylvania Public Utility Commission.
5 "Department." The Department of Labor and Industry of the
6 Commonwealth.

7 "Persons with a disability" or "people with disabilities." A 8 person certified as being deaf, deaf-blind, hard-of-hearing, 9 having a hearing loss or speech impaired by a licensed 10 physician, audiologist, speech pathologist or a qualified State 11 agency.

12 "Program." The Telecommunication Device Distribution Program13 established under this act.

14 "Telecommunication device." Equipment necessary for a person 15 with a disability to engage in communication by wire or radio 16 with another person with a disability or with a hearing 17 individual.

18 "Telecommunication relay service." Telephone transmission services that provide the ability for a person with a disability 19 20 to engage in communication by wire or radio with a hearing 21 individual in a manner that is functionally equivalent to the 22 ability of a person who does not have a disability to 23 communicate using voice communication services by wire or radio. The term includes services that enable two-way communication 24 between an individual who uses a telecommunication device or 25 other nonvoice terminal device and an individual who does not 26 use such a device. 27

28 Section 3. Establishment of Telecommunication Device29 Distribution Program.

30 (a) Establishment.--The Telecommunication Device 19950H0961B1829 - 2 - Distribution Program is hereby established. It shall be a
 program whereby telecommunication devices for people with
 disabilities are distributed at no charge to the distributee.

4 (b) Administration.--The executive director of the Office of 5 Vocational Rehabilitation of the department, in cooperation with 6 other State agencies which serve people with disabilities, shall 7 oversee implementation of the program. To this end, the 8 executive director may do any of the following:

9 (1) Establish criteria of eligibility in accordance with 10 subsection (c) and adopt regulations and forms consistent 11 with the act of July 31, 1968 (P.L.769, No.240), referred to 12 as the Commonwealth Documents Law.

13 (2) Facilitate coordination of funds required for the
14 distribution system with selected centers for independent
15 living OR SELECTED NOT-FOR-PROFIT AGENCIES HAVING EXPERIENCE
16 IN SERVING PERSONS WITH HEARING OR SPEECH DISABILITIES.

17 (3) Determine, in cooperation with other State agencies, 18 the funds required for the distribution system and provide 19 information to the commission as required under section 4. 20 (c) To qualify as distributee.--Each recipient of a 21 telecommunication device shall meet the following criteria:

(1) Be a resident of this Commonwealth.

23 (2) Qualify as a person with a disability.

24 (3) Have telephone service, possess the ability to learn25 how to use a telecommunication device.

26 (4) Be six years of age or older.

27 (5) Have a gross income of less than 200% of the Federal
28 poverty level as determined in accordance with the Link Up
29 America guidelines.

30 Section 4. Establishment of dual party relay service.

(a) Telecommunication relay services.--The commission shall
 design and implement a telecommunication relay service program
 for the Commonwealth that is consistent with and meets or
 exceeds the requirements of the Americans with Disabilities Act
 of 1990 (Public Law 101-336, 104 Stat. 327).

(b) Certification.--The commission is authorized to seek on
behalf of this Commonwealth certification of the
telecommunication relay service program from the Federal
Communications Commission.

10 (c) Additional use of surcharge.--The program shall be 11 funded by the Telecommunication Relay Service Program surcharge, as calculated by the commission on an annual basis under the 12 13 methodology established by the commission in order entered May 29, 1990, and July 9, 1990, at Docket Number M900239. The 14 executive director of the Office of Vocational Rehabilitation in 15 16 the department shall provide the commission with an annual 17 budget and supporting information for the purchase of 18 telecommunication devices for the program. The surcharge shall 19 not be used to fund administrative costs of the program. (d) Limits on expenditures.--Expenditures for the program 20 shall not exceed collections from the Telecommunication Relay 21 22 Service Program surcharge.

(e) Annual report.--The commission shall prepare and submitan annual report to the General Assembly on the program.

(1) The report shall include the fiscal status of the
program, a statement of the surcharge level established under
subsection (c) and the revenues produced by the surcharge, an
account of program expenses and the fund balance.

29 (2) The executive director of the Office of Vocational 30 Rehabilitation in the department shall provide the commission 19950H0961B1829 - 4 - with information on the program, including the purchase and
 distribution of telecommunication devices, for inclusion in
 the annual report to the General Assembly.

4 (3) If the commission determines any of the information 5 is proprietary, the information shall be filed under seal and 6 made available under the terms of an appropriate protective 7 agreement of the type used in cases before the commission. 8 Section 5. Effective date.

9 This act shall take effect immediately.
