AN ACT

- 1 Amending Title 34 (Game) of the Pennsylvania Consolidated
- 2 Statutes, further providing for the protection of property
- 3 used for fish farming.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Section 2121 of Title 34 of the Pennsylvania
- 7 Consolidated Statutes is amended to read:
- 8 § 2121. Killing game or wildlife to protect property.
- 9 (a) General rule. -- Subject to any limitations in this
- 10 subchapter, nothing in this title shall be construed to prohibit
- 11 any person from killing any game or wildlife:
- 12 (1) which the person may witness actually engaged in the
- 13 material destruction of cultivated crops, fruit trees,
- vegetables, livestock, poultry [or], beehives or fish in fish
- 15 <u>farm rearing ponds</u>;
- 16 (2) anywhere on the property under the person's control,
- 17 including detached lands being cultivated for the same or

- 1 similar purposes, immediately following such destruction; or
- 2 (3) where the presence of the game or wildlife on any
- 3 cultivated lands or fruit orchards or fish farm rearing ponds
- 4 is just cause for reasonable apprehension of additional
- 5 imminent destruction.
- 6 Lands divided by a public highway shall not be construed as
- 7 detached lands. Any person who wounds any game or wildlife shall
- 8 immediately make a reasonable effort to find and kill the game
- 9 or wildlife. Every person shall comply with all other
- 10 regulations in this subchapter pertaining to the method and
- 11 manner of killing, reporting the killing and the disposition of
- 12 game or wildlife and their skins and carcasses.
- 13 (b) Protected game or wildlife. -- Before any game or
- 14 wildlife, which may be designated by regulation of the
- 15 commission, or any bird or animal classified as threatened or
- 16 endangered may be killed, every reasonable effort shall be made
- 17 to live trap and transfer such game or wildlife. The trapping
- 18 and transfer shall be done in cooperation with a representative
- 19 of the commission.
- 20 (c) Definition.--As used in this subchapter, the word
- 21 "person" shall be limited to any person cultivating, as a
- 22 primary means of gaining a livelihood, any lands for general or
- 23 specialized crop purposes, truck farming or fruit orchard or
- 24 nursery being regularly maintained or raising fish in fish farm
- 25 rearing ponds as a primary means of gaining a livelihood, as
- 26 either the owner, lessee or a member of the family of the owner
- 27 or lessee assisting with the cultivation of the land or the
- 28 raising of fish, or a domiciled member of the household of the
- 29 owner or lessee or an employee of the owner or lessee, regularly
- 30 and continuously assisting in the cultivation of the land[.] or

- 1 the raising of fish.
- 2 Section 2. This act shall take effect in 60 days.
